As a result, President Washington authorized Mint Director Elias Boudinot to reduce the weight of each planchet from 208 grains to 168 grains as a cost saving measure. Coin collectors today have two types of large cents to collect for the year 1795: Lettered Edge cents struck on thick planchets (this coin), and Plain Edge cents produced on thinner planchets. This coin was struck from dies engraved by John Smith Gardner during his short-lived tenure at the newly established first Mint. Three obverse dies and three reverse dies were used to strike 37,000 Lettered Edge cents dated 1795, resulting in four different die marriages. Another 501,500 cents would later be struck, but at a lighter weight and with a plain edge. Sheldon-75 is the most available Lettered Edge variety for the date, although the Lettered Edge cents of 1795 are notably scarcer than their Plain Edge counterparts. Current research indicates the ratio is about one Lettered Edge example to four of the Plain Edge type. The S-75 pairing is immediately identifiable by the lengthy spine from the leaf

beneath the T in UNITED. Similar die breaks from the N in UNITED, the C and T in CENT, the right ribbon end, and the leaf beneath the second T in STATES suggest that the die engraver was not at the top of his game the day the dies were made. This piece is a splendid chestnut-brown Gem with shimmering luster and an unabraded appearance. Minute planchet flaws are present under TE of STATES and O of OF, but they are unimportant and of Mint origin. Also, an area of die rust is in the right obverse field near Liberty's chin. The 95 in the date and the T in LIBERTY exhibit slight strike doubling, but the overall strike is exceptional, with no soft areas on the legends, portrait, or wreath. All known proof 1856 Liberty Seated dimes were struck from a doubled obverse die that is most readily identifiable by looking at the ribbon upon which the word LIBERTY is inscribed and the bottom of Liberty's gown along the top base of the rock. This is a richly toned near-Gem that is bathed in even lavender and golden-russet patina. The fields impart a semi-reflective finish and are free of all but trivial distractions. The devices and rims exhibit a razor sharp strike that could only be the result of proof production methods (multiple strikes of the dies). This is a prized rarity in proof grades and current estimates show between 30 and 40 of these are known today. These were struck just on the cusp of the large increases in proof coinage for collectors that came later in this decade. Pressure was building by the time this splendid 1856 dime was struck in Proof, with a mintage likely of 50 pieces or so -- while the decade prior saw mintages of proof dimes from zero to 10 specimens in most years. The Carson City Mint, which is perhaps the most well-liked of all coinage facilities in the history of the United States, opened for business in 1870. Among silver denominations, the Mint's production in that year was limited solely to quarters, half dollars, and silver dollars. The first seated dimes did not appear until 1871 at this mint, when slightly more than 20,000 examples were placed into circulation. The 1871-CC is not only a historically significant issue, but it is also one of the most widely respected keys to the long-lived Seated dime series.

Nicely toned and well struck, this is a resplendent example of the kind of quality one likes to describe for bidders of this actively collected Seated Liberty design. Original luster blends easily with soft gold and silver-gray highlights. One would be hard put to find a more truly beautiful specimen of a rare CC-mint issue with only the most minor softness on the head of Liberty. The upper leaves of the wreath on the reverse are full. Surface quality is above average for a Carson City dime of this period, with minimal nicks. The presentation is exceptionally pleasing overall. With a mintage of 18,791 pieces for the year, most of which have all but disappeared today, leaving precious few for collectors to fight over. All told, the combined NGC and PCGS population information tallies at most 128 examples certified of this date in all grades, and that number is undoubtedly high as some coins may have been submitted more than once between both grading services. The rarity of the 1866-S quarter can be blamed on its small mintage and the lack of coin collectors in the West during this period of time. The 1868-S is one in a lineup of distinguished rarities among early San Francisco Mint quarters. As with the other issues in this group, the rarity of the 1868-S resulted from a combination of limited mintage and a heavy rate of attrition through circulation. Only 96,000 pieces were produced, virtually all of which entered circulation at the time of delivery and remained there until worn out or lost. The need for circulating coinage on the West Coast was certainly significant, but there was also essentially no numismatic demand in mintmarked coinage and few contemporary Americans set aside an 1868-S guarter. We suspect that the few Mint State survivors known either survived by chance or represent Assay pieces that were not destroyed through the activities of the Commission. In any event, these are very rare coins with Larry Briggs (1991) assigning the issue a Rarity-6+ rating in Uncirculated condition. This is a Select Mint State Liberty Seated quarter irrespective of date or issuing mint. Lustrous with a satiny texture, the surfaces are enhanced by delicate iridescent toning in golden-apricot and pale pink. Sharply struck over virtually all features and simply a delight to behold. All American proof coinage from the 1840s is rare, no matter whether it is gold, silver, or copper. Various issues were struck simply on a whim, or a visit from a dignitary, or to commemorate an event -- not on a regular basis as post-1858 proof issues were, Many of these obscure proofs were subsequently lost to mishandling or circulation over the years, and quality is often low when found at all. Many of the proof half dollars of this decade are known to exist, but the survival numbers are often extremely low, (4 - 6 of each date), however, the 1847 is downright "common" in a relative sense with perhaps 10-12 known today. The Census and Population Reports record a total of 18 examples graded in various proof grades ranging from Proof 61 to Proof 66, but this contains almost certain duplication from resubmissions. Considerable effort must be expended to match up those known to those recorded in auction appearances to derive a more accurate number. To be sure, there are far fewer proof 1847 half dollars than collectors who want one, and we expect numerous bidders for this important lot. A light coating of golden-orange and dove-gray color is somewhat more pronounced on the obverse, though both sides show significant patina that partly obscures the mirrors. The striking sharpness and high, sharp wire edge leaves little doubt as to this coin's proof status, but a shallow mark in the right obverse field precludes a finer grade designation. WB-2, R.5. Demand for silver coins during the Gold Rush in California was extremely high, and silver bullion could not be purified to the exacting standards required for coinage without the necessary parting acids -- in short supply as the Gold Rush tested the fragile delivery systems then in place from East to West. In 1854, the incoming Director of the Mint, James Ross Snowden, sent pairs of half dollar dies to the San Francisco Mint but these were not used for coinage at that time. At last, a local source was found that could supply the necessary parting acids and coinage of half dollar finally began in 1855. To celebrate, three proofs were struck, one resides at the Smithsonian, the other two are in private hands. The business strike mintage largely entered commerce through normal channels, where most coins were worn out and subsequently lost. This lot presents a rare AU survivor that is of even further significance given that the 1855-S is not only the first San Francisco Mint half dollar, but also the only one of the Arrows, No Motto Liberty Seated type.

This is a partially lustrous AU example of this historic key date half dollar. Untoned save for some delicate golden iridescence, while both sides retain considerable satiny finish. Boldly to sharply defined throughout. The appeal of this coin for the advanced Liberty Seated collector cannot be overstated. B-5, BB-27, R.1. Bowers-Borckardt Die State III. The silver dollar became the cornerstone of the monetary system devised by the early government for the fledgling United States. More than two years passed between the time Congress authorized dollar coinage (1792) and the actual production of the first such coin, the Flowing Hair silver dollar in 1794. As part of the basic Mint Act of April 2, 1792, the House and Senate specified that two key Mint officers -- the chief coiner and assayer -- would each have to post bonds of \$10,000 before they could work with precious metals (gold and silver). The requirement was excessive; it represented more than six times the annual salary of \$1,500 provided for these officers, Understandably, they had trouble meeting it, and until they did, only copper coinage could proceed (cents and half cents of 1793 and 1794).

Silver coinage began with two denominations -- the silver dollar and half dollar; both being essentially identical in design (half dimes of this date were not coined until 1795). The one dollar coin was deemed most prestigious, so Mint officials decided to strike that coin first. Actually, the Mint had gotten a running start on the new coins; engraver Robert Scot had been told to prepare designs for them months before the legal snarl was untangled.

When the first silver dollars were released, the design met with public outcry -- a similar fare greeted the 1793 Chain cents and Wreath cents. In the case of the silver dollar, the powers that be decided it would serve them better to hire a more competent designer for a coin of the importance of the silver dollar. Henry William DeSaussure was retained as the Director of the Philadelphia Mint in June, 1795. The first priority was to issue gold coins; the second was to redesign all other coins, particularly the silver coins. DeSaussure obtained the services of the famous painter Gilbert Stuart to redesign the

all-important silver dollar. Stuart modeled his new obverse from his painting of the most beautiful woman in Philadelphia, Mrs. William Bingham (formerly Ann Willing. His designs are classic 18th century. Liberty is rendered with her long hair bound by a ribbon, and her bust covered by a loose gown. The reverse received considerable attention as well, with the eagle made much smaller and the wreath more delicate. The Flowing Hair design was retired after scarcely 12 months in production. the early days at the Mint presented many challenges, and this coin captures these struggles in magnificent perfection.

This die pairing produced an estimated 100,000 coins which is considered a very high production number from this early time at the Mint. It is virtually unheard of for these large dies for the silver dollar to last for an extended period of time without cracking or shattering during the lengthy production run. The left side of the obverse die features a "scratch or bar" caused by the engraver during preparation of the die, This "bar" is clearly visible in the field behind the uppermost hair curl of Liberty.

This is a truly exceptional coin that displays full, original mint luster beneath layers of soft gray patina that shows occasional deep blue and green accents concentrated around the periphery on the obverse and more evenly distributed across the reverse. Sharply struck throughout with good definition on Liberty's hair curls and on the eagle's breast as well. The only mentionable surface flaws are a series of light adjustment marks at 9 o'clock on the obverse rim, and a few more that extend into the curls.

Any Flowing Hair silver dollar is a rare and desirable coin, especially as a Mint State example. This Select example with richly toned surfaces represents an important numismatic treasure. PCGS Population: 4 in 63, 10 finer. (PCGS 6852) **\$120,000 - 140,000**

Bowers actually records three AU-55 coins in his listing of "Notable Specimens" for this variety. We feel this

Mint State coin qualifies in the Condition Census, and is one of the finer representatives available to early dollar specialists. One of the two varieties, Gobrechts with Die Alignment IV and a reeded edge were from an issue of 300 pieces intended for circulation, while the Die Alignment III pieces, as in this lot, are considered restrikes from a later date than 1839. Much research has been done in recent years including that of Saul Teichman, one of the hosts of the uspatterns. com website. They indicate: "We also note that all 1838 and 1839 dollars made in Die Alignment III are restrikes, and were probably

made during one or more of the following time periods: 1857-1860 (during Snowden's term in office), and 1867-1869 or 1873-1878 (during Lindeman's two terms in office). The exact restriking period cannot be determined with certainty."

The 1839 Gobrecht dollar is a rarity in any grade, however, this exceptional Gem is also tied as the finest certified by PCGS, This is a simply marvelous specimen, with both sides equally toned in vivid peach and light blue iridescence that shines over deeply mirrored surfaces. This total constitutes much of the original mintage, to be sure, but the authors also suggest that a fair number of these coins are impaired from having been placed into circulation by earlier generations of collectors. While it may be difficult to imagine such a scenario in the rare coin market of the 21st century, during the final decades of the 19th century the numismatic value of proofs such as this was not much more than the face value. A head of Liberty faces left, her hair tightly coiled in a bun atop her head, the coil held in place by a band inscribed LIBERTY. Around, the inscription * 6 * G * .3 * S * .7 * C * 7 * G * R * A * M * S * and below, the date 1879 is from a curved logotype. The reverse has a single large star that serves as the central motif, inscribed with incuse lettering ONE STELLA 400 CENTS. Around, in small letters, are the mottoes E PLURIBUS UNUM and DEO EST GLORIA. In large letters, around the border, the legend UNITED STATES OF AMERICA above, and the denomination FOUR DOL. below. Struck in copper with a reeded edge and gilt subsequent to striking. Although not graded by PCGS and simply labeled as Genuine, we believe this piece to grade Proof 63 with gilt surfaces, reflecting a nicely done process. There are no apparent flakes, thin spots, or mentionable blemishes, and a high, sharp wire edge is present on each side. This desirable piece still has lovely eye appeal with pleasing olive-gold patina circling the peripheries and contrasting against the more straw-gold hues at the centers. Liberty's hair is a trifle soft at the usual point above the eyebrow, but the rest of the details are powerfully impressed.

Many collectors are familiar with the design of the Stella, which features a flowing haired Liberty facing left on the obverse and a five-pointed star surrounded by text on the reverse. It is notable that the denomination is written in three different ways on the reverse: ONE STELLA, 400 CENTS, and FOUR DOL. Designed by Charles Barber, the Flowing Hair Stella was proposed to serve as an alternative for several foreign gold coins of the same size. One of several Congressional proposals for an international trade coin, the Stella was never adopted for a variety of reasons, not the least of which is its odd-denomination that is so popular among collectors today. Copper pattern examples are extremely rare, with a population of only 10 examples of the present variety known according to United States Pattern Coins, Ninth Edition. It is unknown how many of these have been gilt after striking. Nearly any collector can speak to the desirability of a Stella, and most can only dream of owning one. Serious consideration should be given to the opportunity to acquire this seldom-offered rarity. (PCGS 92043

One of the most famous rarities in American numismatics is the gold 1880 Coiled Hair \$4 Stella (aka Judd-1660) of which the Guide Book states only eight are known, the rarest of the four different types. The 1880 copper Coiled Hair counterpart (Judd-1661), is shown in United States Pattern Coins with a population of only five examples, although we feel the actual number might be slightly higher, perhaps 15-20 specimens. As is the case with other copper Stellas, several examples of Judd-1661 have been gilt, including the present piece resulting in the number Judd-1661a. This rare example features an extremely sharp strike and a pleasing yellow-golden color, although slightly muted in comparison to a true gold example. Most collectors can only dream of owning a gold 1880 Coiled Hair Stella, but a gilt copper specimen is well within reach of many collectors. (PCGS 92046)

Secure Holder. This significant pattern issue features the working hubs trial of the octagonal \$50 gold slug struck on an oversized round copper planchet 60mm in diameter. This was done to test the die prior to striking a gold impression of the \$50 Octagonal coin. This piece shows the mirror image of the devices that actually appear on the regular issue gold coins.

Prior research indicates the present piece is a unique hubs trial and was most likely in the collection of Virgil Brand for many years. This piece made its initial auction appearance in lot 2249 of the Brand-Lichtenfels, et al Collections (Kreisberg/Schulman, 3/1964). Subsequently, Anthony Swiatek purchased this hubs trial from Sol Kaplan at a coin show in Shaker Heights, Ohio in 1971, and it was off the market until January, 2015 when it was sold at the FUN U.S. Coins Signature Sale (Heritage), lot 4508 for \$99,875.

The \$50 design was prepared by New York artist Robert Aitken. The obverse features the helmeted goddess Minerva (who also appears on the arms of the State of California) inside a circle with the legend UNITED.STATES.OF.AMERICA. above and FIFTY.DOLLARS. below. The date, MCMXV (1915) is on a ribbon on her shoulder. The reverse displays an owl (symbolic of wisdom) perched on a branch of western pine inside a circle with the legend PANAMA. PACIFIC.EXPOSITION. above and SAN FRANCISCO. below. Dolphins appear in the angles of the octagonal corners, outside the circle on both sides.

Extremely sharp definition is evident over both surfaces and the exceptional surfaces of this copper-red Gem radiate vibrant mint luster throughout. A single mentionable carbon spot at 3 o'clock on the obverse is the only mark of note. (ii) the arbitration shall be conducted in the designated location, as follows: (A) in any case in which the subject auction by Bonhams took place or was scheduled to take place in the State of New York or Connecticut or the Commonwealth of Massachusetts, the arbitration shall take place in New York City, New York; (B) in all other cases, the arbitration shall take place in the city of San Francisco, California; and
