

"...In a series of brilliant victories from Austerlitz to Jena and Friedland, [Napoleon Bonaparte, Emperor of the French] had defeated the armies of Austria, Prussia and Russia. In June 1807, after the Russians had been pulverized at Friedland, the French cavalry occupied Tilsit (later Sovetsk) on the River Nieman, the border between Prussian and Russian territory in Poland. The Russian army

was in no state to continue fighting and Tsar Alexander I suggested peace talks between himself, Napoleon and King Frederick William of Prussia. Seeing an opportunity to stabilize his dominant position in western and central Europe, and isolate Britain, Napoleon agreed.

"...To meet on neutral ground the conference was held on a raft hastily built by the French in the middle of the river [Nieman], with two grand white tents on it...

"The discussions continued for several days, punctuated by entertainments in the evenings, with both Napoleon and Alexander quartered in Tilsit, dining together every day and often talking alone together far into the night. They took to each other, hugged each other when they met, walked along holding hands and exchanged cravats and handkerchiefs...

"The treaty between France and Russia was signed on July 7th and the one between France and Prussia on July 9th...

"Many influential Russians and Prussians regarded the treaties as shameful capitulations, and they did not last... Napoleon invaded Russia in June 1812."

The present watch is not only a fine example of 18th century watchmaking but also an important document in the history of the watchmaking industry of Neuchâtel and in particular, the role played by Frederick the Great of Prussia.

Prussia began its rule of the Principality of Neuchâtel when, in 1707, the house of Orléans-Longueville, which had ruled since the early 1500's failed to produce an heir. After a period of diplomatic intrigue, Neuchâtel passed to the Protestant King Frederick I in Prussia of the Berlin-based Hohenzollern dynasty in a personal union. This meant that, in effect, he was an absentee monarch, ensuring that the Protestant religion as well as the language, customs and local government of Neuchâtel were preserved. He was succeeded by his son Frederick II who ruled 1740 – 1786.

The son, better known as the "enlightened despot" Frederick the Great, was deeply interested in the art of horology and saw the economic benefits of the watch trade. He appealed to the watchmakers of Neuchâtel in his attempt to establish the industry in Berlin. With Frederick's encouragement, watchmaking prospered in Neuchâtel, giving it a firm foundation for future growth.

The signature on the watch refers to the watchmaker Abraham-David Perret (1742-1822) and his wife Suzanne-Marguerite Wattel (1740-1808), who he married in 1770. Valangin, a community a short distance from the town center of Neuchâtel was the seat of the local ruling council as well as the site of the Civil and Criminal Courts.

An important citizen, Perret held the position of *justicier* [justice of the peace] and had been granted the title of *maître bourgeois* giving him an active role in the government.

In recognition of his stature in the community, in 1770 and again in 1774 Frederick appointed Perret the sovereign's personal representative or *Gouverneur*, of Neuchâtel, the only official in the principality not required to be a Prussian subject.

Dating from this period, the watch was Perret's homage to Frederick. Finely made, the case bears a likeness of Frederick the Great, taken from the well-known portrait by Johann Heinrich Christian Franke (1738-1792) which widely circulated as a print. The image is crowned with diamonds and flanked by the figures of Mars and Minerva signifying Strength and Wisdom. The Trophy of Arms refers to Frederick's victories on the battlefield.

On October 10, 1934, a US Army Air Corps seven-page dossier which described in detail the design and functions of 'Military Specification No. 27748' was released. These watches were to be designated 'Avigation' watches, a portmanteau of 'Aerial Navigation'. Seven months later, the US Army Air Corps (1926-1941) which was the predecessor to the current US Air Force, placed an order for 175 Avigation Hack Type A-7 watches from Longines through their US Agent, Wittnauer Co.

As clearly drawn on Fig. 1 of page 4 of the highly detail-specific dossier, the Type A-7 features a right angled off-centered design, offset by 40 degrees from the vertical, a co-axial monopusher in the diamond-shaped crown, as well as large Arabic numerals, 30-minute register at 12 o'clock and constant running seconds subdial at 6 o'clock. These design elements allow pilots to read the dial, activate, stop, and restart the chronograph, as well as to always have a relative notion of position of 12 o'clock, without twisting the forearm or letting go of the yoke.

As these watches, were manufactured specifically for the US Army Air Corps, no civilian versions of the 51mm Avigation Type A-7 were ever produced and due to the high compliance of specification number 27748, only two other manufacturers, Meylan and Gallet, could produce Type A-7 watches; watches were only produced for a short period and in limited quantities.

Not only due to its rarity, but also owing to its distinctive and easily identifiable design, as well as the practicality inherent as a pilot's watch, the Avigation Hack Watch is the quintessential military 'tool watch'.





Purchasers who make direct arrangements for collection by a shipper who is considered a "private" or "contract" carrier by the New York Department of Taxation and Finance will be charged New York sales tax, regardless of the destination of the property. Property collected for delivery to a destination outside of New York by a shipper who is considered a "common carrier" by the New York Department of Taxation and Finance (e.g. United States Postal Service, United Parcel Service, and FedEx) is not subject to New York sales tax, but if it is delivered into any state in which Bonhams is registered or otherwise conducts business sufficient to establish a nexus, Bonhams may be required by law to collect and remit the appropriate sales tax in effect in such state. Property collected for delivery outside of the United States by a freight-forwarder who is registered with the Transportation Security Administration ("TSA") is not subject to New York sales tax.

#### MEDIATION AND ARBITRATION PROCEDURES

- (a) Within 30 days of written notice that there is a dispute, the parties or their authorized and empowered representatives shall meet by telephone and/or in person to mediate their differences. If the parties agree, a mutually acceptable mediator shall be selected and the parties will equally share such mediator's fees. The mediator shall be a retired judge or an attorney familiar with commercial law and trained in or qualified by experience in handling mediations. Any communications made during the mediation process shall not be admissible in any subsequent arbitration, mediation or judicial proceeding. All proceedings and any resolutions thereof shall be confidential, and the terms governing arbitration set forth in paragraph (c) below shall govern.
- (b) If mediation does not resolve all disputes between the parties, or in any event no longer than 60 days after receipt of the written notice of dispute referred to above, the parties shall submit the dispute for binding arbitration before a single neutral arbitrator. Such arbitrator shall be a retired judge or an attorney familiar with commercial law and trained in or qualified by experience in handling arbitrations. Such arbitrator shall make all appropriate disclosures required by law. The arbitrator shall be drawn from a panel of a national arbitration service agreed to by the parties, and shall be selected as follows: (i) If the national arbitration service has specific rules or procedures. those rules or procedures shall be followed; (ii) If the national arbitration service does not have rules or procedures for the selection of an arbitrator, the

arbitrator shall be an individual jointly agreed to by the parties. If the parties cannot agree on a national arbitration service, the arbitration shall be conducted by the American Arbitration Association, and the arbitrator shall be selected in accordance with the Rules of the American Arbitration Association. The arbitrator's award shall be in writing and shall set forth findings of fact and legal conclusions.

- (c) Unless otherwise agreed to by the parties or provided by the published rules of the national arbitration service:
- (i) the arbitration shall occur within 60 days following the selection of the arbitrator;
- (ii) the arbitration shall be conducted in the designated location, as follows: (A) in any case in which the subject auction by Bonhams took place or was scheduled to take place in the State of New York or Connecticut or the Commonwealth of Massachusetts, the arbitration shall take place in New York City, New York; (B) in all other cases, the arbitration shall take place in the city of San Francisco. California; and
- (iii) discovery and the procedure for the arbitration shall be as follows:
- (A) All arbitration proceedings shall be confidential;
- (B) The parties shall submit written briefs to the arbitrator no later than 15 days before the arbitration commences;
- (C) Discovery, if any, shall be limited as follows: (I) Requests for no more than 10 categories of documents, to be provided to the requesting party within 14 days of written request therefor; (II) No more than two (2) depositions per party, provided however, the deposition(s) are to be completed within one (1) day; (III) Compliance with the above shall be enforced by the arbitrator in accordance with California law;
- (D) Each party shall have no longer than eight (8) hours to present its position. The entire hearing before the arbitrator shall not take longer than three (3) consecutive days;
- (E) The award shall be made in writing no more than 30 days following the end of the proceeding. Judgment upon the award rendered by the arbitrator may be entered by any court having jurisdiction thereof.

To the fullest extent permitted by law, and except as required by applicable arbitration rules, each party shall

bear its own attorneys' fees and costs in connection with the proceedings and shall share equally the fees and expenses of the arbitrator.

#### LIMITED RIGHT OF RESCISSION

If within one (1) year from the date of sale, the original purchaser (a) gives written notice to us alleging that the identification of Authorship (as defined below) of such lot as set forth in the BOLD TYPE heading of the catalog description of such lot (as amended by any saleroom notices or verbal announcements during the sale) is not substantially correct based on a fair reading of the catalog (including the terms of any glossary contained therein), and (b) within 10 days after such notice returns the lot to us in the same condition as at the time of sale, and (c) establishes the allegation in the notice to our satisfaction (including by providing one or more written opinions by recognized experts in the field, as we may reasonably require), then the sale of such lot will be rescinded and, unless we have already paid to the consignor monies owed him in connection with the sale. the original purchase price will be refunded.

If, prior to receiving such notice from the original purchaser alleging such defect, we have paid the consignor monies owed him in connection with the sale, we shall pay the original purchaser the amount of our commissions, any other sale proceeds to which we are entitled and applicable taxes received from the purchaser on the sale and make demand on the consignor to pay the balance of the original purchase price to the original purchaser. Should the consignor fail to pay such amount promptly, we may disclose the identity of the consignor and assign to the original purchaser our rights against the consignor with respect to the lot the sale of which is sought to be rescinded. Upon such disclosure and assignment, any liability of Bonhams as consignor's agent with respect to said lot shall automatically terminate.

The foregoing limited right of rescission is available to the original purchaser only and may not be assigned to or relied upon by any subsequent transferee of the property sold. The purchaser hereby accepts the benefit of the consignor's warranty of title and other representations and warranties made by the consignor for the purchaser's benefit. Nothing in this section shall be construed as an admission by us of any representation of fact, express or implied, obligation or responsibility with respect to any lot.
