
The extinct flightless bird, Aepyornis maximus, produced the largest egg of any animal that ever lived, including the dinosaurs. Commonly known as the Elephant Bird, a name that originated from Marco Polo's account of the giant bird in 1298, the species was described by Marco Polo as a ten-foot-tall bird that weighed over half a ton, having talons large enough to seize an elephant. Aepyornis maximus lived only on the island of Madagascar and went extinct in the middle of the 17th century. The present exceptional egg is unbroken and original. Specimens of this quality and condition are very rare and highly desired by collectors. TAXIDERMIC WHITE PEACOCK Pavo cristatus

An albino peacock is a type of peafowl, distinctive for its pure white color due to total or partial lack of biochromes. Often incorrectly referred to as an "albino peacock", it is nothing of the sort: albinism, would cause lack of pigmentation not just in the feathers, but in the skin and eyes as well. A white peacock is, technically, a genetic variant of the Indian Blue Peafowl.

The colors in the feathers of a bird are determined two factors: pigment and structure. For example, the green in some parrots is a result of yellow pigments over blue-reflecting feathers. In the case of a white peacock, its unusual lack of color is due to a missing pigment. This missing pigment is dark and absorbs incident light, making diffracted and interference light visible (i.e. common peacocks). Pigment colorization in birds comes from three different groups: melanins, carotenoids, and porphyrines. Melanins occur as tiny specs of color in both the skin and feathers, and ranges from the darkest black to pale vellows. Carotenoids are plant-based and are acquired only by eating plants or by eating something that ate a plant. They produce bright yellows and brilliant oranges. The last pigment group, Porphyrins, produces a range of colors including pink, browns, reds, and greens. Feather structure is as important to color as pigment. Each feather consists of thousands of flat branches, each with minuscule bowl-shaped indentations, at the bottom of which are lamellae (thin plate-like layers), that act like a prism splitting light-with the same principle for butterfly wings and hummingbirds. 

Kiruna, Norrbotten, Sweden

Dated to have impacted northern Sweden approximately one million years ago, and initially discovered in 1906, this locality has become one of the best sites for fine octahedrite irons. Searches for the impact crater from the original shower, near the Arctic Circle have been in vain, as several glacial periods have most likely transported the meteorites away from the original strewn field.

These meteorites are almost always found buried under several feet of glacial moraine, and require specialized metal detectors to be found at these depths. The Muonionalusta is also the first meteorite in which Stishovite has been identified, a rare and extremely hard silicon dioxide polymorph of quartz, formed by very high shock pressure created





by the hypervelocity of a meteorite impact, giving rise to the theory that the Muonionalusta impact was one of the most violent and direct impacts on this planet.

Offered is a cube of Muonionalusta is the classic Widmanstätten patterns of meteorite metal matrix, an unearthly grid of shimmering shades of grey and silver, comprising two forms of nickel-iron, kamacite, and taenite. The high nickel content galvanizes the iron to some extent, which aids immensely in the meteorite's survival for nearly a million years under conditions highly favorable to rusting. Rarity and difficulty to recover make these specimens uncommon on the market. Any sizeable specimens are now difficult to find as the area around Meteor Crater near Winslow, Arizona has been closed for years. Most currently available Canyon Diablo meteorites are a mere 100-200 grams in weight. Meteor Crater, which measures nearly one mile in diameter, was created over 50,000 years ago when a meteor, measuring approximately fifty feet in diameter, exploded high over the Arizona desert. Campo del Cielo Iron, coarse octahedrite Gran Chaco, Argentina

Iron meteorites originate from the molten iron core of what were immature planets that briefly existed between Mars and Jupiter. These quasi-planetary bodies broke apart approximately 4.5 billion years ago during the birth of the solar system; the asteroid belt contains the artifacts of this event. In what is among the largest of pinball galleries, material is periodically deflected into an Earth intersecting orbit. This was the case 4,000 years ago when a major meteorite shower occurred in what is now known as Campo del Cielo ("Valley of the Sky"), Argentina. In 1576, Campo del Cielo meteorites were first written about by Spanish explorers before their unearthly origins were understood. 

MINERALS FROM THE COLLECTION OF JOEL AND BARBARA HAUSER, SAN **BERNARDINO, CALIFORNIA**

An ardent rock hound, Joel Hauser pursued his hobby of rock collecting and lapidary for over 60 years. Under the blazing sun of his native southern California, as well as Arizona deserts, he frequently dragged his four sons and wife through miles of rocky terrain to search for agates, geodes and petrified wood. Along the way, he discovered a deposit of agate geodes in Riverside County's Little Chuckawalla Mountains, a locality now known to rock hounds as the Hauser Geode Beds (see lot 2064). Joel's wife, Barbara, wrote for local newspapers and mineral hobby magazines and, most famously, one article she penned was titled "Bride of a Rock Hound" and it chronicled their many adventures in rock hunting.

Joel became an expert at contour polishing-perfecting that freeform, undulating polishing style that reveals the beauty of a specimen while removing blemishes, yet never removing any more material than necessary. Guided by an artistic vision, he expertly revealed the lovely patterns-particularly in highly figured minerals with concentric banding, such as the rhodochrosites seen in this catalogue. To this end, he fashioned special saws and grinding equipment that could handle cutting and polishing the large specimens he collected. Many minerals in the Hauser collection are from localities that are no longer accessible or producing. And those that are, no longer yield the large, high-quality ornamental gem materials seen here. Many of his specimens were donated to GIA in Carlsbad, CA, to inspire future generations of rock hounds.
