

# Dylan**Lewis**Shapeshifting

Over the past decade, Dylan Lewis has been creating a unique seven-hectare sculpture garden in South Africa located in the foothills of the Stellenbosch mountains situated outside Cape Town. To facilitate further expansion of the garden, he has decided to release from his personal collection the works offered in this catalogue. Created by the artist over the past two decades, these sculptures are the last remaining commercially available examples of each edition and the vast majority are artist's proofs.

Dylan Lewis continues his strong relationship with Christie's that began in the summer of 2007 with his first highly successful auction of animalier bronzes created during the early years of his career. A second successful auction entitled "Predators and Prey II" took place in June 2011. This latest collection entitled "Shapeshifting" encompasses the artist's transition from the Big Cat bronzes to the Shamanic human figures.

I have always been drawn to the wilderness areas of Southern Africa, places where I have experienced deep personal meaning as well as creative inspiration. My initial response was to draw, paint and sculpt the animals I saw around me on a daily basis in the Kruger National park where I lived and worked during the early years of my career. Over time the big cats, especially leopard, lion and cheetah began to dominate my sculptural output. Powerfully symbolic of the wilderness areas they inhabit, these apex predators are metaphors for all that is wild and untamed in the human psyche. With the passage of time, my interest in wilderness shifted to the symbolic, psychological meaning of wild places within the human psyche.

I believe modern humans have largely tamed Earth's wilderness, we have cut down forests, exterminated dangerous predators and fenced off the wild lands making the world a "safer" place in which to live and multiply. The modern lifestyles many of us enjoy are often a direct result of technological advancement based on ever increasing attempts to tame and control our environment. These advances are not without a shadow, including widespread environmental destruction, overpopulation, mass extinction and profound psychological alienation brought on by rapid separation from the natural world in which we have lived and evolved for millennia. In an urban environment, I often feel cut off from the rhythms, cycles and seasons of nature including ancient rites of passage linking internal and outer nature. In addition, urban smells, sounds and material textures are essentially "foreign" and increasingly we are entering a virtual reality where our sensory disconnection from the natural world is complete at every level.

Poetically speaking, I think the same "taming of the wilderness" seems to unfold in the human psychological journey. A young healthy child is born "wild", authentic, instinctive, intuitive, creative with an animal-like capacity to live in the moment. However, as children we are taught to tame this "wilderness within" in order to survive in our family and community. Authenticity is often problematic

in relationships and inevitably we start to cut down the forests within, taming the wild lands of our psyche. I believe that, as with the taming of the literal wilderness, there are consequences to this action. We may get much needed family and community support but we run the risk of destroying the original authentic, untamed life we came into the world with.







Much of life seems to be a push and pull between these two powerful opposite needs. I think the rebellion of the teenage years could be seen as a vitally important attempt to recapture or remember that part of ourselves we had to suppress. Once again in our twenties and thirties as we start relationships, families and careers, we embark in a taming process. At midlife, the "jungle" begins to grow back into the psyche causing disruption and disturbance. Relationships, health, ideals and careers start to fall apart as the call of the unacknowledged authentic life becomes increasingly urgent. These disturbing transitions are generally shamed in our modern world. However, I see them as profoundly important attempts to rebalance the psyche in whichever disruptive form they occur.

I think the call to re-wild our psyche presents us with a choice to either engage or remain on the tamed path. Each answer delivers pairs of opposites, a life and a death. Human history teaches that engaging with authenticity often ends in death. There are countless stories of political, religious and scientific martyrs who have died at the hands of their families, communities and nations because they chose to resolutely follow their own internal truth. Today this death is still literal for some but for most it seems to be symbolic. Perhaps a relationship, an ideal or career has to die in order to make way for the new life coming through. To me, the life of the tamed path has to do with service, self-sacrifice and finding meaning within community, all of which seem to be important to the psyche. The death we meet on this path is the possibility that we may live out that which others expect of us to such an extent that our own authentic life dies within us.

In order to express these ideas, I shifted from the animal to the human form. All my human figures are naked, alluding to original freedoms, allowing me to use the entire canvas of the body to express primal feeling. I work with the surface of the human body in the same way as my animal subjects, evoking an animalistic feel in the musculature and compositions of the sculptures. I think of the word animalistic in terms of its original meaning arising in early hunter gatherer societies, when to be associated with animal qualities was an honour. As we increasingly separated ourselves from the natural world, the image of the animal darkened to the negative and is now associated with human savagery and brutality. Savagery comes from a place of fear, the animalistic I refer to comes from self-love and has to do with honouring the free, wild, untamed authentic life within. In further exploring this tension, I have often used the animal skull worn as a mask to signify an engagement with the authentic life within. Male figures wear as masks the skulls of lion, waterbuck, Gemsbok and Eland respectively, each animal symbolising a particular energy. The skull mask both conceals and reveals something of the identity of the wearer, signifying a ritualistic engagement with the authentic life.

I am delighted to be offering here in this auction a selection of my "shapeshifting" bronzes, from animal to human, each the last available example of its edition and many of them my own artist's proof.




