PROVENANCE:

Formerly the property of Madeline Wyndham (1869-1941) and thence by descent.

Miss Wyndham appeared, aged sixteen, in a delicately rendered chalk portrait by Burne-Jones executed circa 1878. She was the daughter of Mr and Mrs Percy Wyndham who were well-known in British Society at the time and were part of a social group of politicians and intellectuals known as 'The Souls'. A similar social group evolved from the orginal referred to as 'The Coterie' and counted aristocrats, politicians and art-lovers amongst its members, including Sir Edward Burne-Jones.

LITERATURE:

Cf. C. Gere and G. C. Munn, *Pre-Raphelite to Arts and Crafts Jewellery*, Suffolk, 1996, p. 137 for a Giuliano bird brooch of near-identical design which was given to the Victoria & Albert Museum by Geoffrey and Caroline Munn. In the same publication see p. 134 for pencil designs by Burne-Jones of bird motif jewels within heart-shaped foliate surrounds which are assumed to be preliminary sketch renderings for the design that Guiliano eventually executed.

In their book, Gere and Munn intimate that the designs might perhaps have been inspired by medieval mosaics of olive trees found in Venice that Burne-Jones might have either seen in person when he visited the city in 1862, or alternatively came across as illustrated in the publication *Stones of Venice*, *Volume III*, published in 1853.

A small number of iterations of this brooch are known to exist, one of which belonged to Margaret Burne-Jones, daughter of Sir Edward Burne-Jones, and currently resides in the collections of the Victoria & Albert Museum (likely to be the very same jewel illustrated in the book written by Charlotte Gere and Geoffrey Munn which was given on loan for a travelling exhibition entitled *Edward Burne-Jones, Victorian Artist-Dreamer* from 1998-1999). Another belonged to Laura Tennant who was an acquaintance of Burne-Jones and sat as subject for many of his portraits, and a third is said to have belonged to the art critic Harry Quilter which was sold at auction in London in 1990.

PROVENANCE:

The property of the family of Sir William Lawrence (1783-1867).

Sir William Lawrence, 1st Baronet FRCS FRS, was an English surgeon, Fellow of the Royal Society, President of the Royal College of Surgeons of London and Serjeant-Surgeon to Queen Victoria. At the age of 32 he was appointed Professor of Anatomy and Surgery by the Royal College of Surgeons and held a series of lectures which were published in 1816. After a long and illustrious career as one of the foremost surgeons in England, he was rewarded by the Queen with a baronetcy shortly before his death in 1867.

Created using 22 carat Scottish Gold, this cuff bracelet is unique within a series of celebratory jewels to be produced by the Edinburgh jeweller and Royal Warrant holders, Hamilton & Inches. Having been granted the rights to the production of Cononish Gold Mine, at the foot of Ben Lui in the Highlands of Scotland, Hamilton & Inches's team of craftsmen are hand making modern jewels in the firm's 153 year old workshop; bringing together Scotland's goldsmithing heritage with the only known source of commercially mined Scottish Gold.

Designed to particularly showcase the beauty of 22ct gold Scottish gold, with hammered surface decoration, rather than gemstones, this cuff was inspired by the scintillating waters of the Tyndrum waterfall, that sits alongside the Cononish Gold Mine. The organic edging detail incorporated to further enhance the natural, organic pattern



A Rare English Medieval Ring

The sapphire is held by eight claws into an octofoil collet which echoes the traceried windows of Gothic cathedrals. This cusped design is illustrated by Gerard David in his Portrait of a Goldsmith (dated 1505-1510), who holds up rings with similar bezels (Kunsthistorisches Museum, Vienna). A sapphire of this size and quality is highly unusual in jewels of this period, as is its faceting. Most surviving examples are set with sapphires cut *en cabochon*, that is in the domed form and shape. One of the earliest known examples of a faceted sapphire in scalloped setting is that said to have been found in the tomb of William Wytlesey Archbishop of Canterbury (d.1374) (cf. C. Oman, 1974, plate 18c). This ring also strongly relates to two examples illustrated by D. Scarisbrick, *Historic Rings*, 2004, p 48-50, no.s 117 and 118, both dated to the 15th century.

The source of the sapphire is not European but from the East, and is likely to have been sourced from one of the traditional mines in either Ceylon, Burma or Kashmir, and subsequently brought across Asia by caravan to a Mediterranean seaport. From thence, the stone would have been sold in Genoa or Venice where it was customary for itinerant merchants to acquire precious stones to trade in the cities of the north.

Prized for its intrinsic value, beauty and rarity, the sapphire was also worn as an amulet. According to Marbode, Bishop of Rennes, France (1035-1133) author of the most influential lapidary, or compendium, of the healing and protective powers of stones, the sapphire kept the wearer from poverty and, being the colour of the Virgin and of the heavens, protected his or her chastity, comforted the heart, expelled envy, detected fraud and witchcraft and helped prisoners to escape. (cf C. Oman, *British Rings*, 1974, p. 60). It was also believed to act as a remedy for infections of the eyes, and the inventory of Charles V of France (J. Labarte no. 2937,) lists a sapphire "pour toucher aux yeux".

Adding to the properties of this ring are the infant Christ and of St. Elizabeth of Hungary engraved on the shoulders that belong to a type of English devotional ring named iconographic although unusually, these figures are located on the shoulders only and are subsidiary to the gem-set bezel. Also unusual is the image of the Infant Christ independent of his mother, the Virgin Mary ,whereas the a similar depiction of the young and queenly St. Elizabeth of Hungary (1207-31), revered for her austerities and care for the poor, can be found on the beads of an English gold rosary of about 1500 (cf. Eric Maclagan, *Archaeologia* Vol. LXXXV p.6 no.28a). With other saints she is also represented on a carved rood screen of the same date at Holy Trinity Church, Torbryan, in Devon, England.

Evoking the age of faith, the intrepid merchants who risked many dangers on their travels by land and sea, the skills of the goldsmiths and lapidaries who benefited from the rising prosperity of towns, especially Paris, Cologne, Bruges, Antwerp and London, this extraordinary find epitomises the late medieval world and the desire of the upper ranks of society to display their wealth.





By family tradition, these earrings were a gift from Empress Eugénie of France on the occasion of her visit to Egypt for the inauguration of the Suez Canal on 17th November 1869.

The construction of the Suez Canal, linking the Red and the Mediterranean Seas, started on the shore of the future Port Said on 25th April 1859 and took some 10 years to complete.

In what was to be an international event of huge significance, Khedive Isma'il Pasha of Egypt invited Empress Eugénie to preside over the inauguration. After the religious ceremonies were complete and to the sound of a canon salute, the imperial yacht L'Aigle, with Eugénie aboard, undertook the first voyage down the canal followed by a flotilla of ships bearing the Viceroy, the Emperor of Austria, the Crown Prince of Prussia and the ambassadors of wGreat Britain and Russia.



Born in 1925 to the entrepreneur John Moores and his wife Ruby, Betty was raised in the context of her father's extraordinary success. John Moores founded the Littlewoods empire, a retail and football betting company, in 1923. By 1982 Littlewoods was the largest privately run company in Europe, with, at its height, over 510,000 employees and a turnover of over £3.5 billion per year; success due in no little part to the contribution of Betty, by then Lady Grantchester.

Betty was educated at Cheltenham Ladies College and Newnham College, Cambridge, where she met her future husband Kenneth Suenson-Taylor, who succeeded his father to become 2nd Baron Grantchester in 1976. Together the couple had six children. In 1977 Betty joined the Littlewoods board where her innate commercial acumen and drive set her apart as an extraordinary business woman, particularly in the context of an era when women in the boardroom were scarcely known.

Following the sale of both the pools business and retail empire in 2000 and 2002 respectively, Lady Grantchester dedicated herself to philanthropy, which, amongst many others, included directing and providing financial support for mature female undergraduates at Lucy Cavendish College, Cambridge, The Moores Family Charity Foundation, the Welsh National Opera and the John Moores Painting Prize, one of the earliest winners of which was David Hockney in 1967. In memory of her late husband, she also set up a substantial bursary to aid law students at Christ's College, Cambridge.

Lady Grantchester was always immaculately dressed, her personal collection of jewels offered here, a testament to her taste and discerning eye. Although Lady Grantchester had a considerable personal fortune her greatest pleasure was derived from her family and the charitable works to which she devoted the rest of her life.







AN EXQUISITE AND VERY RARE MULTIGEM AND DIAMOND ART DÉCO FOB WATCH, CARTIER

First travelling to India in 1911, Jacques Cartier met with Sayaji Rao III, the Gaekwar of Baroda, who, following their meeting, commissioned Cartier to reset his entire jewellery collection in platinum, so inspired was he by the new precious metal and the innovative jewellery styles that he had been shown. This moment proved an important turning point for the firm; until this time they had remained steadfastly loyal to the traditional Belle Epoque motifs which had until then dominated their oeuvre.

In 1913, Cartier New York held an exhibition of fifty 'jewels from the Hindoo, Persian, Arab, Russian and Chinese' of which, according to the accompanying catalogue, twenty were inspired by Indian art. For the next quarter of a century Indian rulers asked Cartier to transform their jewels. The Maharajah of Patiala was responsible for the most famous commission due to the quality and vast quantity of his crown jewels. In 1928, before returning the reworked jewels to Patiala, Cartier exhibited them in their showrooms on the rue de la Paix. This event not only attracted huge publicity but dramatically increased Indo-Persian inspired commissions both from India, Europe and the United States.

Of all gem stones, emeralds are the most closely associated with India, due to the long established tradition of Indian rulers acquiring and wearing the best examples of Colombian mined stones. Having arrived in India these emeralds were often carved on both sides with typical Mughal floral sprays and in the case of this pendant watch with a flowering plant on the obverse and a peacock on the reverse. This jewel is an extraordinary example of the Indian influence prevalent in Cartier's work during the 1920 and 30s; combining as it does, an abundance of richly coloured gems and brilliant-cut diamonds, a 19th century carved emerald inset with a modern miniature skeletonised watch, contrasting with vibrant cabochon cut stones.

Jeanne Toussaint's influence, undoubtedly one of the most creative and talented people ever brought into the firm, is also evident here. Toussaint was inspired by the jewels of India and combined this rich tableau with other exotic themes as well as the dazzling colour and movement of Diaghilev's Ballets Russes. Along with her 'panthere' designs, Toussaint is perhaps most famous for the developement of Cartier's signature carved gem and diamond tutti frutti jewellery, arguably the most sought-after of the firms Art Deco creations.

This pendant watch is a true masterpiece, epitomising the exoticism and Indo-Persian influence which so richly imbued some of Cartier's most spectacular designs of the 1920s; a period of truly extraordinarily innovative production, this jewel is Cartier at its best.

A RARE AND IMPORTANT DIAMOND NECKLACE, SHINDE

Ambaji Venkateshwara Shinde, born in Goa in 1917, began his journey into the world of design at the age of seventeen when he attended the JJ School of Arts in Bombay, graduating in 1937 with a degree in textile design. His talents were soon recognised by Nanubhai Sagar, manager at Narauttam Bhau Jhaveri, one of the most prominent jewellery salons in Bombay, and Shinde was promptly taken on as a jewellery designer for the firm at only 20 years old.

In 1941 Sagar left Narauttam Bhau Jhaveri to set up his own jewellery venture, taking the dynamic young designer with him. In time, and with the help of Shinde, Nanubhai gained the prestigious status of official court jeweller to rulers such as the Maharajas of Gwalior, Palanpur, Travancore, Bhavnagar and His Imperial Highness the Emperor of Ethiopia, amongst others.

In 1947 the age of the Maharajas came to an end with the dissolution of India as a British colony. Widespread distaste for the immeasurable wealth of the rulers compared with that of its constituents instigated a wave of important jewels being sold discreetly, disassembled and reimagined in a manner more sympathetic to modern tastes and intended for an international clientele.

In her book entitled *Shinde Jewels*, Reema Keswani describes Shinde being presented with an impressive collection of diamonds from which he may well have designed the baguette-cut diamond necklaces as illustrated here and on page 39 of her book:

'An opportunity to demonstrate his versatility and mastery came in 1953. Nanubhai had purchased a collection of royal antique Indian objets d'art and jewellery set with exceptionally large *polki*, or table-cut diamonds - the average stone was more than an inch and a half in length. It was clear from the size, quality, and quantity of diamonds that the collection had come from a princely family. [...] The tablet-shaped diamonds were ideally suited to being refashioned into an equally rare collection of oversize baguette-cut diamonds, shaped like batons. A number of suites [...] were created from this collection, two of which were purchased by the Maharaja of Gwalior and one by Harry Winston.'

It was in 1955, when Harry Winston visited Nanubhai's to purchase a third jewel from the baguette-cut diamond collection, that Mr Winston and Shinde met for the first time and seven years later, in 1962, Winston had formally hired him. By 1966 Shinde was appointed as lead design atelier and it was not until four decades later that he finally retired from Winston's employment.

During the course of his career Shinde designed jewels for some of India's most prominent rulers, including the Maharaja Sayaji Rao Gaekwad of Baroda, as well as the Begum Aga Khan and royal houses throughout the Middle East and South Asia. Whilst under the aegis of Harry Winston, he produced pieces for King Ibn Saud of Saudi Arabia, Imelda Marcos, Sharon Stone, Madonna and Gywneth Paltrow and some notable jewels such as the 'Star of Sierra Leone' brooch and the 'Etoile du Désert' diamond.

Despite his illustrious reputation amongst industry insiders and cognoscenti, Shinde's talents and influence remain, to this day, largely unrecognised outside the jewellery world. His creative legacy was arguably the most important and influential contribution to Harry Winston's design history, cementing the classic Winston aesthetic of gemstones seemingly floating in mid-air with a very minimum amount of metal mounting visible.




