

Exceedingly rare original souvenir pennant issued in promotion of the 1913-14 World Tour of the Chicago White Sox and New York Giants. The tour was organized by Charles Comiskey and John McGraw, with marked significance as the first time that American baseball was played by its star players on foreign soil. The game's greatest stars took part, most notably Christy Mathewson, who is memorialized on the offered pennant.

#### HISTORIC APRIL 20, 1912 FENWAY PARK INAUGURAL OPENING DAY PANORAMIC PHOTOGRAPH

Author John Updike once noted "Fenway Park is a lyric little bandbox of a ballpark. Everything is painted green and seems in curiously sharp focus, like the inside of an old-fashioned peeping-type Easter egg."

On April 20, 1912, the new Fenway Park opened its gates to the public and assumed its place in history. Seated between the Muddy River and Stony Brook, the stadium was constructed by railroad owner John Taylor, who built the park as a real estate venture on an area known as the "Fens." Ground was broken in September 1911, and although not yet complete, the first game was played on April 20, 1912 before a crowd of 27,000 fans. Appropriately, the inaugural opponent was the New York Highlanders (who later became the Yankees). The game was decided a Red Sox victory in the 10th inning on a Tris Speaker hit

The offered panoramic image of that inaugural game at Fenway measures an impressive 7"x45," framed, with both teams lined up in front of the grandstand. Pictured players include Speaker, Wood, Hooper, Cicotte, Chase, Ford and Warhop. Amusingly, Speaker and Wood appear twice, as they ran around to the Highlanders side after the first exposure was taken. Marked "Glines photo, Washington" at top right corner. Photo retains excellent clarity and contrast with the (presumably) red, white, and blue bunting visible behind the players. Area of professionally restored creasing is present at far left end with some more minor creasing and soiling found at far right end. The offered example is one of only a scant few known examples, and represents both the beginning of the legendary stadium and the storied rivalry between the Yankees and Red Sox: EX



#### SIGNIFICANT JULY 11, 1914 BABE RUTH FIRST MAJOR LEAGUE GAME "LINEUP CARD" (TOMMY CONNOLLY COLLECTION)

On July 11, 1914 Tommy Connolly, along with umpire O'Loughlin, presided over a game played between the Boston Red Sox and the Cleveland Naps at Fenway Park in Boston. The game was, for the most part, fairly insignificant save for the debut of a young pitcher by the name of George "Babe" Ruth. Ruth played in his first Major League game on this date departing with a no decision after six innings. Ruth surrendered only five hits and one run to the mighty Cleveland team, whose lineup included Nap Lajoie and Joe Jackson. Ironically, on the offensive side of the ball, Ruth struck out in his first at bat. The lineup card itself is neatly penned in Connolly's hand, including positions, date, site, umpires (including a last name autograph of Connolly), and even the substitution of left fielder Duffy Lewis for Olaf Henriksen (misspelled 'Hendrickson' by Connolly). The Babe is simply listed as "Ruth-P." just above the name of the substitute Duffy. The size of the paper stock card is 4¼"x 4½" with a single horizontal fold line.

This particular item originated from the personal collection of Hall of Fame umpire Tommy Connolly. Connolly was documented to have preserved additional noteworthy items of memorabilia within his collection including the first pitch baseball in the history of Fenway Park (See Hunt Auctions, April 2012, lot 335) and the Eddie Collins single signed baseball within this auction. Given the impeccable provenance of the offered card and the mundane nature of Ruth's debut, the card is certainly unique and possibly one of the more significant lineup cards of its type extant.



#### SIGNIFICANT EDWARD MAYNARD BOSTON RED SOX PHOTOGRAPHIC ARCHIVE AND AUTOGRAPHED GUEST REGISTER C.1915-16 (EX-DRAPER & MAYNARD COLLECTION)

Important and unique original archive with relation to the Boston Red Sox World Championship team of the 1915 and 1916 seasons, including Babe Ruth. The archive originated from the family of Edward Maynard, who was a partner in the highly regarded Draper & Maynard Sporting Goods Company. The firm was one of the most prominent sporting goods suppliers in the country from the late 1800s through the 1940s. Based in New England, Edward Maynard owned a camp on Cotton Cove at Squam Lake in New Hampshire. After the World Series contests in 1915 and 1916 Maynard invited the victorious Red Sox to stay at the camp as his guests. It was during these two trips that the offered archive was accumulated, and then passed down through the Maynard family. Offered is a period photographic album containing (24) original 4"x5" sepia tone images taken during the trip to the Draper & Maynard factory and the camp at Squam Lake. Numerous photos included with players wearing their Red Sox sweaters, as well as players learning how to make baseball equipment at the factory. A remarkable eleven images within the album picture Babe Ruth in various poses including making baseballs, ready for hunting wearing a fur coat, and at Draper & Maynard Park in full Red Sox uniform. Photo quality is very fine throughout, with only one or two having minimal wear to edges/ corners.

The archive also includes the original bound guest book from "Eveleds Camp," as built and operated by Edward Maynard at Cotton Cove on Squam Lake, NH. The album measures a sizeable 7"x9" and has been autographed by (91) guests of the Camp. The signatures include a number of players from the World Champion Boston Red Sox of 1915-16 who signed when visiting. Among the signatures is a very scarce and desirable early career autograph of "Mr. Geo H Ruth" dated (in Ruth's hand) "Oct. 17-1916". Signature exhibits all the qualities of Ruth's early penmanship as his autograph evolved into the classic form that would become the most recognized in all of sports.

Additional player/notable signatures include Tim Murnane, Richard Hoblitzell, Ernie Shore and Tris Speaker. Several members of the Maynard family have signed the book as well. Signatures range from 7-9 out of 10, with Ruth grading 8. Amazing intact archive dating to the Boston Red Sox Championship era and infancy of Babe Ruth's iconic career. 














#### SCARCE AND IMPORTANT BABE RUTH BOSTON RED SOX ERA PROFESSIONAL MODEL BASEBALLL BAT C. 1916-18 (PSA/ DNA 9.5) (CONNIE MACK/PHILADELPHIA ATHLETICS BAT BOY PROVENANCE)

In 1914, the heralded and yet unbridled young player by the name of Babe Ruth made his Major League debut with the Boston Red Sox, Ruth had quickly ascended through the Minor League ranks, first with Baltimore and then Providence. Although young Ruth's penchant for long home runs gained him attention, it was Ruth's prowess as a left-handed pitcher that proved his strongest talent early in his career. During his first six seasons with the Red Sox, Ruth compiled a total of 89 wins with an ERA of 2.19. For a period of four seasons, Ruth was second in the AL for wins to only Walter Johnson. By 1916, Ruth had reached the pinnacle of his pitching career earning a record nine shutouts in the regular season, and a 14 inning complete game victory in the World Series. In 1917 his pitching success continued, with Babe notching 24 wins against 13 losses.

However, in 1918 world events created an opportunity for Ruth that would change the course of history. Due to many players being called into service for World War I there was a need for everyday players. Ruth was aware of this need, and had also become frustrated with only pitching every third or fourth day, versus playing a regular fielding position. He ultimately convinced Red Sox manager Ed Barrow that the game would never be quote "the same." During a War-shortened season Ruth batted .300 and tied for the league lead in home runs with 11. During Babe's final season with the Red Sox in 1919 he fully emerged as the greatest slugger in the game belting 29 home runs, 113 RBIs, and 103 runs scored —all league leading totals. Due to Ruth's exceptional pitching success early in his career, his ability to hit was extremely limited. Up until 1918, Ruth had amazingly never had more than 150 at bats in a season. Additionally, during the beginning of his career Ruth was incessantly teased about his rugged demeanor and raw behavior. According to period accounts of this early career period, Ruth was limited primarily to a pitching role, and would arrive to find his bats having been sawed in half by teammates to ridicule the young player. As such, professional model game bats dating to Babe Ruth's tenure with the Red Sox are nearly non-existent, with a fractional handful documented to exist.

Offered is one of only two documented pre-1918 era Babe Ruth block letter stamped Louisville Slugger professional model bats known to exist. Ruth block letter bats pre-date the facsimile signature stamped variants instituted after he signed his contract with the Hillerich & Bradsby Co. in 1918 making them the most coveted and scarce of any Ruth game bats. The imposing war club measures 353/4" long and weighs an incredible 43.6 ounces. Handsome graining present in the ash bat, which displays strong evident use in the form of extensive ball marks, grain checking and a professionally repaired handle crack. Louisville Slugger manufacturer's stampings display boldly at centerbrand area (1916-18 label variant) with "RUTH" in block lettering on the barrel. Handle crack once had period black tape (applied by Frank Gara in the period) around it for support, which has since been removed and expertly

The bat possesses a succinct provenance, which traces its origins to Ruth himself during an appearance at a 1944 War Bond Game played at Shibe Park in Philadelphia. Connie Mack had invited Ruth to participate, and would be given three swings to try to hit a home run. According to family history, Ruth hit the first ball to the fence, the second ball to the fence, and with the third and final swing also hit one to the wall, but cracked the bat. Ruth reportedly remarked to the crowd, "Ole Babe doesn't have it anymore." The bat was presented to his old friend Connie Mack, who in turn presented it to the Philadelphia A's bat boy Frank Gara whose father, a Philadelphia Police Captain, was a dear friend of Mack. It descended within the Gara family until its purchase by noted bat collector Michael Montbriand in 1991. The scarcity of any pre-1918 Ruth bat cannot be overstated for the aforementioned. The provenance and history of this particular example create a compelling argument in favor of standing as one of the most important early career Babe Ruth bats extant. Extensive supporting documentation accompanies the bat to include: 1994 notarized letter from Fran Gara chronicling the history of the bat including vintage black and white photo showing Gara standing with the bat having black handle tape visible on the handle; 1997 typewritten letter of authenticity/provenance from Michael Montbriand, and LOA from PSA/DNA (GU 9.5): EX 35¾ in. long 43.6 ounces


# The Inaugural Hall of Fame Class of 1939 Lots 19 - 30

Between 1936 and 1939 annually, the inaugural rosters of (25) baseball players, managers, executives, and pioneers were selected for induction into the National Baseball Hall of Fame. However, it was on June 12, 1939 that the historic museum in Cooperstown, New York opened its doors to tremendous fanfare and attendance. Most significantly, on that grand celebratory date all eleven living members of those twenty five players were in attendance for the ceremonies. Babe Ruth, Ty Cobb, Walter Johnson, Cy Young, George Sisler, Honus Wagner, G.C. Alexander, Connie Mack, Tris Speaker, Eddie Collins, and Larry Lajoie consisted of the greatest assemblage of star players to have congregated in one location to that date. Famously, Ty Cobb was late to the ceremonies and as such many of the coveted autographed souvenirs acquired on the June 1939 date are lacking Cobb's signature.

# SIGNIFICANT CHRISTY MATHEWSON SINGLE SIGNED BASEBALL: A SURVIVING ATTRIBUTED BENEFIT AUCTION EXEMPLAR C.1918-24 (PSA/DNA)

Christopher Mathewson began his career in the humble blue collar town of Factoryville, PA. His athletic success continued as he attended Bucknell University where he played baseball, football and basketball, in addition to serving as class president. It would not take long for Matty's path to the Major Leagues to blossom, as he earned a 20-2 record with the Norfolk Minor League club in 1900. Mathewson would then play for the New York Giants from 1900-1916 compiling a National League record of 373 career victories. In an era when ballplayers were known as hard-living, hard-drinking rouges, the college-educated, fair-haired and handsome Mathewson was the idol of millions. His articulate, dignified persona contrasted a fierce competitiveness on the mound that made him, arguably, the most dominant pitcher of his time. Tragically, while serving his country during World War I in 1918 he was exposed to poison gas and subsequently developed tuberculosis as a result of the damage to his lungs. "Big Six" passed away in 1925 at the age of 45 at Saranac Lake in New York, leaving the baseball world devoid of one of its greatest icons. Appropriately, Christy Mathewson was named as an original inductee to the newly formed National Baseball Hall of Fame in 1936. As a result of his early passing and the era in which Matty played, there are exceedingly few examples of his single signed baseballs surviving to date.

The best remaining examples originate from a few charitable benefit auctions

that were held during the 1910-20 era, and there have been scant few of these "Holy Grail" Mathewson baseballs to surface. Offered is a crown jewel attributed with origins to that limited club.

Official John Heydler National League baseball exhibits light even age toning and surface wear retaining nicely visible manufacturer's stampings. Mathewson's classic penmanship is on full display in the form of a beautiful black fountain pen signature rightfully occupying the sweet spot position. Signature presents in uniform tonality rating 8 out of 10 having only some minor areas of surface flaking mentioned for accuracy only. This example originally entered the hobby in a 1994 auction conducted by Robert Edward Auctions. Through research in the period it was determined that the ball was attributed to have been one of the prized examples that was in fact signed by Mathewson to be offered at a charity benefit auction in the period. While this cannot be fully documented it is very likely accurate in light of the ball type, signing period and consistency with others of its attribution. Numerous such Mathewson signed baseballs were contributed by Matty to various charitable benefit auctions from as early as 1909 through the early 1920s era, as evidenced by accompanying copies from newspaper articles and original photographs. Very significant Matthewson single signature baseball which is without question among the finest ever offered at public auction. ## IMPORTANT 1931 LOU GEHRIG NEW YORK YANKEES PROFESSIONAL MODEL HOME JERSEY

Presented is a very rare and desirable original home garment as donned by Lou Gehrig during the 1931 New York Yankees home season. Cream color heavy gauge flannel jersey displaying its original blue pinstripes, having A.G. Spalding manufacturer's tagging affixed inside the collar area. Very fine "L.Gehrig" name identification chain stitched in red within the collar, displays beautifully with strong contrast. Body of the jersey exhibits heavy use including some areas of "thinning" to the shoulder areas including a few small portions of surface loss. The buttons are original to the shirt with exception of second button from the top which is a period replacement mentioned for accuracy only. The front of the jersey displays faint vestiges of the lettering "Stanton" from the Minor League team it had been passed to by the Yankees, as customary in the period. Reverse of the jersey displays a period navy blue Yankees "4" which was restored in the outline where the original "4" once resided when Gehrig wore the shirt. Vestiges of a slightly varied "4" are visible underneath, which is likely from Minor League numeral. Top of the back area under the collar also exhibits notable "thinning" including some surface loss.

"Fat strap" strip tag and partial straps remain at base of the back area of the shirt. General evident use is visible throughout including typical surface soiling and staining. The areas of thinning were expertly reinforced and the replacement "4" on the back was positioned by the renowned Textile Conservation Workshop in New York.

By 1931, Lou Gehrig had emerged from the shadow of Babe Ruth to rightfully assume his position as the finest player in the American League, if not all of baseball. While Ruth remained a dominant figure in the game, and others such as Jimmie Foxx had risen to prominance, the Iron Horse had established himself as an all around offensive force with no equal. Gehrig finished in second place only due to Lefty Grove's impossible season in which he compiled a 31-4 pitching record. During the 1931 campaign Gehrig batted .341 and led the league in four major categories: 163 Runs, 211 Hits, 46 Hone Runs and 185 RBIs.

Through examination by Resolution Photomatch in addition to other reviewed images of the period we are able to determine a very substantive and





thorough timeline of use for the offered jersey throughout the 1931 season. Gehrig is pictured in a series of images with dating between 4/14-4/16/1931 (See Plate I) which picture him wearing a long sleeve jersey having several fairly unique match points with the offered shirt. Subsequently, several other images dated 9/18/1931 (See Plate II) show Gehrig wearing the same jersey again with distinct matching features only now having the sleeves shortened from long to short. (\*NOTE: Detailed image/jersey comparisons with identified matching points available within online description). This photographic documentation provides a detailed corroborative to the well documented occurrence of Gehrig's preference for shortened sleeves during the warm weather months of the season. The heavy gauge wool jerseys of the period were very difficult to endure during the months of extreme summer heat, leading numerous players of the period to shorten the sleeves to lessen the effects of same. While not precisely an exact photo match there are a


number of very specific matching characteristics within the comparative images (and others during the 1931 season) which allow for presentation of this jersey as a likely photo matched exemplar. The documentation of use by Gehrig throughout the entire 1931 season provides additional insight into the heavy usage characteristics of the jersey as well. 
## ICONIC "WALTER KENT" BABE RUTH SINGLE SIGNED BASEBALL: UNIQUE AND IMPORTANT PHOTO MATCHED EXAMPLE (PSA/DNA 5.5)

Babe Ruth's appreciation for his youngest fans is very well documented through countless stories, photographs, inscribed autographs, and period interviews. This is largely believed to have been borne of his own experience as a youth within the St. Mary's School for Boys in Baltimore during a turbulent childhood. Equally well documented are the exaggerative tales of mythical proportions relating to various moments in Ruth's career. In both instances there is usually a blend of fact and fiction. This too can leak into memorabilia related to the Babe as often the related stories tend to expand the boundaries of accuracy. There are however exceptions wherein the history of a particular item is of equal importance to the piece itself.


In April of 1931, an eleven year old young boy by the name of Walter Kent Jr. was being treated for a brain tumor at Boston's Peter Bent Brigham Hospital. The young man had undergone several surgeries and had gone blind but retained an energetic outlook that only an eleven year old could. It was at this time that Babe Ruth had been admitted to the very same hospital for an injury to a ligament in his leg sustained during a game at Fenway Park. Given Walter Kent's condition and his love of baseball, he was brought up to meet the Babe while recovering in his room. Ruth and the young man enjoyed the meeting and the Babe sent Walter "some fruit and candy" according to period newspaper accounts. A few days later Ruth was to leave the hospital and as such Walter Kent was brought to Ruth in order to say goodbye. The Babe presented the boy with the offered baseball in order to raise his spirits and as a memory of their meeting. The farewell encounter was relayed in a period newspaper account, "KENT: Thank you for the candy and flowers which you sent me. I hope you will be better soon. RUTH: You look out for yourself. Never mind about me. You get better right away." Ruth then signed the baseball for Kent, shook his hand, and said to the boy, "Well, good bye sonny. I hope I see you again sometime. And I hope you'll be much better when I do." Kent would retain the baseball as his most cherished possession. Just six years later, in 1937, Walter Kent Jr. passed away from his illness with this very baseball at his bedside. The ball itself is a light evenly toned E.Barnard AL baseball (1927-31 period) which displays the very autograph on its side panel, "To My Pal Walter Kent From Babe Ruth". Black fountain pen signature remains very strong rating 8 out of 10 overall. There are a few areas of the inscription and autograph with some relatively minor "flaking" but overall eye appeal is very fine.

Appropriately, in 1998 the baseball was donated by the family of Walter Kent Jr. to "Hearts and Hands" which was a Massachusetts based charity that helped kids affected with similar issues to Walter. The ball was sold to benefit the the charity for an unprecedented amount at the time of its offering. This particular Ruth autographed baseball may well be the most well documented examples of any which have entered the marketplace. Furthermore, it embodies the human spirit for which Babe Ruth is so beloved. It's history and original intent can only be matched by what it must have meant to Walter Kent during his courageous medical battle. An extremely special baseball artifact of the highest desirability. Although the New York Yankees again secured the World Championship title in 1938, there were anomalies to Lou Gehrig's performance during the season. His numbers, by mortal standards, were very fine, but in comparison to his typical career statistics, there was a marked drop. In late 1938, Lou Gehrig explained, "I tired mid season. I don't know why, but I just couldn't get going again." Even during the 1938 World Series, Lou managed only four singles, which was further indication of his notable drop in power hitting.

With the coming of spring in 1939, the Yankees readied themselves to defend their two previous consecutive World Championships. At the very beginning of Spring Training, it was evident that something was not right with Lou Gehrig. Sportswriter James Kahn remarked at the time, "I think there is something wrong with him. Physically wrong, I mean. I don't know what it is, but I am satisfied that it goes far beyond his ball-playing. I have seen ballplayers 'go' overnight, as Gehrig seems to have done. But they were simply washed up as ballplayers. It's something deeper than that in this case, though. I have watched him very closely and this is what I have seen: I have seen him time a ball perfectly, swing on it as hard as he can, meet it squarely, and drive a soft, looping fly over the infield. In other words, for some reason that I do not know, his old power isn't there... He is meeting the ball, time after time, and it isn't going anywhere." Others took notice as well. Manager Joe McCarthy, who had always been one of Gehrig's closest mentors on the Yankees, tried to support Gehrig's meager play, hoping that he would eventually snap back to the form once considered as a given for the Yankee slugger.

During the first month of the 1939 season, Gehrig's statistics were abysmal with a .143 batting average and only a single RBI. On April 30, 1939, the Yankees were at home playing a game against the Washington Senators. As the 1939 World's Fair opened across town to enormous crowds, the Yankees played the April 30th game before a modest gate number of 23,712. Little did those fans realize they were witnesses to history. Gehrig went 0 for 4 that

fateful day, adding fuel to the swirling speculation that he should be removed from the Yankees lineup. The next day was a day off, before the team would open a series in Detroit against the Tigers. On May 2, 1939, Lou Gehrig sought out Yankees manager Joe McCarthy in the Book Cadillac Hotel in Detroit. Arthur E. Patterson recounted the meeting in the New York Herald Tribune: "Joe, I'd like to talk to you," Gehrig said. "Sure thing, Lou. C'mon around the corner here and sit down," McCarthy said. "Joe, I'm not helping this team any," Gehrig said. "I know I look terrible out there. This string of mine doesn't mean a thing to me. It isn't fair to the boys for me to stay in there. Joe, I want you to take me out of the lineup today." While it was difficult for Gehrig's longtime friend and manager to hear, McCarthy understood Gehrig's intentions and granted his request.

At the insistence of Gehrig himself, in what has become one of the more legendary and poignant moments of the era, Gehrig mandated that he be permitted to deliver the lineup card to home plate on May 2, 1939 without his name written in the starting nine. With tears in the eyes of the once great and powerful Yankee slugger, Gehrig stoically presented the Yankees lineup card to the umpires with the name "Babe Dahlgren" written in as first baseman, so ending his streak of 2,130 consecutive games played. John Kieran of The New York Times wrote, "So they unhitched the Iron Horse from the old wagon, but Marse Joe McCarthy didn't order him to be taken behind the barn and destroyed." More tragically, it would mark the beginning of the final chapter in Gehrig's life, as he was diagnosed shortly thereafter with a terminal illness, amyotrophic lateral sclerosis. Although Gehrig would press on to deliver the most famous oration in sports history with his July 4, 1939 "Luckiest Man" speech, his stature as the "Iron Man" of baseball had come to an end. Fitting for a man of Gehrig's integrity, the "Iron Horse" succumbed to the horrid disease on June 2, 1941, at 10:10 p.m., sixteen years to the day after he had first replaced Wally Pipp as first baseman for the New York Yankees.

Dear Paul:

I immensely appreciate your having ampules of thismin made up and shipped to me. The reason for my asking for prescriptions is that I have so little confidence in New York medicine and New York pharmacies after seeing your institution that I much prefer and feel a great deal safer when I receive the ingredients directly from you. I also could not figure out whether a New York pharmacist would not think me crazy if I were to walk in and ask for "five mg. ampules of thismin chloride".

I do not quite understand from your wire whether you went me to take 100 mg. doses of nicotinic acid and also 50 mg. doses of absorbic acid intravenously or by mouth as I have been doing. I have plenty of pills of each one left and can very easily have these refilled at your basement drugstore. If you have decided that I am to take these via injections, I would appreciate it if you will recommend to me a reliable drug company here in New York or have Weber and Judd make them up and send them to me in the form of pmpules. I hate to sound so ignorant, but after all what does an oil can ball player know about medicine.

I hate to appear so obstinately persistent, but I want you to know how deeply I regret that you can't make the Cincinnati trip. At the end of the letter he includes, "I am on my way to the Baseball Writer's Dinner tonight, and if it is possible at all, I shall make every effort to send an autographed menu to Pat". Amazingly, the archive includes the actual signed program that Gehrig references in his letter. Program is signed on the back by several attendees including Herbert Hoover, Honus Wagner, Ed Barrow and Ford Frick, with the pencil autographs having been enhanced in ink.

There will be fewer people unemployed and everybody will work longer hours and harder than ever before.....And that means that they ought to have a chance for recreation and for taking their minds off their work even more than before.... Here is another way of looking at it - if 300 teams use 5,000 or 6,000 players, these players are a definite recreational asset to at least 20,000,000 of the fellow citizens - and that in my judgment is thoroughly worthwhile." # United States All-Star Tour of Japan

Lots 110 - 140

The United States All-Star Team Tours of Japan in the early 1930s remain an impressive feat of soft diplomacy, as some of the greatest baseball players in the world were sent to promote the sport, and ideally ease heightening political tensions. The 1934 team in particular remains to date one of the most iconic teams of its type for any sport. The team was comprised of an incredible line up featuring the most feared sluggers in Major League Baseball at the time, including Babe Ruth, Lou Gehrig and Jimmie Foxx. Aside from the goal of drawing business and notoriety for the Japanese newspaper that sponsored the Tour, it was the hope of the United States that bringing these baseball stars to Japan could assuage US-Japanese political tensions. By all accounts, the Tour was a resounding success, and in some circles was believed to have cast aside the growing cloud of war between the two countries. Although the legend of the Tours have endured, its luster was greatly tarnished by December 7, 1941 when the Japanese attacked Pearl Harbor, drawing the United States into World War II, much to the dismay of the era's legendary ball stars.

Incredibly poignant and remarkably personal Marilyn Monroe handwritten letter is penned on the reverse of a dry cleaning receipt. The letter reads as follows:

"Dear Joe, I know I was wrong! I acted the way I did and said the things I did because I was hurt - not because I meant them-and it was stupid of me to be hurt because actually there wasn't enough reason-in fact no reason at all. Please accept my apology and don't, don't, don't, don't be angry with your baby-she loves you. Lovingly, your wife (for life) Mrs. J.P. DiMaggio."

The letter was discovered within Joe DiMaggio's wallet, which contained other objects dating to the 1954 era. Due to years of storage and likely handling from time to time by the recipient, the letter has separated into four equal sections. Although it could be restored to one piece, there is a certain appeal to leaving the note as it had been treasured by Joe for those many years.

The wallet and its contents remain exactly as they were found, including several membership cards issued to Joe (unsigned), a few pieces of foreign currency, and a charming photo of Joe Jr. putting air into a tire. The wallet itself was obviously one of Joe's favorites, as it had been used to the degree that several joints have split at the sides. "JD" monogram is impressed on the front.

The letter corroborates the loving and yet challenging relationship that the two American icons enjoyed. It had been long rumored within the media at the time that their relationship was publicity driven, which subsequently has been proven otherwise by several period documents inclusive of the offered letter. #### 1 DESCRIPTION OF LOTS

#### 3 CONDITION

If Christie's delivers the **lot** to, or the **lot** is collected by, any framer, restorer or other similar service provider in New York that you have hired, New York law considers the **lot** delivered to the successful bidder in New York and New York sales tax must be imposed regardless of the ultimate destination of the **lot**. In this circumstance, New York sales tax will apply to the **lot** even if Christie's or a common carrier (authorized by Christie's that you hire) subsequently delivers the **lot** outside New York.

Successful bidders claiming an exemption from sales tax must provide appropriate documentation to Christie's prior to the release of the lot or within 90 days after the sale, whichever is earlier. For shipments to those states for which Christie's is not required to collect sales tax, a successful bidder may have a use or similar tax obligation. #### E WARRANTIES

### 1 SELLER'S WARRANTIES For each lot, the seller gives a warranty that the seller:

- (a) is the owner of the **lot** or a joint owner of the **lot** acting with the permission of the other co-owners or, if the seller is not the owner or a joint owner of the **lot**, has the permission of the owner to sell the **lot**, or the right to do so in law; and
- (b) has the right to transfer ownership of the lot to the buyer without any restrictions or claims by anyone else.

If either of the above **warranties** are incorrect, the seller shall not have to pay more than the **purchase price** (as defined in paragraph F<sub>1</sub>(a) below) paid by you to us. The seller will not be responsible to you for any reason for loss of profits or business, expected savings, loss of opportunity or interest, costs, damages, **other damages** or expenses. The seller gives no **warranty** in relation to any **lot** other than as set out above and, as far as the seller is allowed by law, all **warranties** from the seller to you, and all other obligations upon the seller which may be added to this agreement by law, are excluded.

#### 2 OUR AUTHENTICITY WARRANTY

We warrant, subject to the terms below, that the lots in our sales are authentic (our "authenticity warranty"). If, within 5 years of the date of the auction, you give notice to us that your lot is not authentic, subject to the terms below, we will refund the purchase price paid by you. The meaning of authentic can be found in the glossary at the end of these Conditions of Sale. The terms of the authenticity warranty are as follows:

- (a) It will be honored for claims notified within a period of 5 years from the date of the auction. After such time, we will not be obligated to honor the authenticity warranty.
- (b) It is given only for information shown in UPPERCASE type in the first line of the catalogue description (the "Heading"). It does not apply to any information other than in the Heading even if shown in UPPERCASE type.

- (c) The authenticity warranty does not apply to any Heading or part of a Heading which is qualified. Qualified means limited by a clarification in a lot's catalogue description or by the use in a Heading of one of the terms listed in the section titled Qualified Headings on the page of the catalogue headed "Important Notices and Explanation of Cataloguing Practice". For example, use of the term "ATTRIBUTED TO..." in a Heading means that the lot is in Christic's opinion probably a work by the named artist but no warranty is provided that the lot is the work of the named artist. Please read the full list of Qualified Headings and a lot's full catalogue description before bidding.
- (d) The authenticity warranty applies to the Heading as amended by any Saleroom Notice.
- e) The authenticity warranty does not apply where scholarship has developed since the auction leading to a change in generally accepted opinion. Further, it does not apply if the **Heading** either matched the generally accepted opinion of experts at the date of the auction or drew attention to any conflict of opinion.
- (f) The authenticity warranty does not apply if the lot can only be shown not to be authentic by a scientific process which, on the date we published the catalogue, was not available or generally accepted for use, or which was unreasonably expensive or impractical, or which was likely to have damaged the lot.
- (g) The benefit of the authenticity warranty is only available to the original buyer shown on the invoice for the lot issued at the time of the sale and only if on the date of the notice of claim, the original buyer is the full owner of the lot and the lot is free from any claim, interest or restriction by anyone else. The benefit of this authenticity warranty may not be transferred to anyone else.
- (h) In order to claim under the authenticity warranty you must:
  - (i) give us written notice of your claim within 5 years of the date of the auction. We may require full details and supporting evidence of any such claim;
  - (ii) at Christie's option, we may require you to provide the written opinions of two recognised experts in the field of the lot mutually agreed by you and us in advance confirming that the lot is not authentic. If we have any doubts, we reserve the right to obtain additional opinions at our expense; and
  - (iii) return the lot at your expense to the saleroom from which you bought it in the condition it was in at the time of sale.
- (i) Your only right under this authenticity warranty is to cancel the sale and receive a refund of the purchase price paid by you to us. We will not, under any circumstances, be required to pay you more than the purchase price nor will we be liable for any loss of profits or business, loss of opportunity or value, expected savings or interest, costs, damages, other damages or expenses.
- (j) Books. Where the lot is a book, we give an additional warranty for 21 days from the date of the auction that any lot is defective in text or illustration, we will refund your purchase price, subject to the following terms:
  - (a) This additional warranty does not apply to:(i) the absence of blanks, half titles, tissue guards or
  - (i) the absence of blanks, half titles, tissue guards or advertisements, damage in respect of bindings, stains, spotting, marginal tears or other defects not affecting completeness of the text or illustration;
  - (ii) drawings, autographs, letters or manuscripts, signed photographs, music, atlases, maps or periodicals;
  - (iii) books not identified by title;
  - (iv) lots sold without a printed estimate;
  - (v) books which are described in the catalogue as sold not subject to return; or
  - (vi) defects stated in any condition report or announced at the time of sale.
  - (b) To make a claim under this paragraph you must give written details of the defect and return the lot to the sale room at which you bought it in the same condition as at the time of sale, within 21 days of the date of the sale.
- (k) South East Asian Modern and Contemporary Art and Chinese Calligraphy and Painting. In these categories, the authenticity warranty does not apply because current scholarship does not permit the making of definitive statements. Christie's does, however, agree to cancel a slae in either of these two categories of art where it has been proven the lot is a forgery. Christie's will refund to the original buyer the purchase price in accordance with the terms of Christie's Authenticity Warranty, provided that the original buyer notifies us with full supporting evidence documenting the forgery claim within twelve (12) months of the date of the auction.

- Such evidence must be satisfactory to us that the property is a forgery in accordance with paragraph E2(h)(ii) above and the property must be returned to us in accordance with E2h(iii) above. Paragraphs E2(b), (c), (d), (e), (f) and (g) and (i) also apply to a claim under these categories.
- (I) Chinese, Japanese and Korean artefacts (excluding Chinese, Japanese and Korean calligraphy, paintings, prints, drawings and jewellery). In these categories, paragraph E2 (b) (e) above shall be amended so that where no maker or artist is identified, the authenticity warranty is given not only for the Heading but also for information regarding date or period shown in UPPERCASE type in the second line of the catalogue description (the "Subheading"). Accordingly, all references to the Heading in paragraph E2 (b) (e) above shall be read as references to both the Heading and the Subheading.

#### **3 YOUR WARRANTIES**

- (a) You warrant that the funds used for settlement are not connected with any criminal activity, including tax evasion, and you are neither under investigation, nor have you been charged with or convicted of money laundering, terrorist activities or other crimes.
- (b) where you are bidding on behalf of another person, you warrant that:
- (i) you have conducted appropriate customer due diligence on the ultimate buyer(s) of the lot(s) in accordance with all applicable anti-money laundering and sanctions laws, consent to us relying on this due diligence, and you will retain for a period of not less than 5 years the documentation evidencing the due diligence. You will make such documentation promptly available for immediate inspection by an independent third-party auditor upon our written request to do so;
- (ii) the arrangements between you and the ultimate buyer(s) in relation to the lot or otherwise do not, in whole or in part, facilitate tax crimes;
- (iii) you do not know, and have no reason to suspect, that the funds used for settlement are connected with, the proceeds of any criminal activity, including tax evasion, or that the ultimate buyer(s) are under investigation, or have been charged with or convicted of money laundering, terrorist activities or other crimes.

#### F PAYMENT

#### 1 HOW TO PAY

- (a) Immediately following the auction, you must pay the **purchase price** being:

#### 2 TRANSFERRING OWNERSHIP TO YOU

You will not own the **lot** and ownership of the **lot** will not pass to you until we have received full and clear payment of the **purchase price**, even in circumstances where we have released the **lot** to you.

#### 3 TRANSFERRING RISK TO YOU

The risk in and responsibility for the **lot** will transfer to you from whichever is the earlier of the following:

- (a) When you collect the lot; or
- (b) At the end of the 30th day following the date of the auction or, if earlier, the date the lot is taken into care by a third party warehouse as set out on the page headed 'Storage and Collection', unless we have agreed otherwise with you.

  - (viii) we can exercise all the rights and remedies of a person holding security over any property in our possession owned by you, whether by way of pledge, security interest or in any other way as permitted by the law of the place where such property is located. You will be deemed to have granted such security to us and we may retain such property as collateral security for your obligations to us; and
  - (ix) we can take any other action we see necessary or appropriate.
- (b) If you owe money to us or to another Christie's Group company, we can use any amount you do pay, including any deposit or other part-payment you have made to us, or which we owe you, to pay off any amount you owe to us or another Christie's Group company for any transaction.

#### 5 KEEPING YOUR PROPERTY

If you owe money to us or to another Christie's Group company, as well as the rights set out in F4 above, we can use or deal with any of your property we hold or which is held by another Christie's Group company in any way we are allowed to by law. We will only release your property to you after you pay us or the relevant Christie's Group company in full for what you owe. However, if we choose, we can also sell your property in any way we think appropriate. We will use the proceeds of the sale against any amounts you owe us and we will pay any amount left from that sale to you. If there is a shortfall, you must pay us any difference between the amount we have received from the sale and the amount you owe us.

#### G COLLECTION AND STORAGE

(a) You must collect purchased lots within seven days from the auction (but note that lots will not be released to you until you have made full and clear payment of all amounts due to us).

- (b) Information on collecting lots is set out on the storage and collection page and on an information sheet which you can get from the bidder registration staff or Christie's Post-Sale Services Department on +1 212 636 2650.

However, we can arrange to pack, transport, and ship your property if you ask us to and pay the costs of doing so. We recommend that you ask us for an estimate, especially for any large items or items of high value that need professional packing. #### 2 EXPORT AND IMPORT

Any lot sold at auction may be affected by laws on exports from the country in which it is sold and the import restrictions of other countries. Many countries require a declaration of export for property leaving the country and/or an import declaration on entry of property into the country. Local laws may prevent you from importing a lot or may prevent you selling a lot in the country you import it into.

- (b) (i) We are not responsible to you for any reason (whether for breaking this agreement or any other matter relating to your purchase of, or bid for, any lot) other than in the event of fraud or fraudulent misrepresentation by us or other than as expressly set out in these conditions of sale; or
  - (ii) give any representation, warranty or guarantee or assume any liability of any kind in respect of any lot with regard to merchantability, fitness for a particular purpose, description, size, quality, condition, attribution, authenticity, rarity, importance, medium, provenance, exhibition history, literature, or historical relevance. Except as required by local law, any warranty of any kind is excluded by this paragraph.
- (c) In particular, please be aware that our written and telephone bidding services, Christie's LIVE™, condition reports, currency converter and saleroom video screens are free services and we are not responsible to you for any error (human or otherwise), omission or breakdown in these services.
- (d) We have no responsibility to any person other than a buyer in connection with the purchase of any lot.
- (e) If, in spite of the terms in paragraphs I(a) to (d) or E2(i) above, we are found to be liable to you for any reason, we shall not have to pay more than the purchase price paid by you to us. We will not be responsible to you for any reason for loss of profits or business, loss of opportunity or value, expected savings or interest, costs, damages, or expenses.

#### J OTHER TERMS

#### **OUR ABILITY TO CANCEL**

In addition to the other rights of cancellation contained in this agreement, we can cancel a sale of a lot if: (i) any of your warranties in paragraph E3 are not correct; (ii) we reasonably believe that completing the transaction is, or may be, unlawful; or (iii) we reasonably believe that the sale places us or the seller under any liability to anyone else or may damage our reputation.

#### 2 RECORDINGS

We may videotape and record proceedings at any auction. We will keep any personal information confidential, except to the extent disclosure is required by law. However, we may, through this process, use or share these recordings with another Christie's Group company and marketing partners to analyse our customers and to help us to tailor our services for buyers. If you do not want to be videotaped, you may make arrangements to make a telephone or written bid or bid on Christie's LIVETM instead. Unless we agree otherwise in writing, you may not videotape or record proceedings

We own the copyright in all images, illustrations and written material produced by or for us relating to a lot (including the contents of our catalogues unless otherwise noted in the catalogue). You cannot use them without our prior written permission. We do not offer any guarantee that you will gain any copyright or other reproduction rights to the lot.

#### 4 ENFORCING THIS AGREEMENT

If a court finds that any part of this agreement is not valid or is illegal or impossible to enforce, that part of the agreement will be treated as being deleted and the rest of this agreement will not be affected.

#### TRANSFERRING YOUR RIGHTS AND RESPONSIBILITIES

You may not grant a security over or transfer your rights or responsibilities under these terms on the contract of sale with the buyer unless we have given our written permission. This agreement will be binding on your successors or estate and anyone who takes over your rights and responsibilities.

#### 6 TRANSLATIONS

If we have provided a translation of this agreement, we will use this original version in deciding any issues or disputes which arise under this agreement.

#### 7 PERSONAL INFORMATION

We will hold and process your personal information and may pass it to another Christie's Group company for use as described in, and in line with, our privacy notice at www.christies.com/about-us/contact/privacy and if you are a resident of California you can see a copy of our California Consumer Privacy Act statement at www.christies.com/about-us/contact/ccpa.

#### 8 WAIVER

No failure or delay to exercise any right or remedy provided under these Conditions of Sale shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

#### 9 I AW AND DISPUTES

This agreement, and any non-contractual obligations arising out of or in connection with this agreement, or any other rights you may have relating to the purchase of a lot will be governed by the laws of New York. Before we or you start any court proceedings (except in the limited circumstances where the dispute, controversy or claim is related to proceedings brought by someone else and this dispute could be joined to those proceedings), we agree we will each try to settle the dispute by mediation submitted to JAMS, or its successor, for mediation in New York. If the Dispute is not settled by mediation within 60 days from the date when mediation is initiated, then the Dispute shall be submitted to JAMS, or its successor, for final and binding arbitration in accordance with its Comprehensive Arbitration Rules and Procedures or, if the Dispute involves a non-U.S. party, the JAMS International Arbitration Rules. The seat of the arbitration shall be New York and the arbitration shall be conducted by one arbitrator, who shall be appointed within 30 days after the initiation of the arbitration. The language used in the arbitral proceedings shall be English. The arbitrator shall order the production of documents only upon a showing that such documents are relevant and material to the outcome of the Dispute. The arbitration shall be confidential, except to the extent necessary to enforce a judgment or where disclosure is required by law. The

arbitration award shall be final and binding on all parties involved. Judgment upon the award may be entered by any court having jurisdiction thereof or having jurisdiction over the relevant party or its assets. This arbitration and any proceedings conducted hereunder shall be governed by Title 9 (Arbitration) of the United States Code and by the United Nations Convention on the Recognition and Enforcement of Foreign Arbitral Awards of June 10, 1958.


