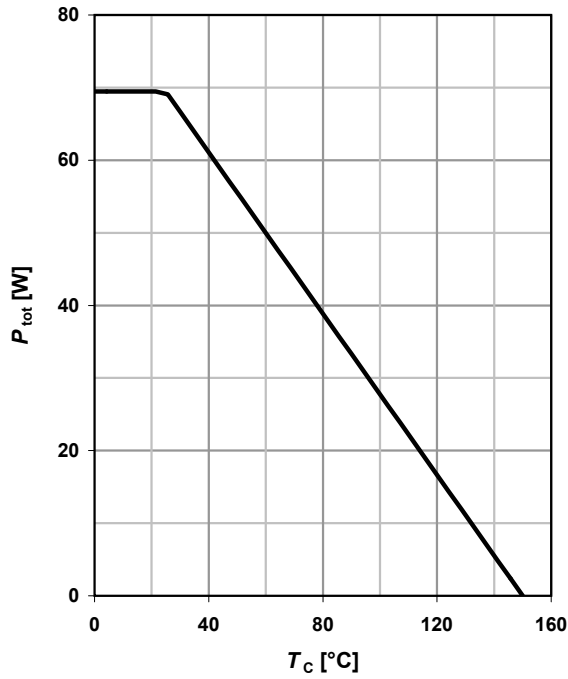

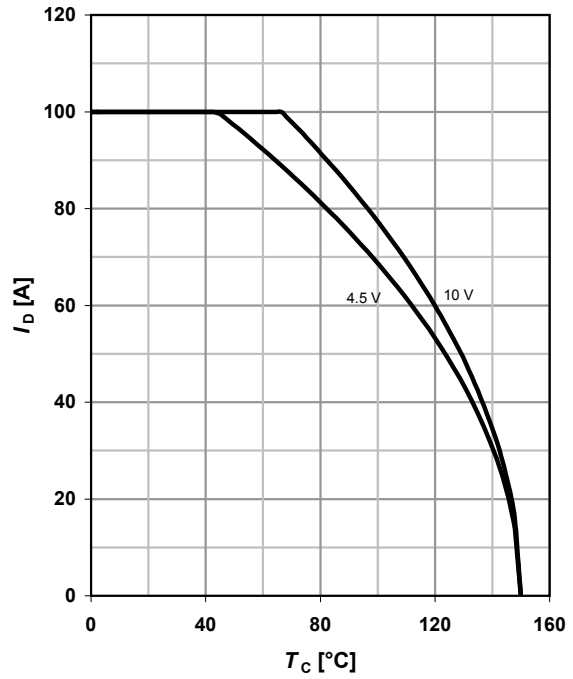

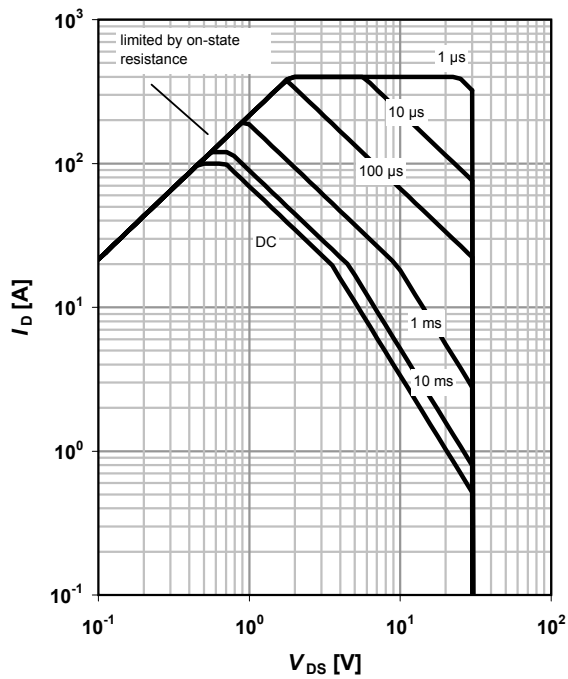

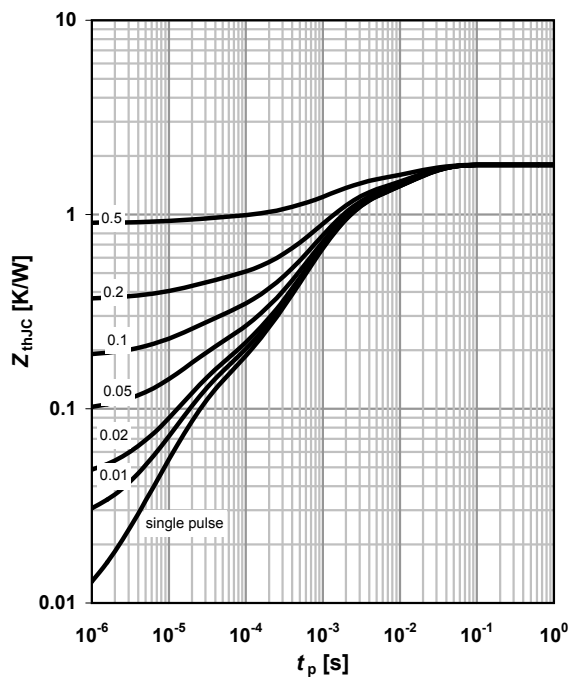

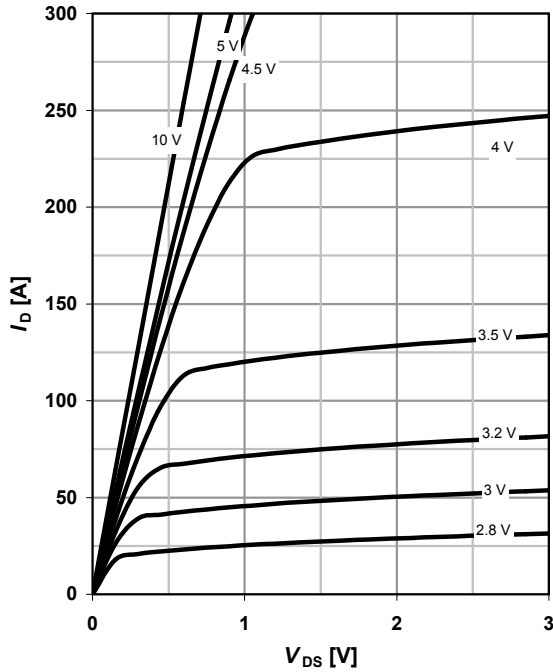

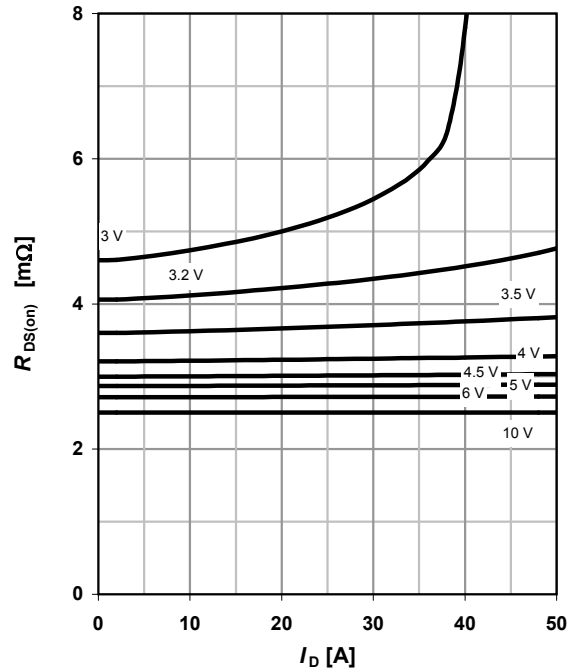

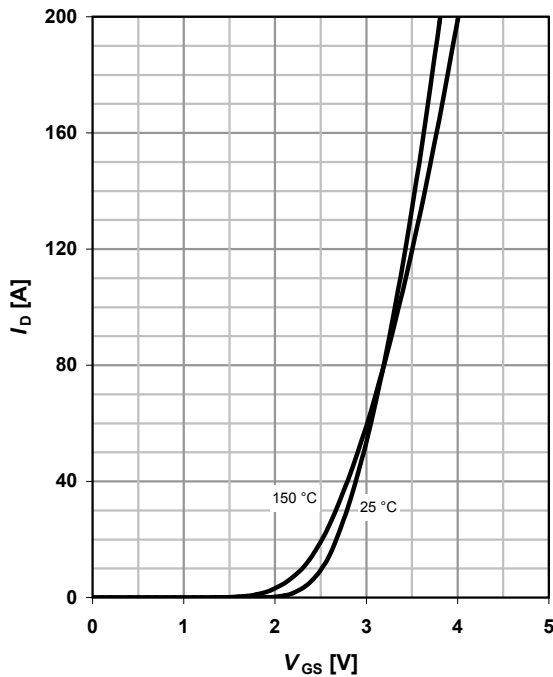

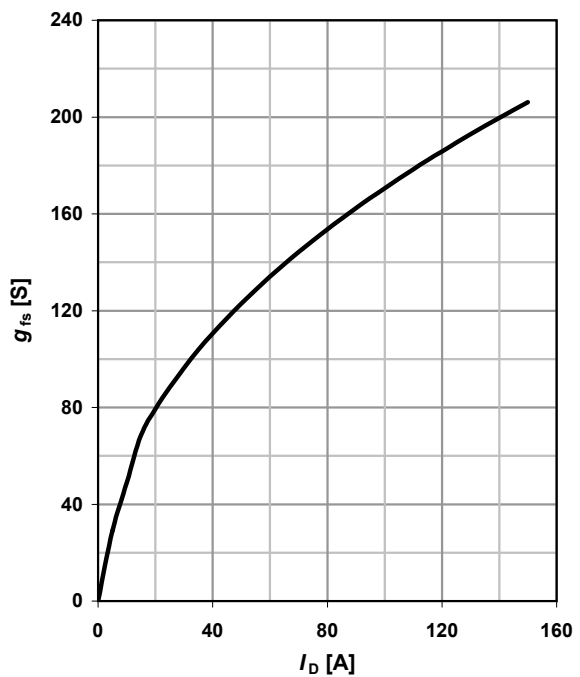

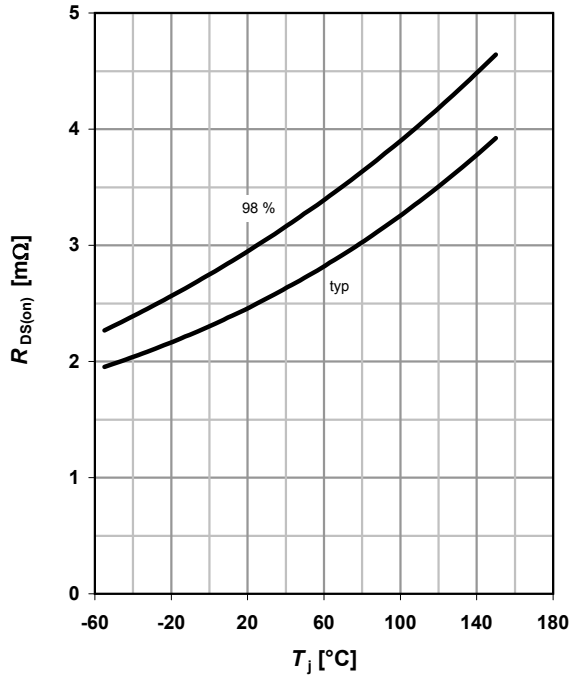
8 Typ. forward transconductance

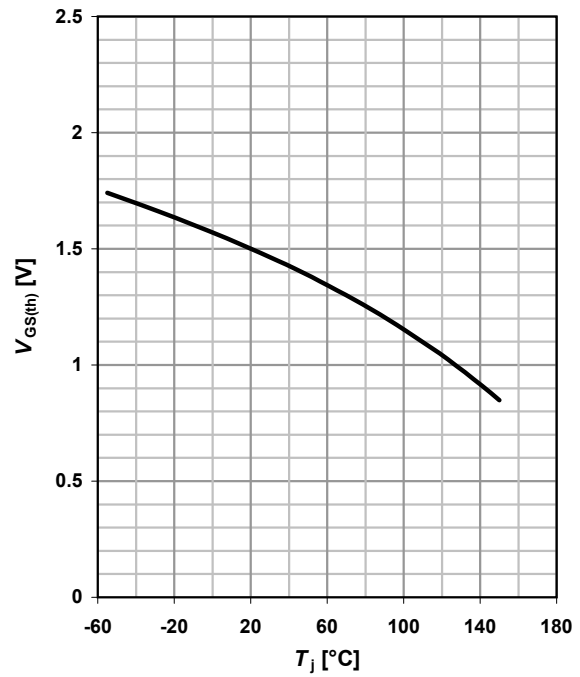

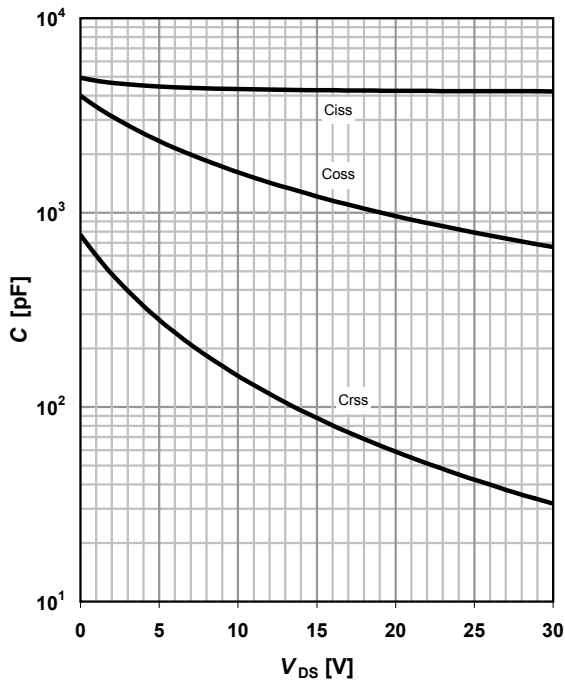

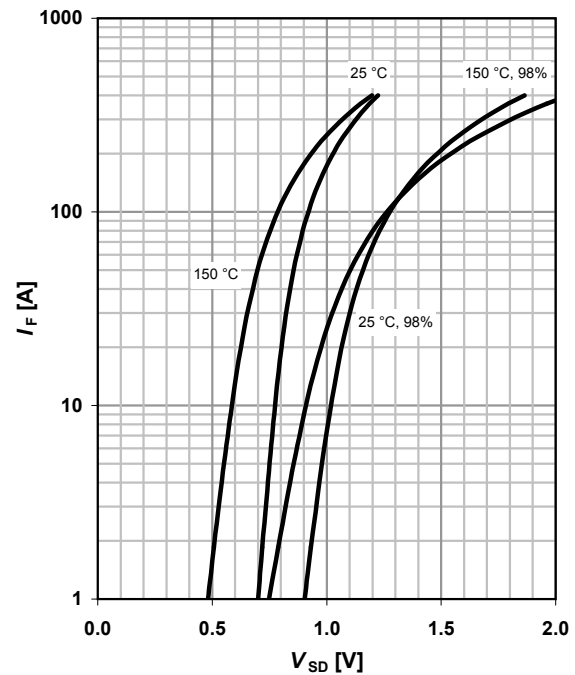

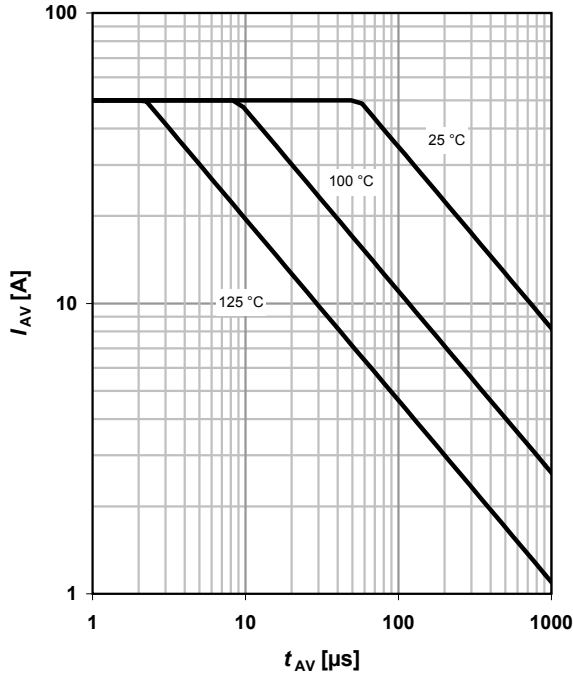

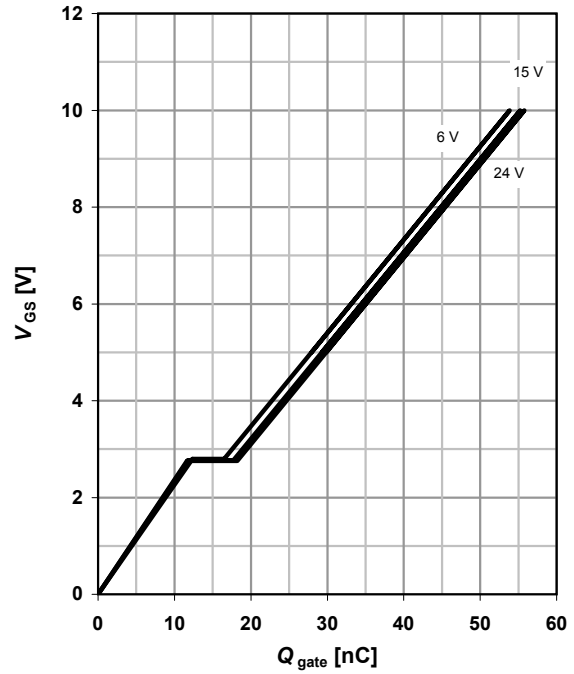

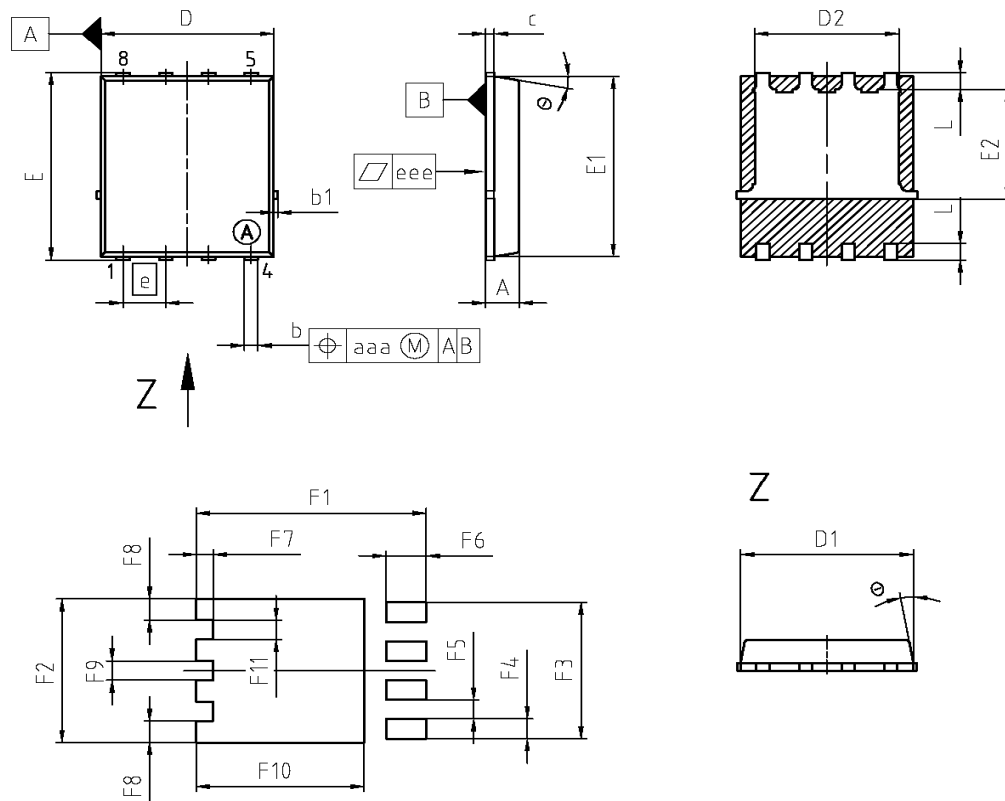


16 Gate charge waveforms
