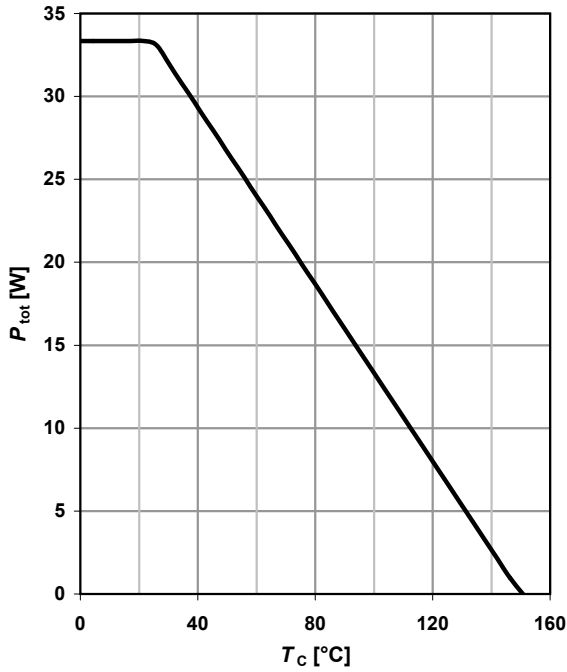

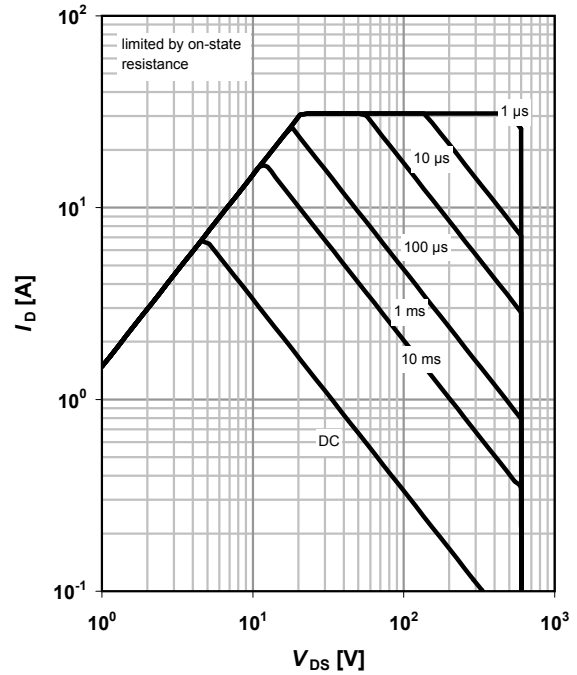

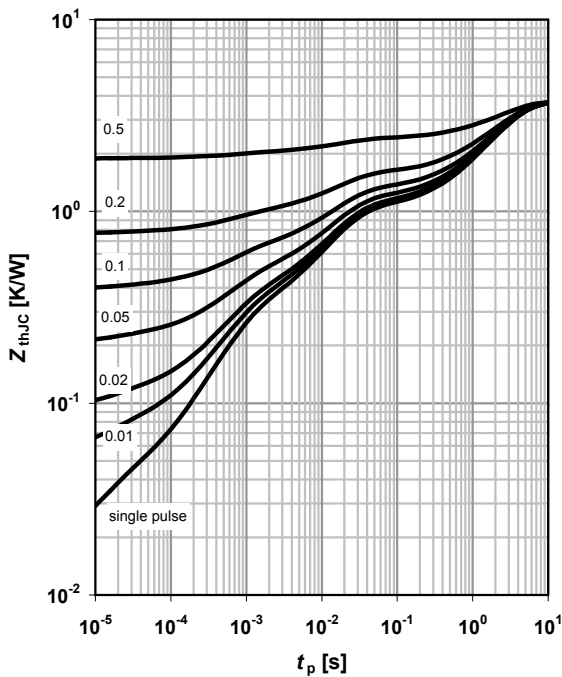

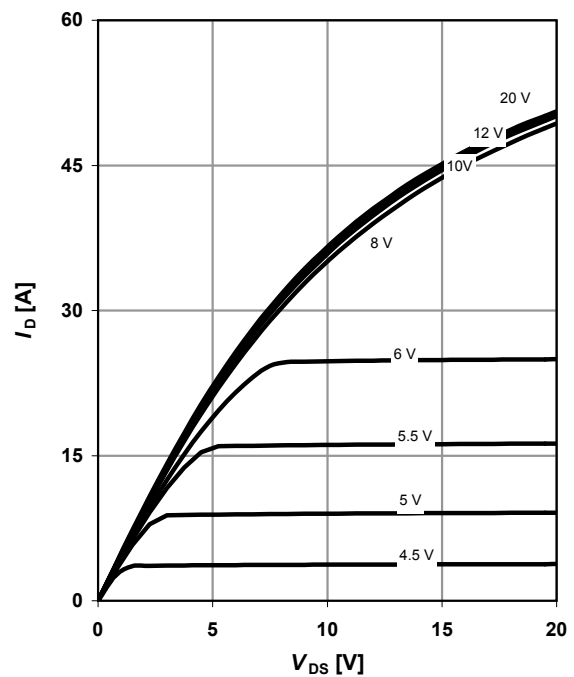

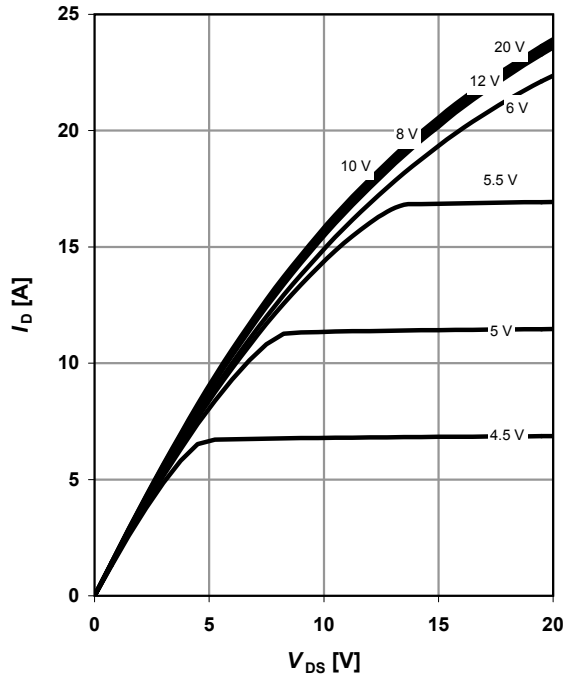

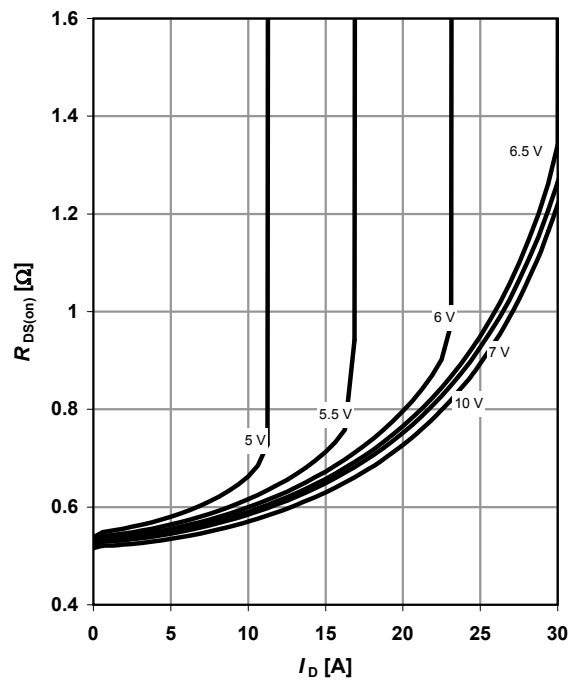

6 Typ. drain-source on-state resistance

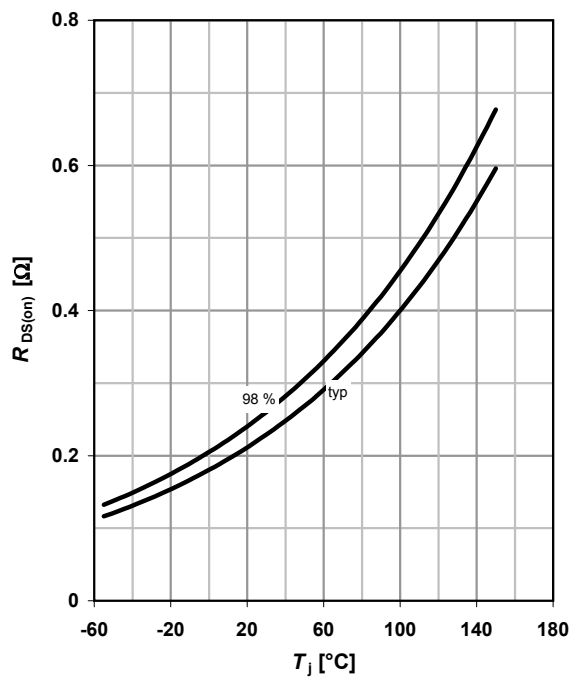

7 Drain-source on-state resistance

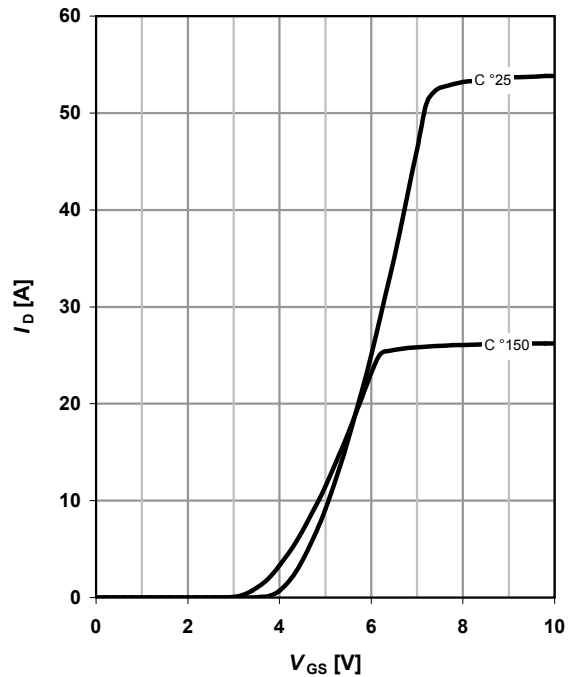

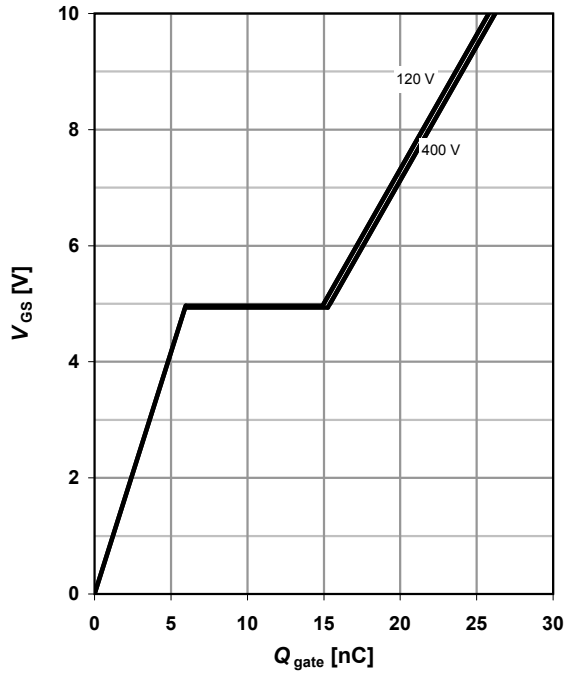

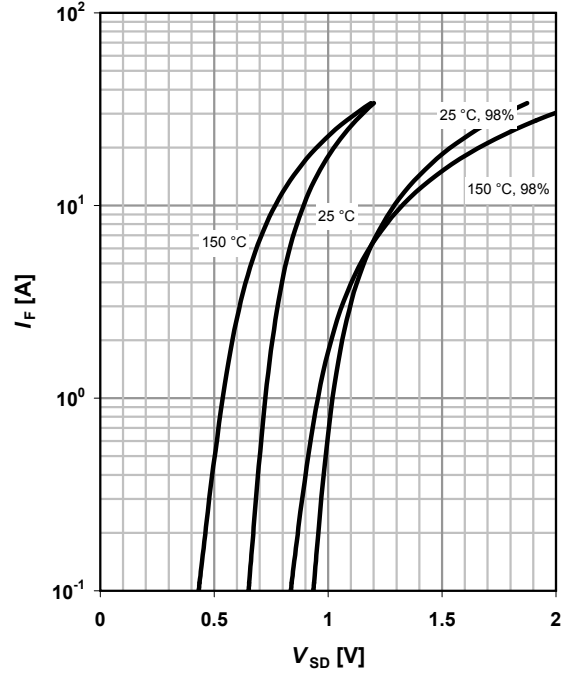

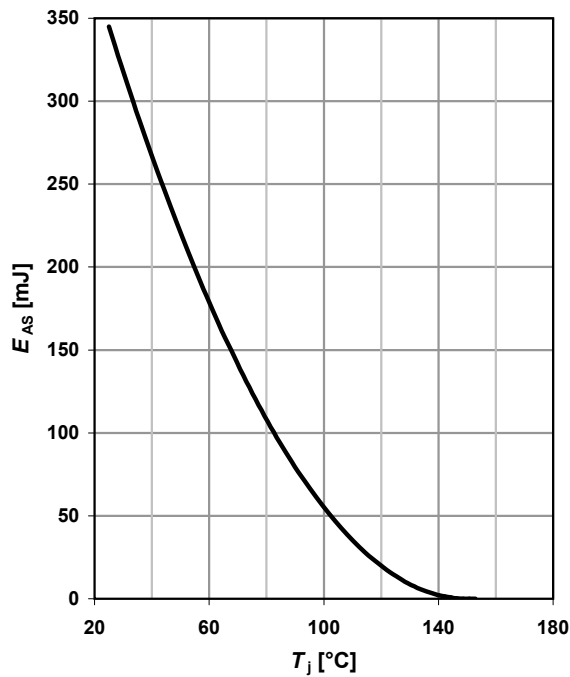

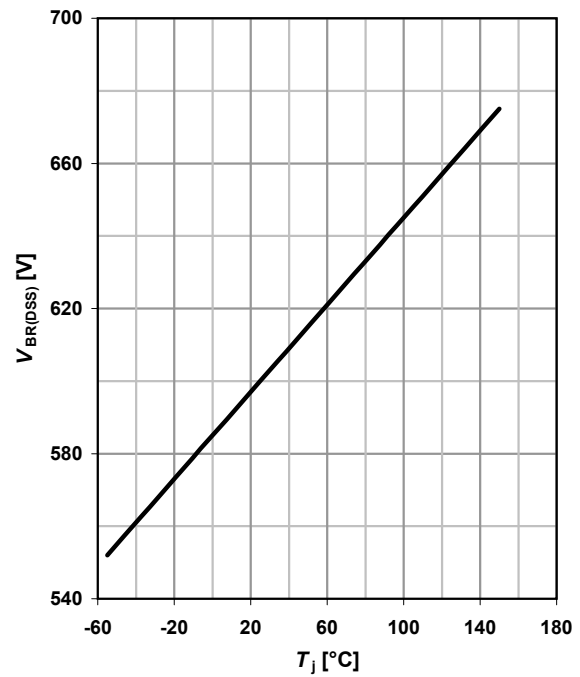

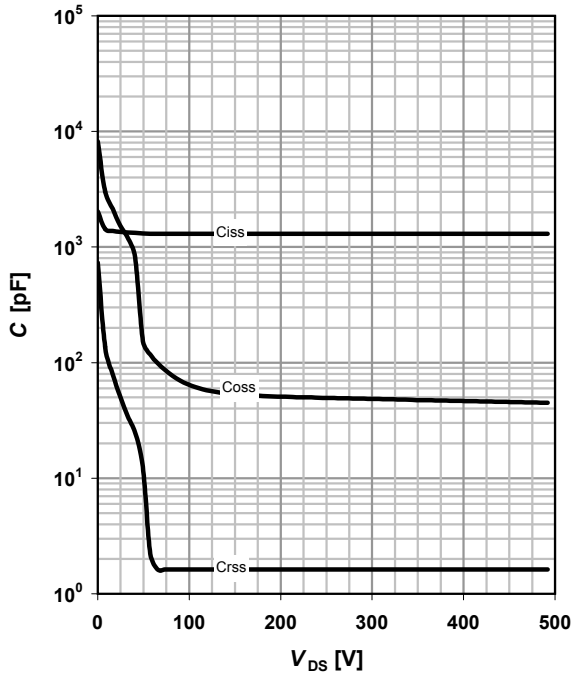
12 Drain-source breakdown voltage

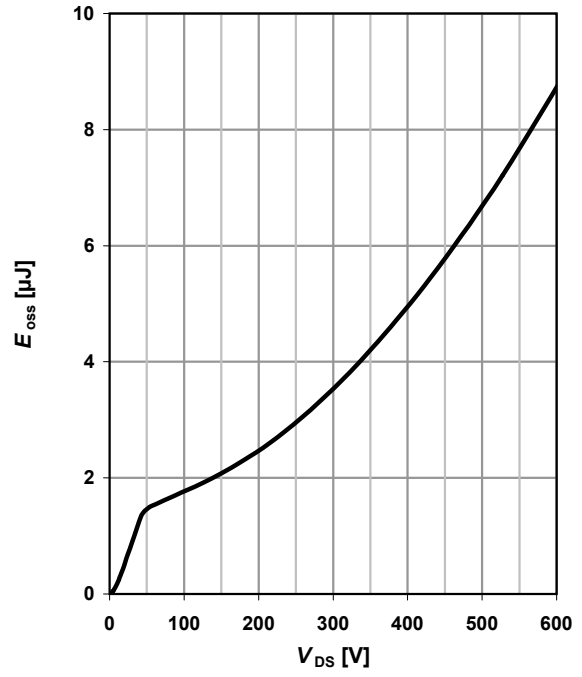
13 Typ. capacitances

14 Typ. Coss stored energy

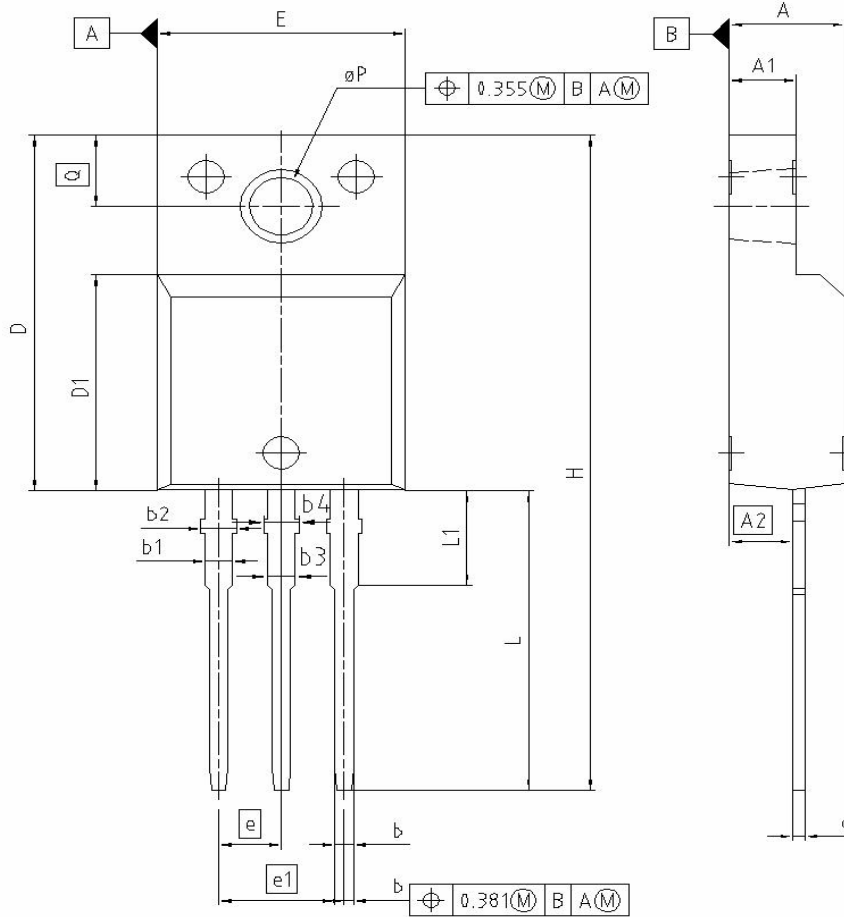
