### 1. General description

The 74AHCT04A is a hex inverter.

Designed to operate over a  $V_{CC}$  range from 4.5 V to 5.5 V, the inputs are TTL compatible, which allows the device to be used to translate from 3.3 V to 5 V.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device is fully specified for partial Power-down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.

- Specified from -40 °C to +85 °C and from -40 °C to +125 °C









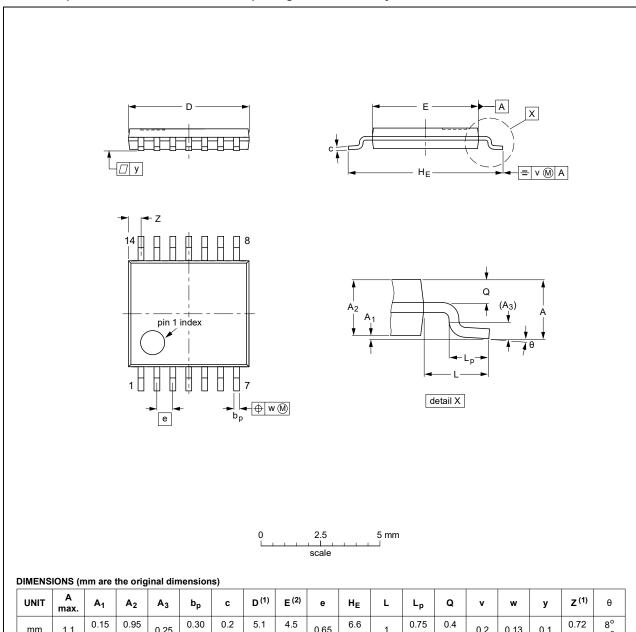
