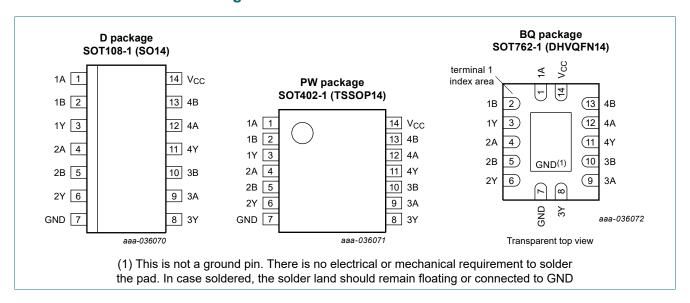

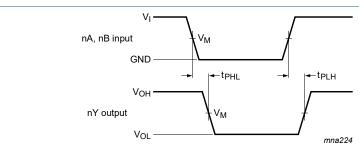

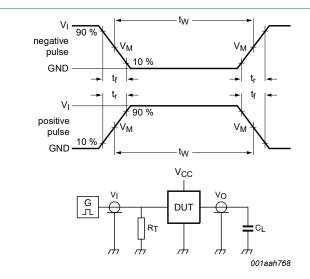

Fig. 5. Test circuit for measuring switching times

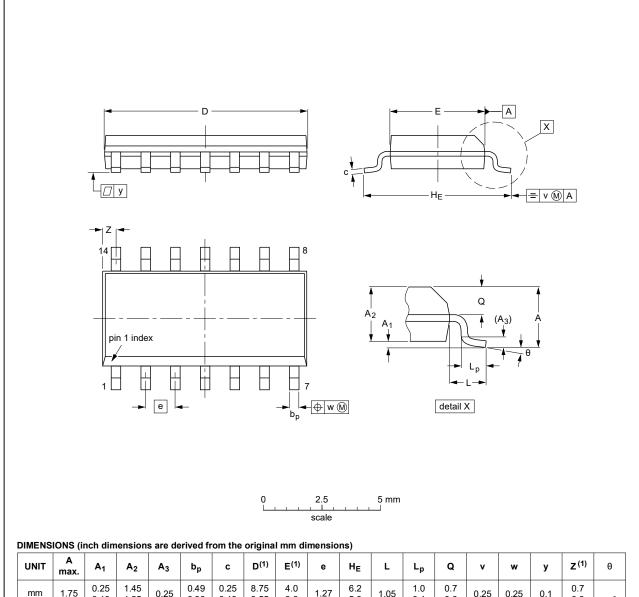

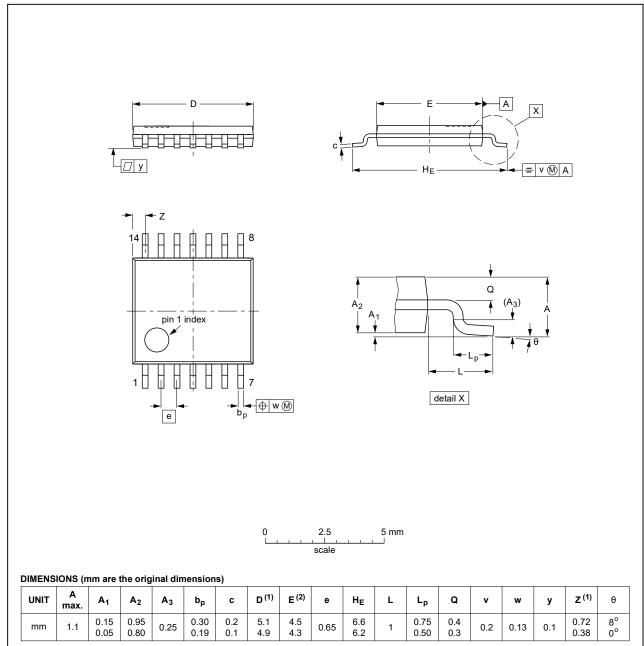

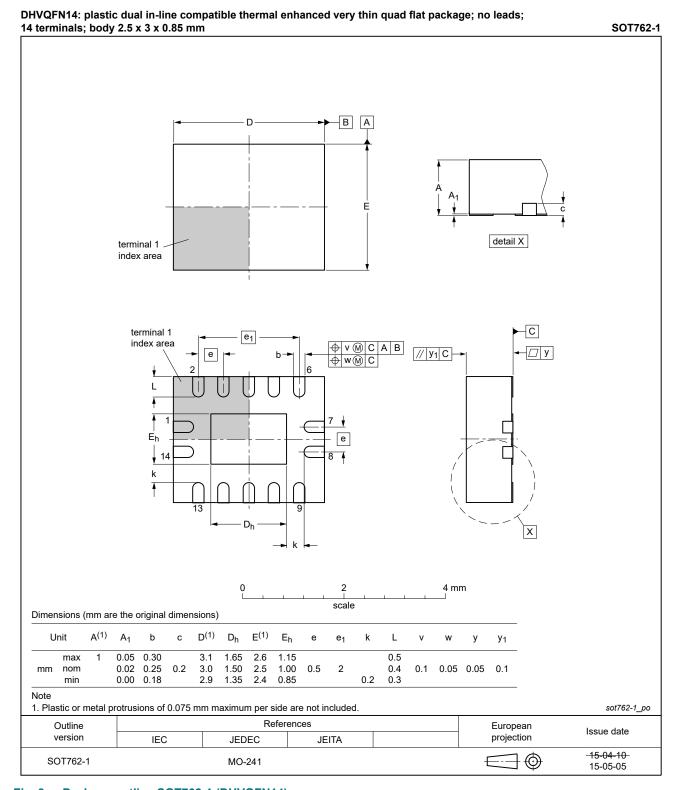


Fig. 8. Package outline SOT762-1 (DHVQFN14)
