







Fig. 7. Test circuit for measuring switching times

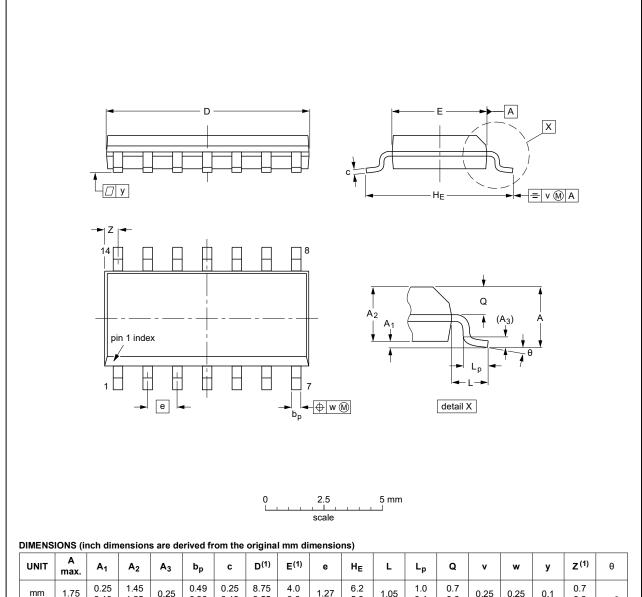



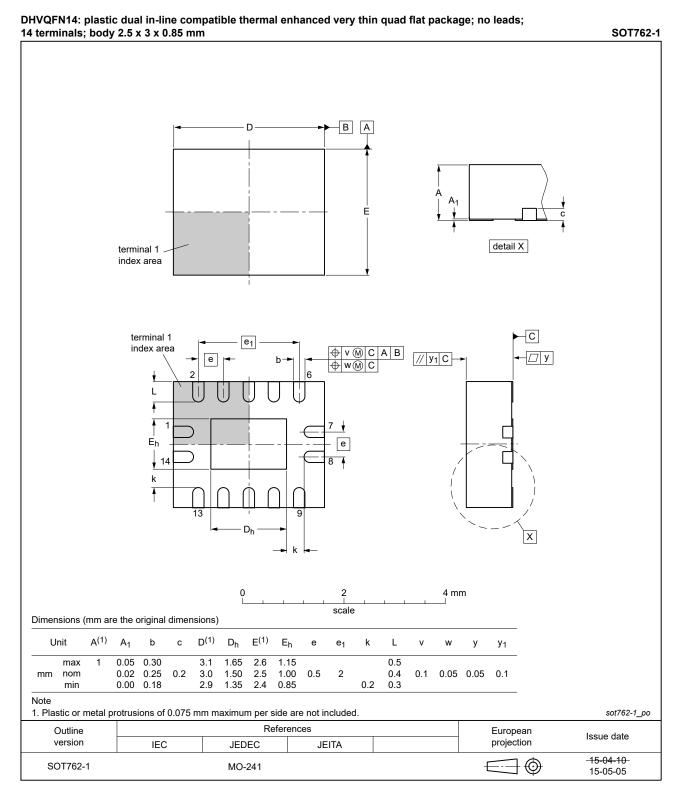


Fig. 10. Package outline SOT762-1 (DHVQFN14)
