1. General description

The 74LVC125A is a quad buffer/line driver with 3-state outputs controlled by the output enable inputs ($n\overline{OE}$). A HIGH on $n\overline{OE}$ causes the outputs to assume a high impedance OFF-state. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device is fully specified for partial power down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.








Fig. 8. Test circuit for measuring switching times




Fig. 9. Package outline SOT108-1 (SO14)




Fig. 10. Package outline SOT402-1 (TSSOP14)




Fig. 11. Package outline SOT762-1 (DHVQFN14)
