1. General description

The 74LVC86A is a quad 2-input EXCLUSIVE-OR gate. Inputs can be driven from either 3.3~V or 5~V devices. This feature allows the use of these devices as translators in mixed 3.3~V and 5~V environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.












Fig. 8. Package outline SOT762-1 (DHVQFN14)
