# 1. General description

XC7SET86 is a high-speed Si-gate CMOS device. It provides a 2-input EXCLUSIVE-OR function.






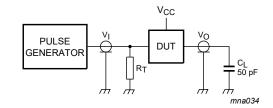


Fig. 5. The input (A and B) to output (Y) propagation delays

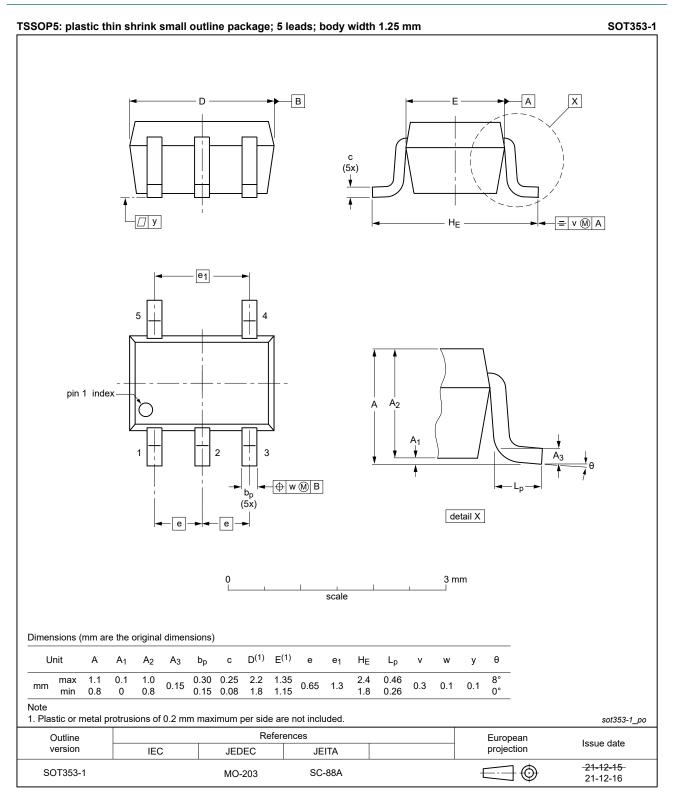




Fig. 8. Package outline SOT753 (SC-74A)
