## 1. General description

The HEF4071B-Q100 is a quad 2-input OR gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of  $V_{DD}$ .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.

- Automotive product qualification in accordance with AEC-Q100 (Grade 1)
  - Specified from -40 °C to +85 °C and from -40 °C to +125 °C
- Fully static operation
- 5 V, 10 V, and 15 V parametric ratings
- CMOS low power dissipation

- Standardized symmetrical output characteristics
- Inputs and outputs are protected against electrostatic effects
- Complies with JEDEC standard JESD 13-B
- ESD protection:
  - HBM JESD22-A114F exceeds 2000 V

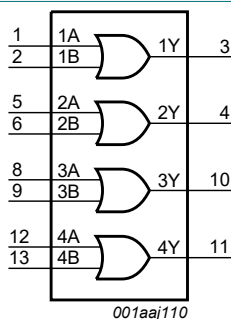


Fig. 1. Functional diagram

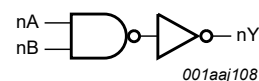
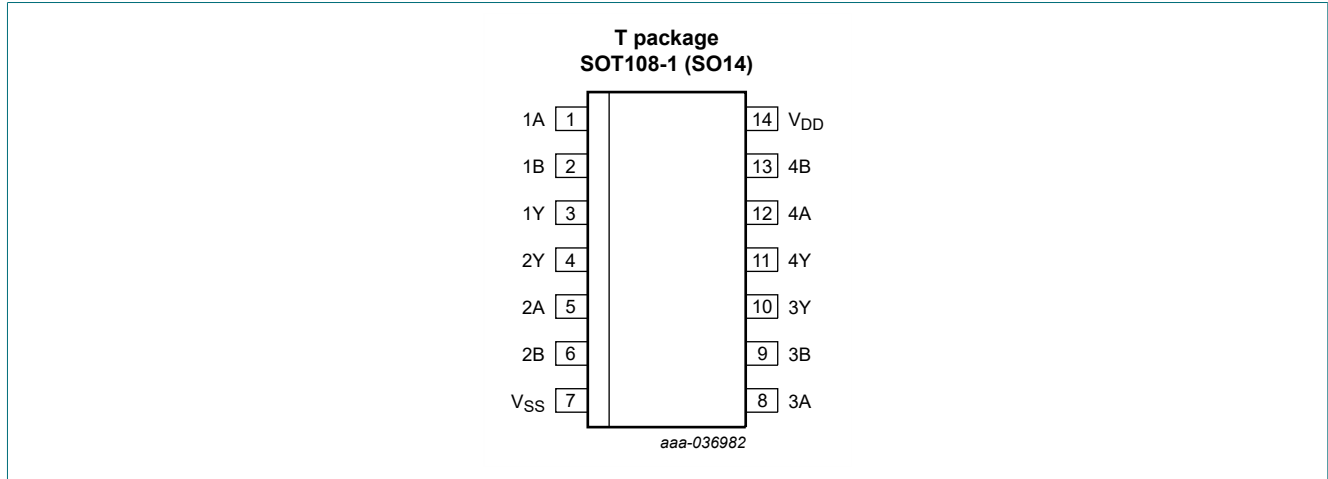


Fig. 2. Logic diagram (one gate)

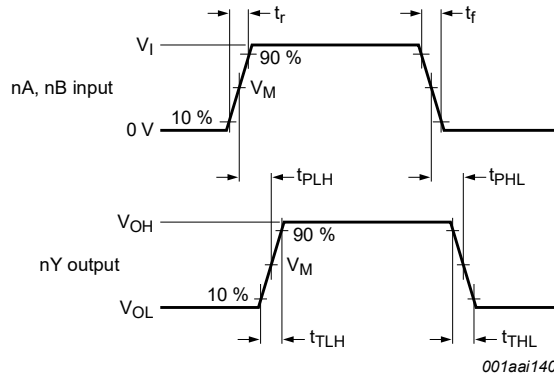

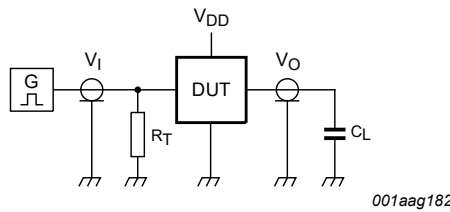

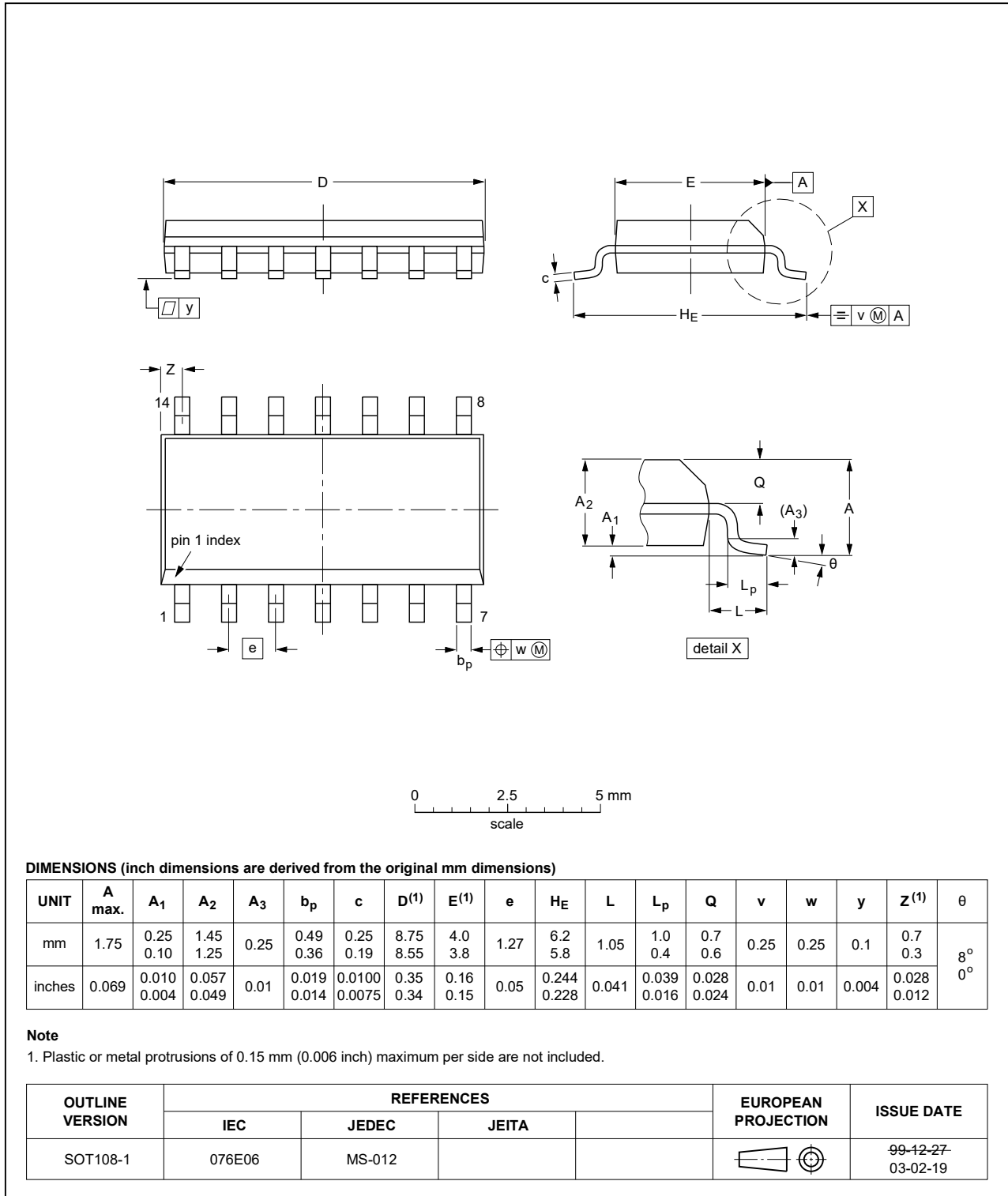


Fig. 5. Package outline SOT108-1 (SO14)
