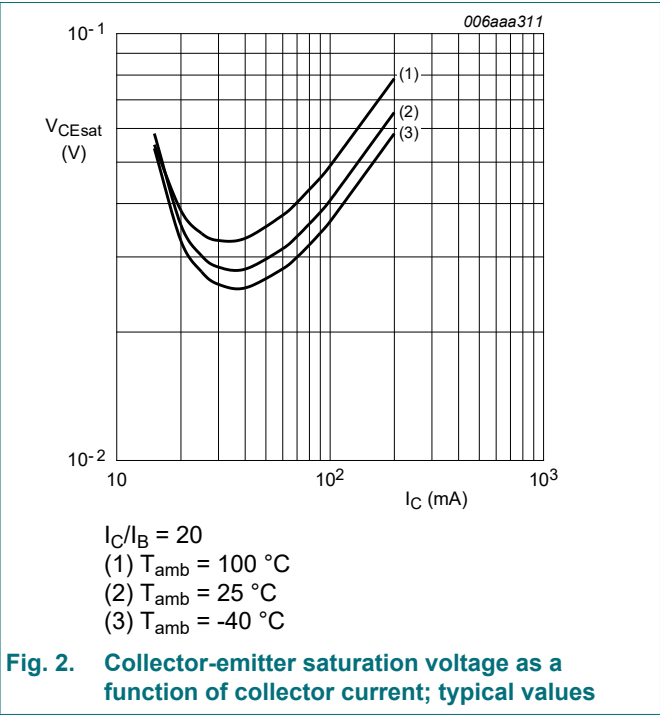
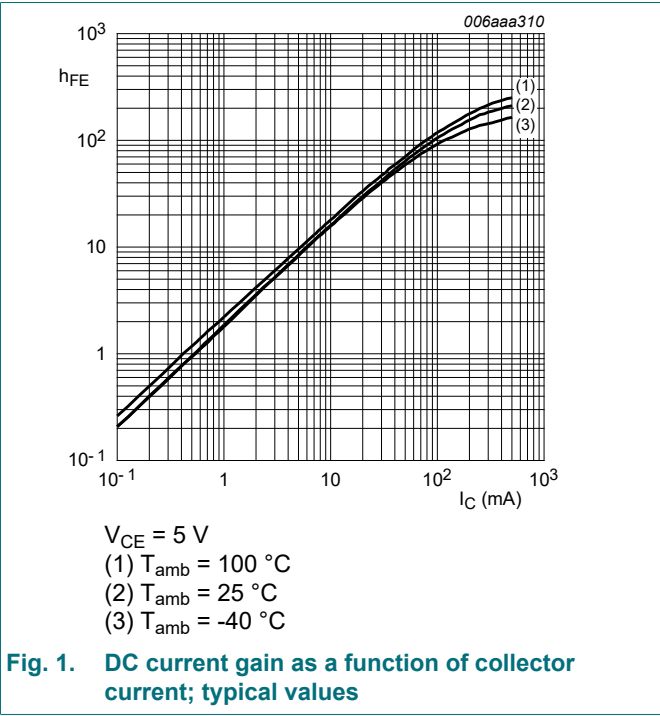

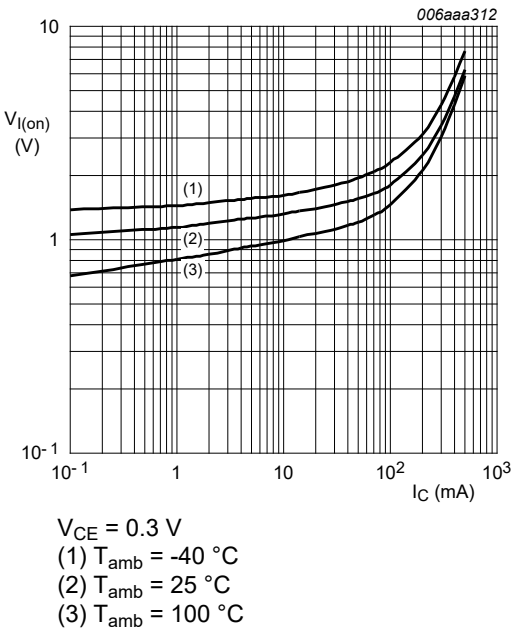


Fig. 3. On-state input voltage as a function of collector current; typical values

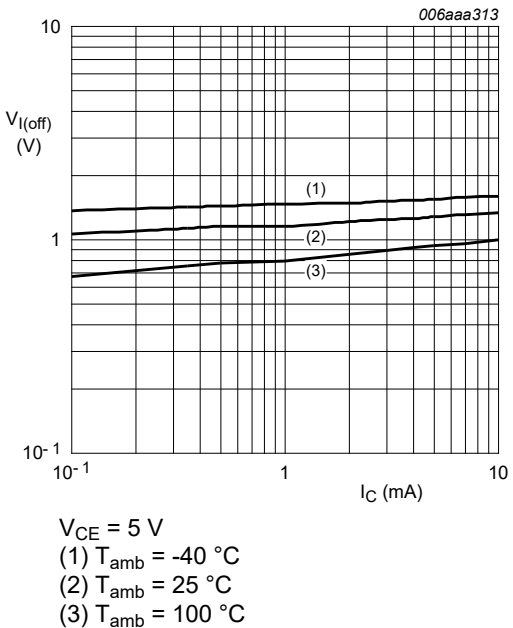


Fig. 4. Off-state input voltage as a function of collector current; typical values

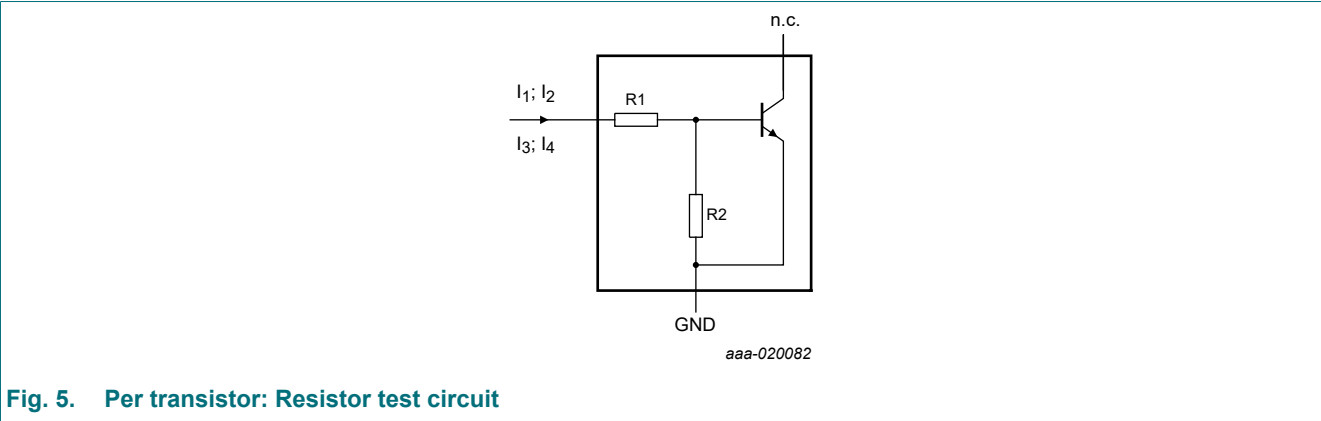
Resistor calculation

$$\frac{R_2}{R_1} = \frac{V(I_4) - V(I_3)}{R_1 \cdot (I_4 - I_3)} - 1$$

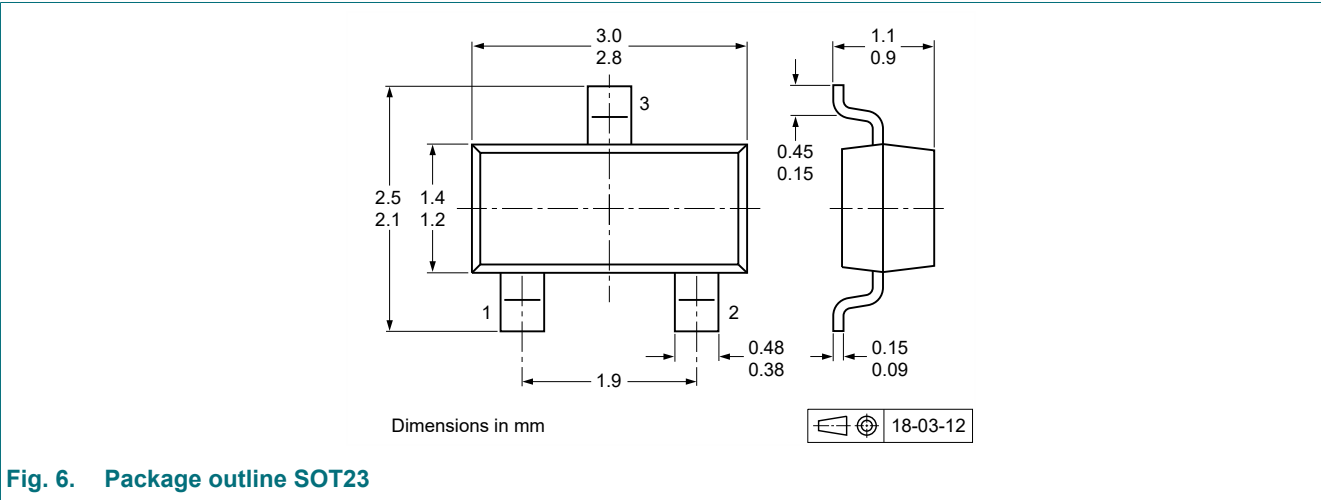

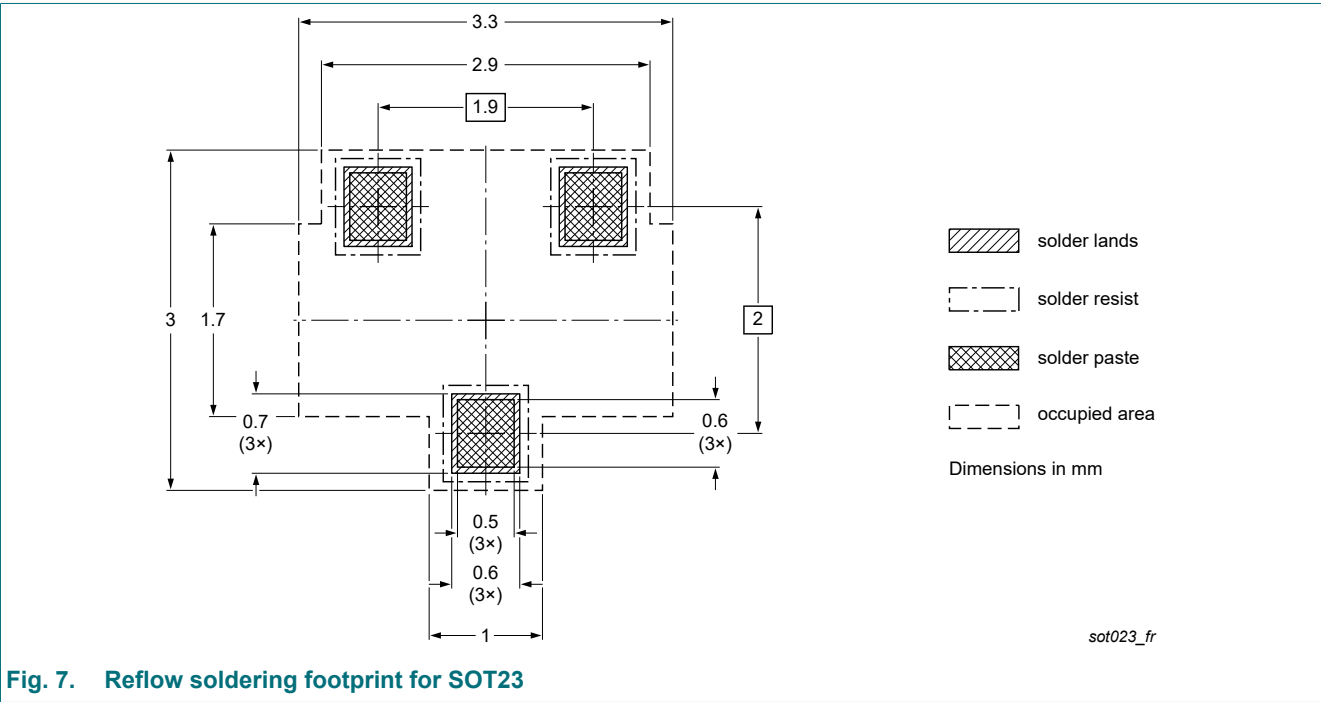

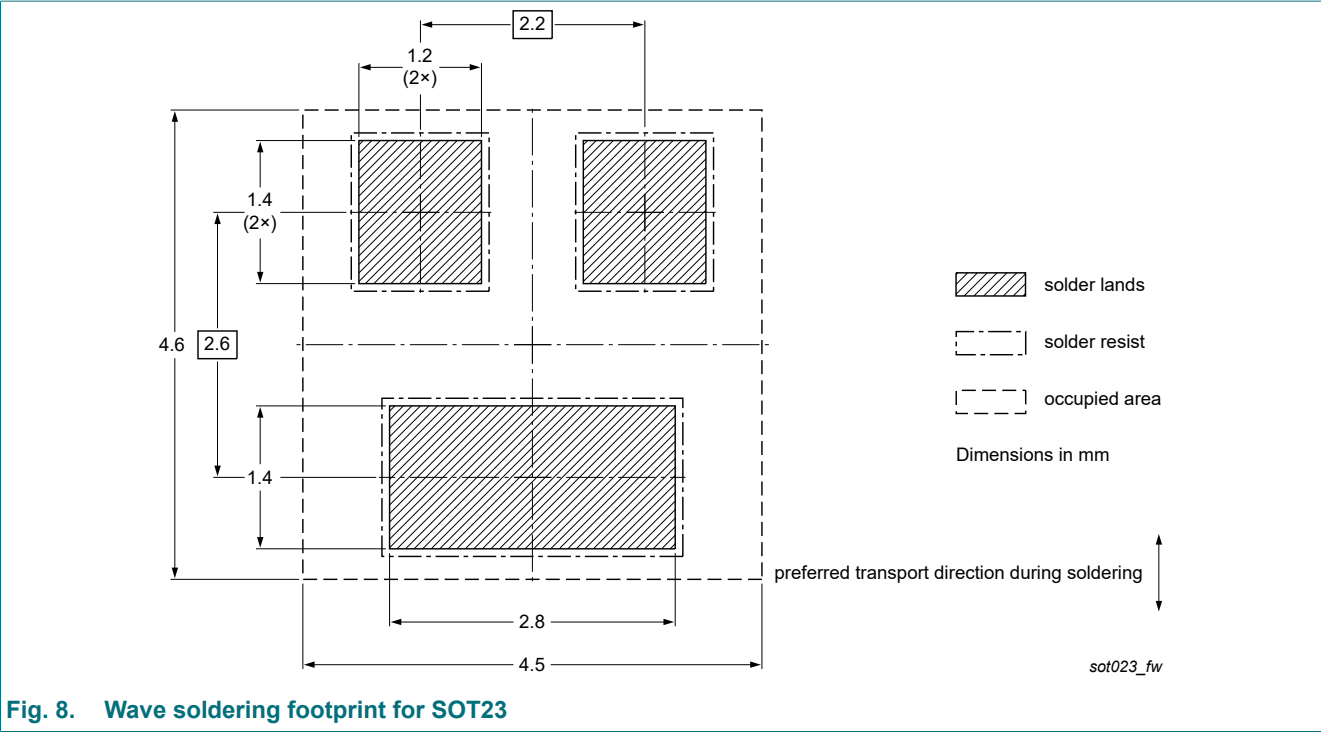


Fig. 8. Wave soldering footprint for SOT23
