


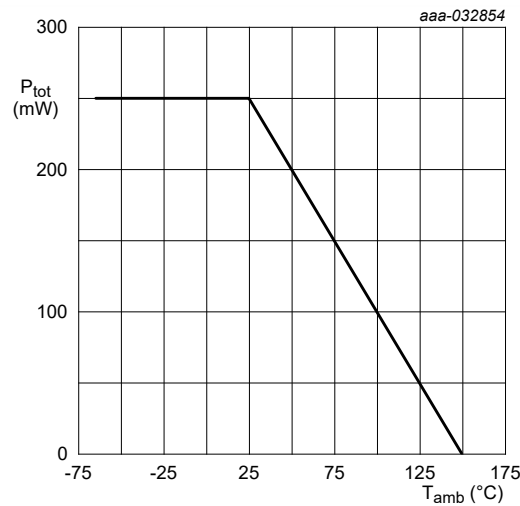


Fig. 1. Power derating curve

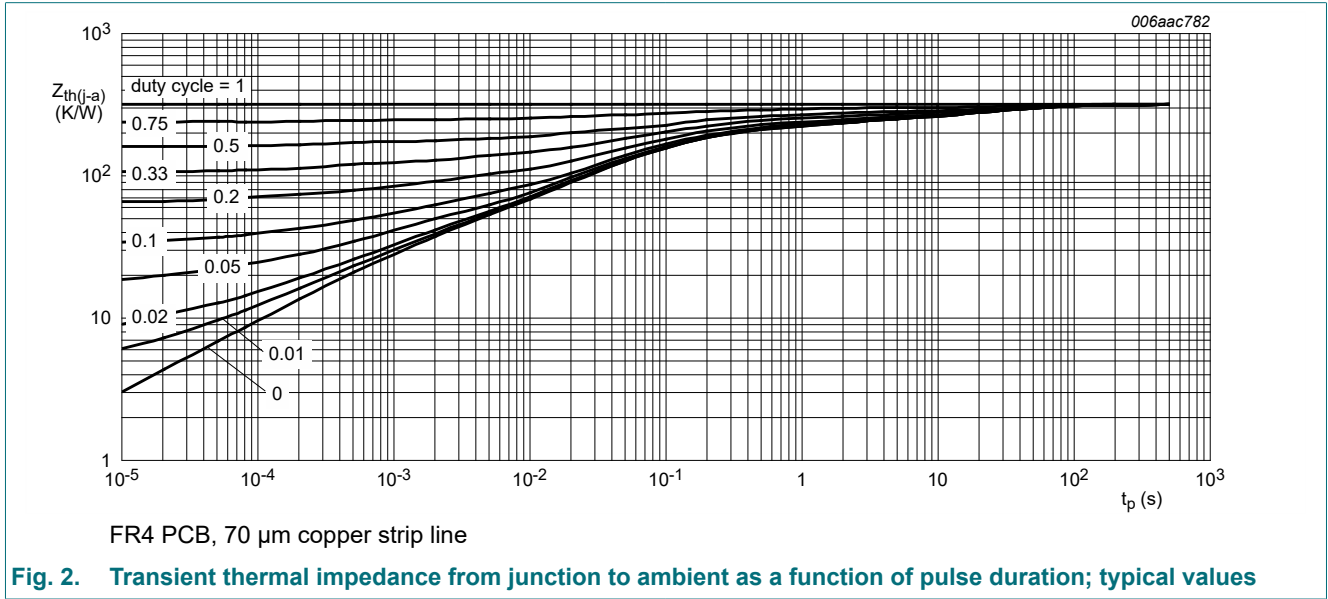


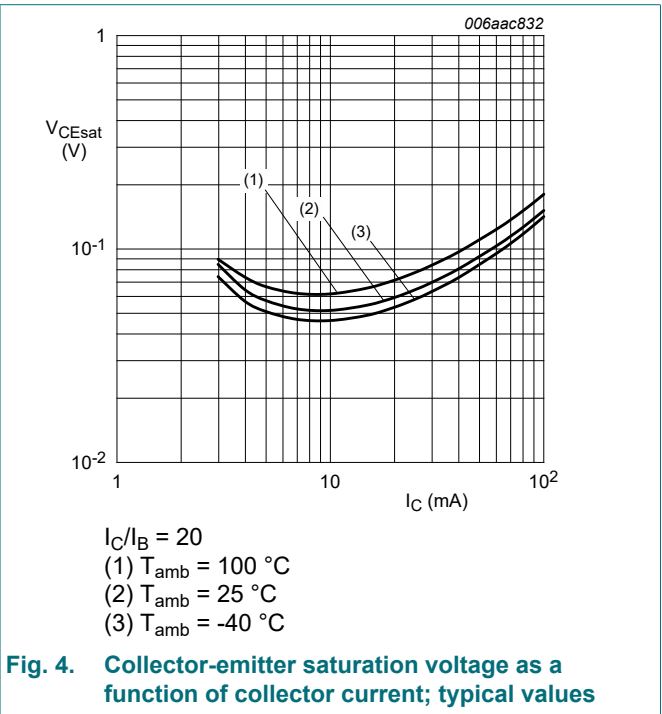
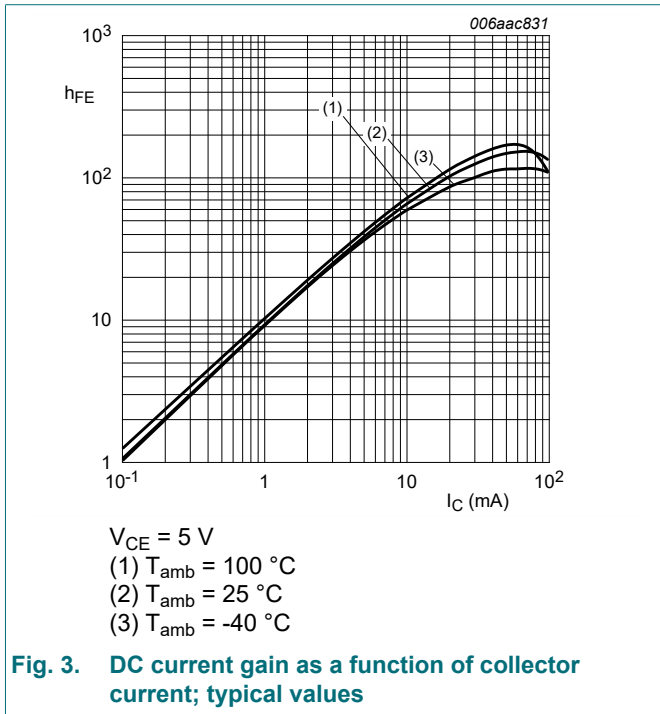
Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

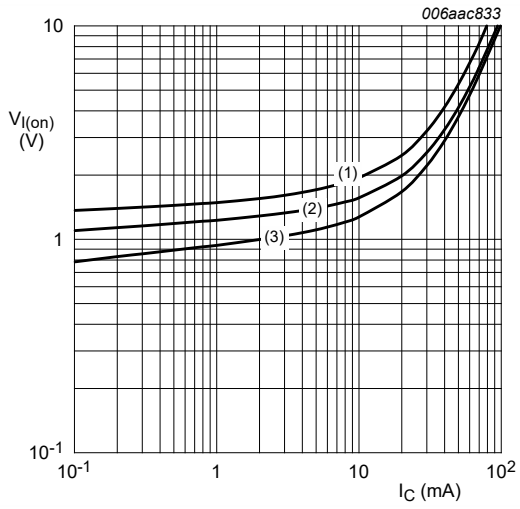

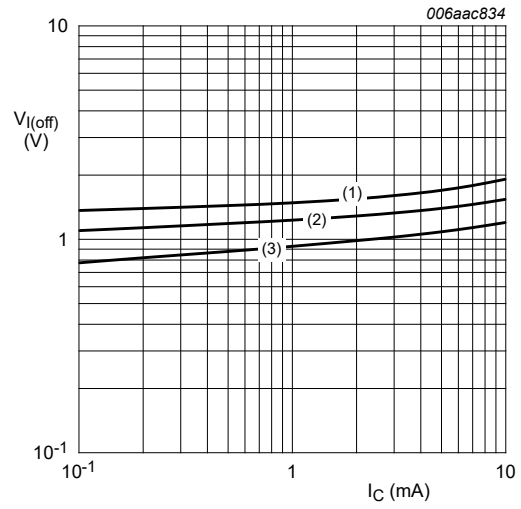

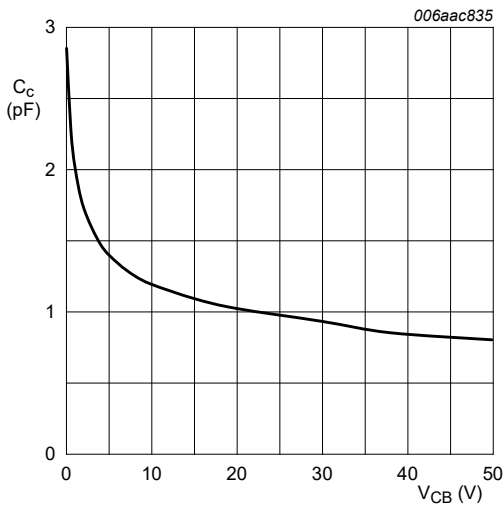

Fig. 5. On-state input voltage as a function of collector current; typical values



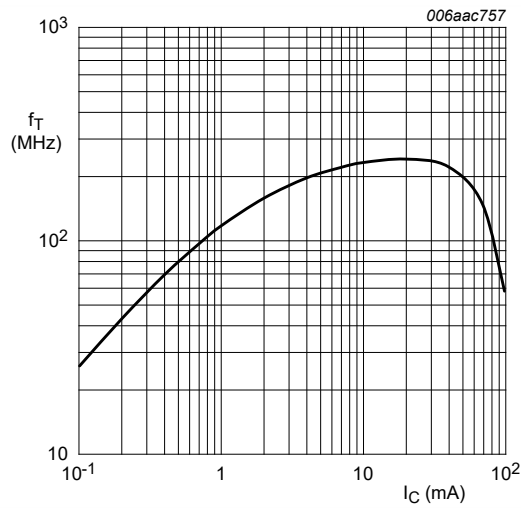

$$\frac{R_2}{R_1} = \frac{V(I_4) - V(I_3)}{R_1 \cdot (I_4 - I_3)} - 1$$

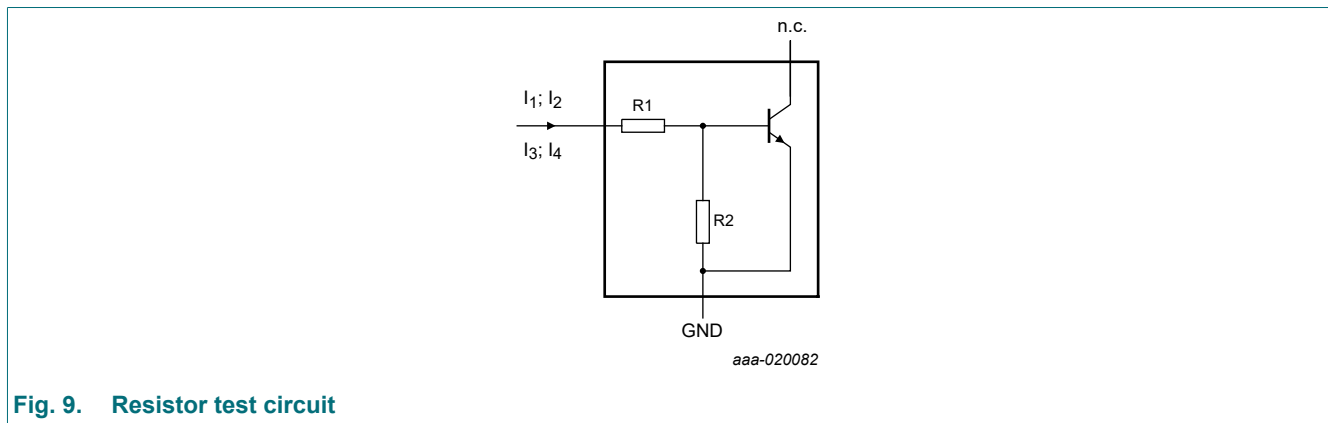


Fig. 9. Resistor test circuit

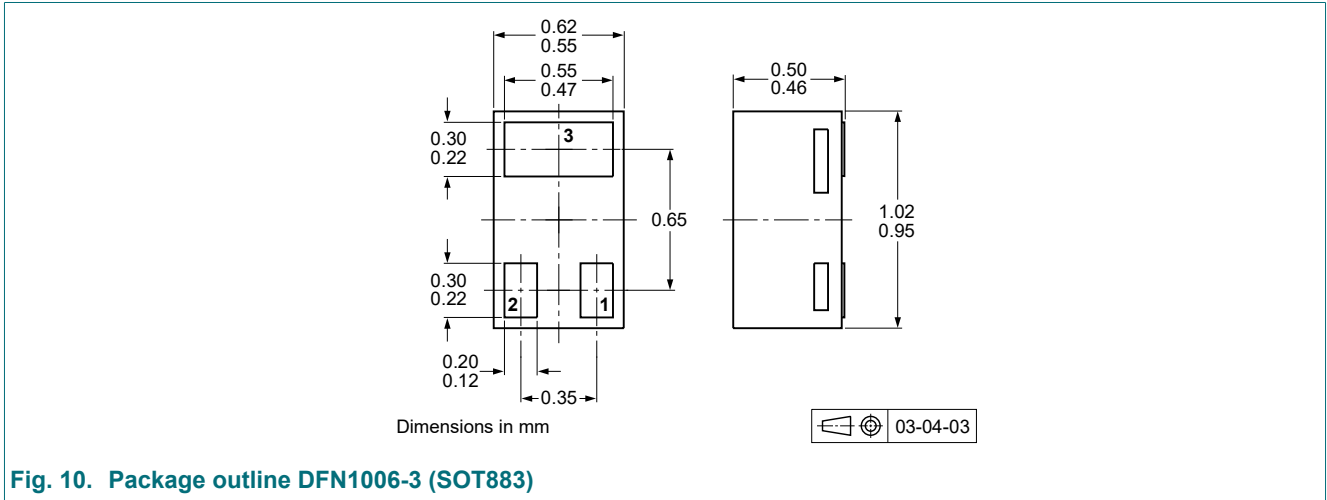


Fig. 10. Package outline DFN1006-3 (SOT883)

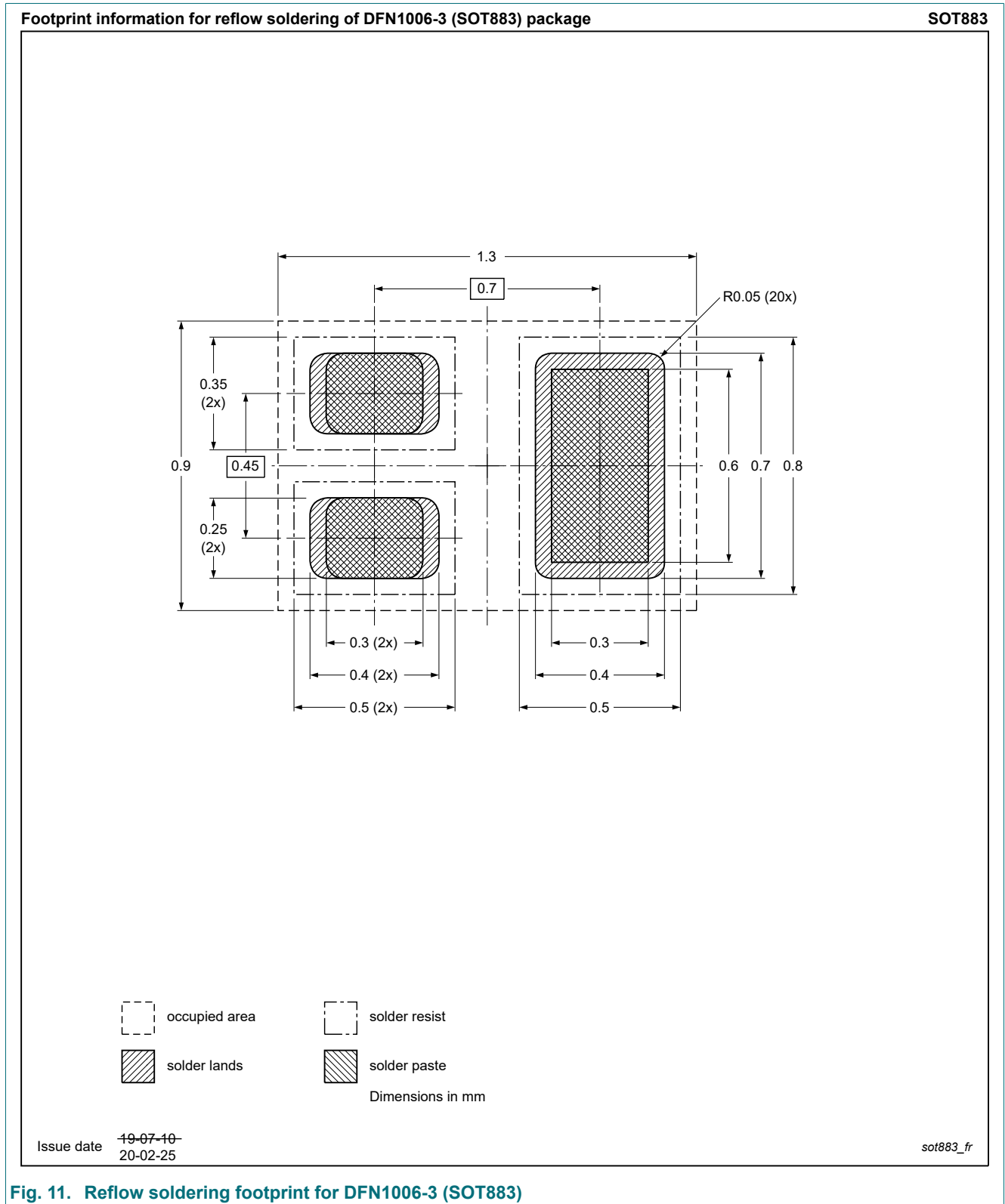


Fig. 11. Reflow soldering footprint for DFN1006-3 (SOT883)
