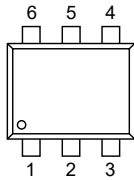
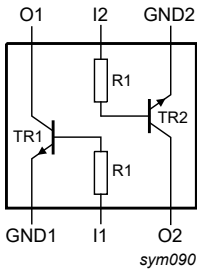

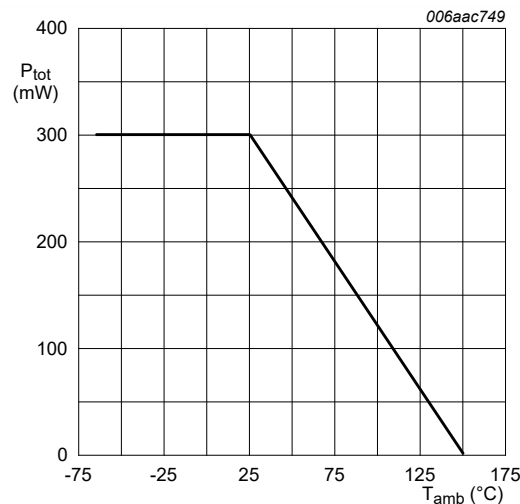

**Fig. 1. Per device: Power derating curve**

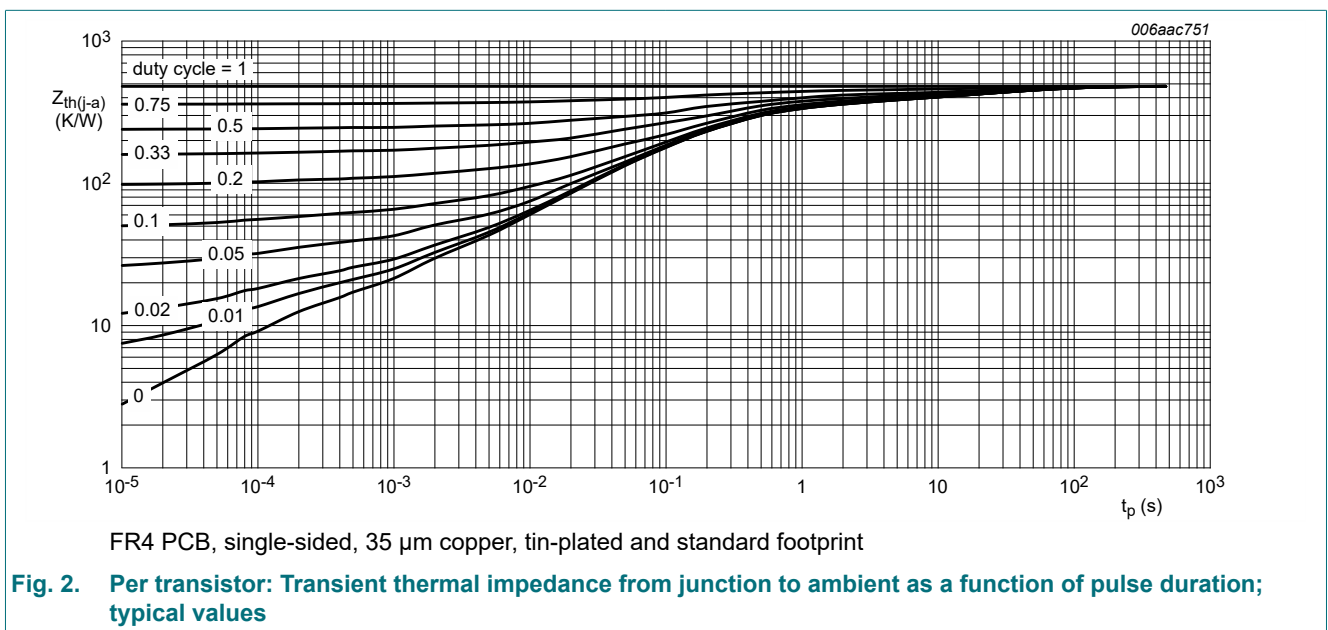

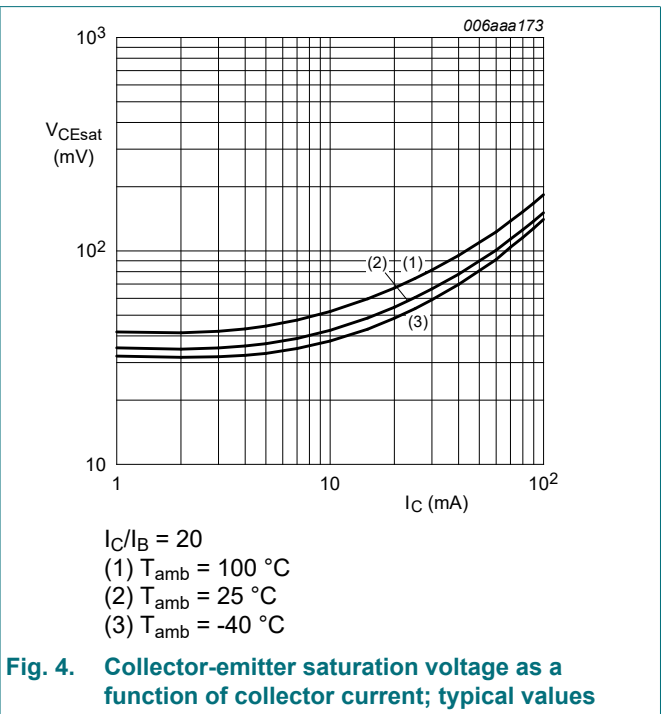
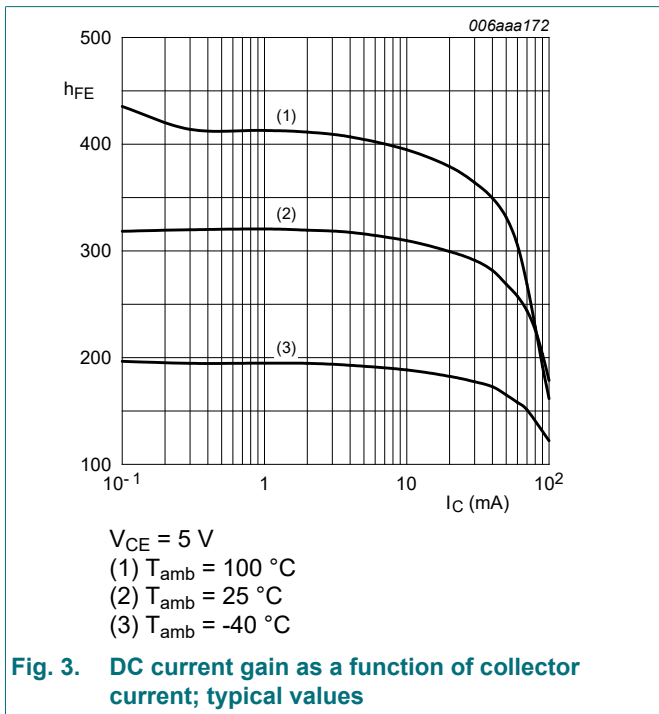

$$R_1 = \frac{V(I_2) - V(I_1)}{I_2 - I_1}$$

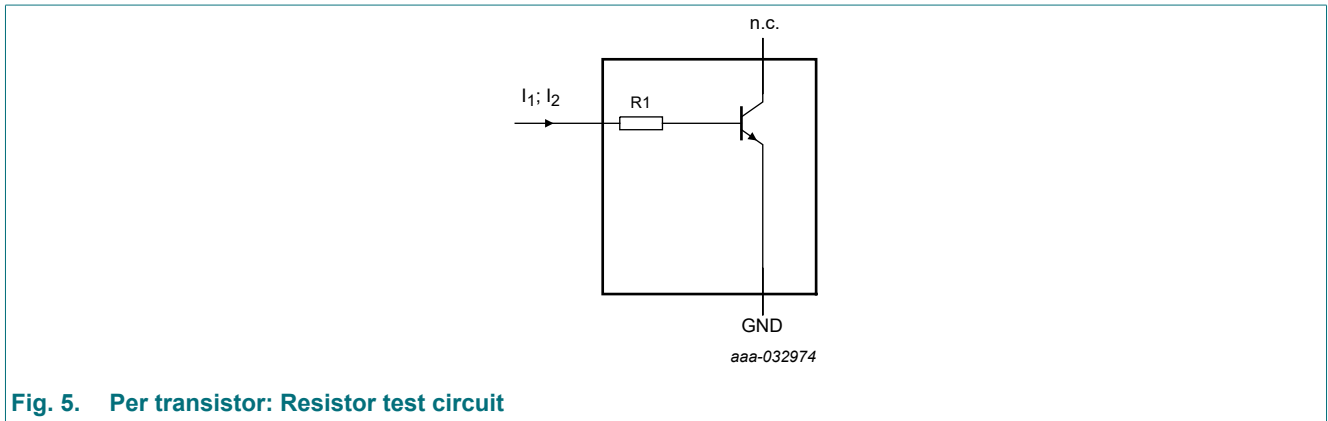


Fig. 5. Per transistor: Resistor test circuit

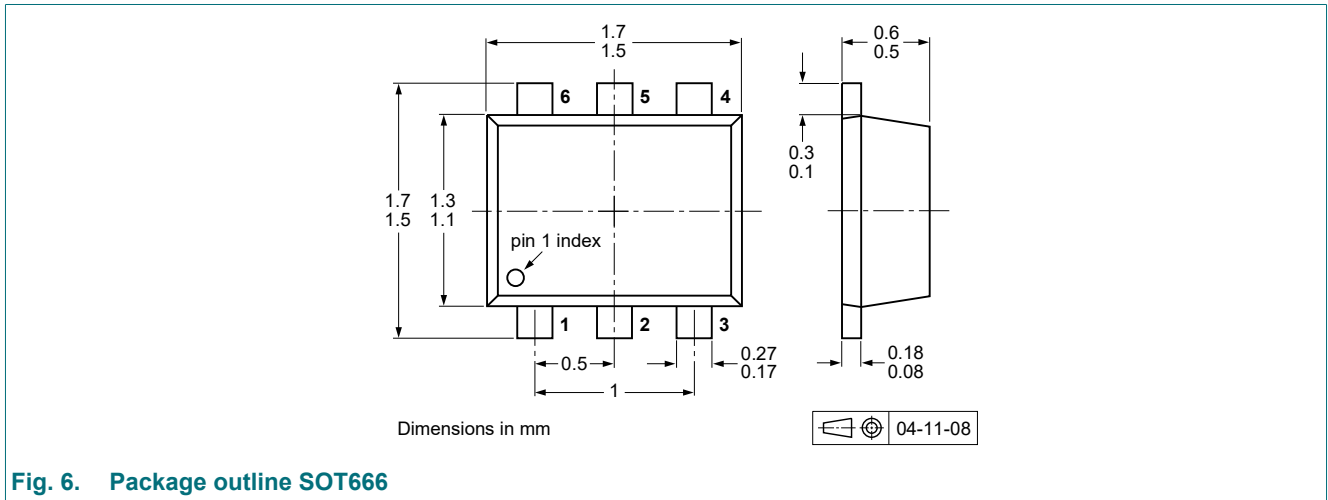


Fig. 6. Package outline SOT666

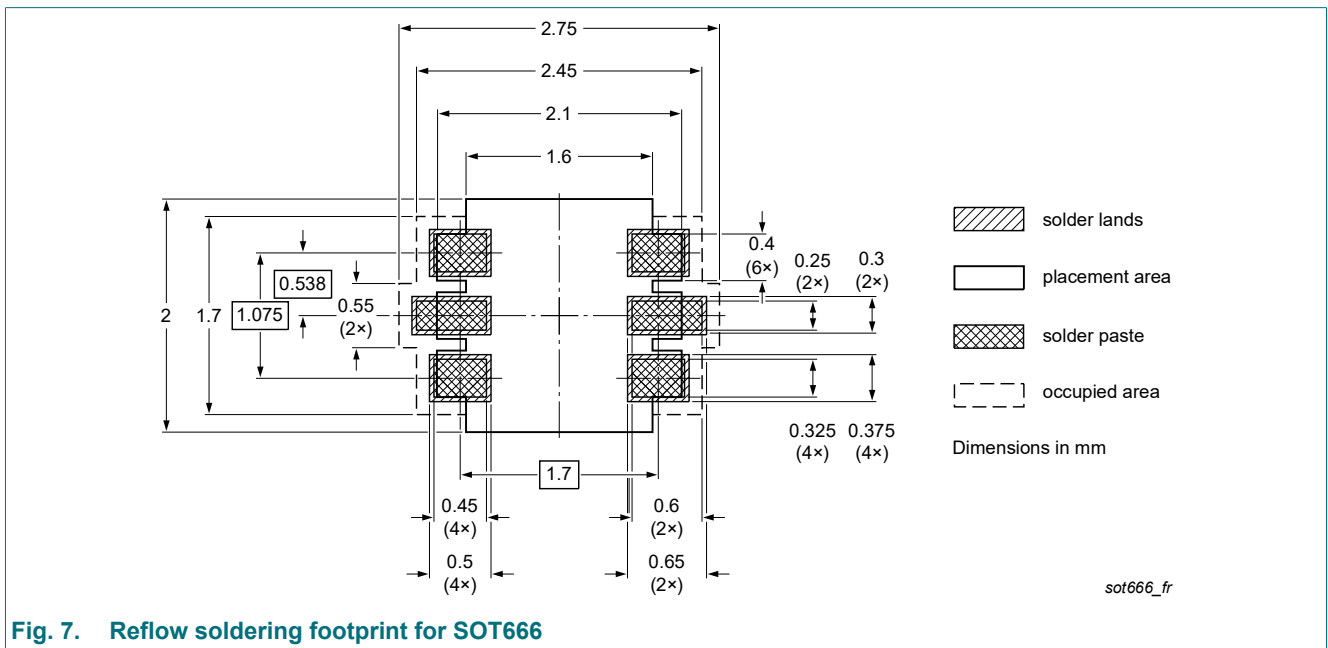


Fig. 7. Reflow soldering footprint for SOT666
