


Fig. 1. Normalized total power dissipation as a function of mounting base temperature




Fig. 2. Avalanche rating; avalanche current as a function of avalanche time






Fig. 3. Transient thermal impedance from junction to mounting base as a function of pulse duration

70 µm thick copper on FR4 board


Fig. 5. PCB layout with minimum footprint for thermal resistance from junction to ambient




