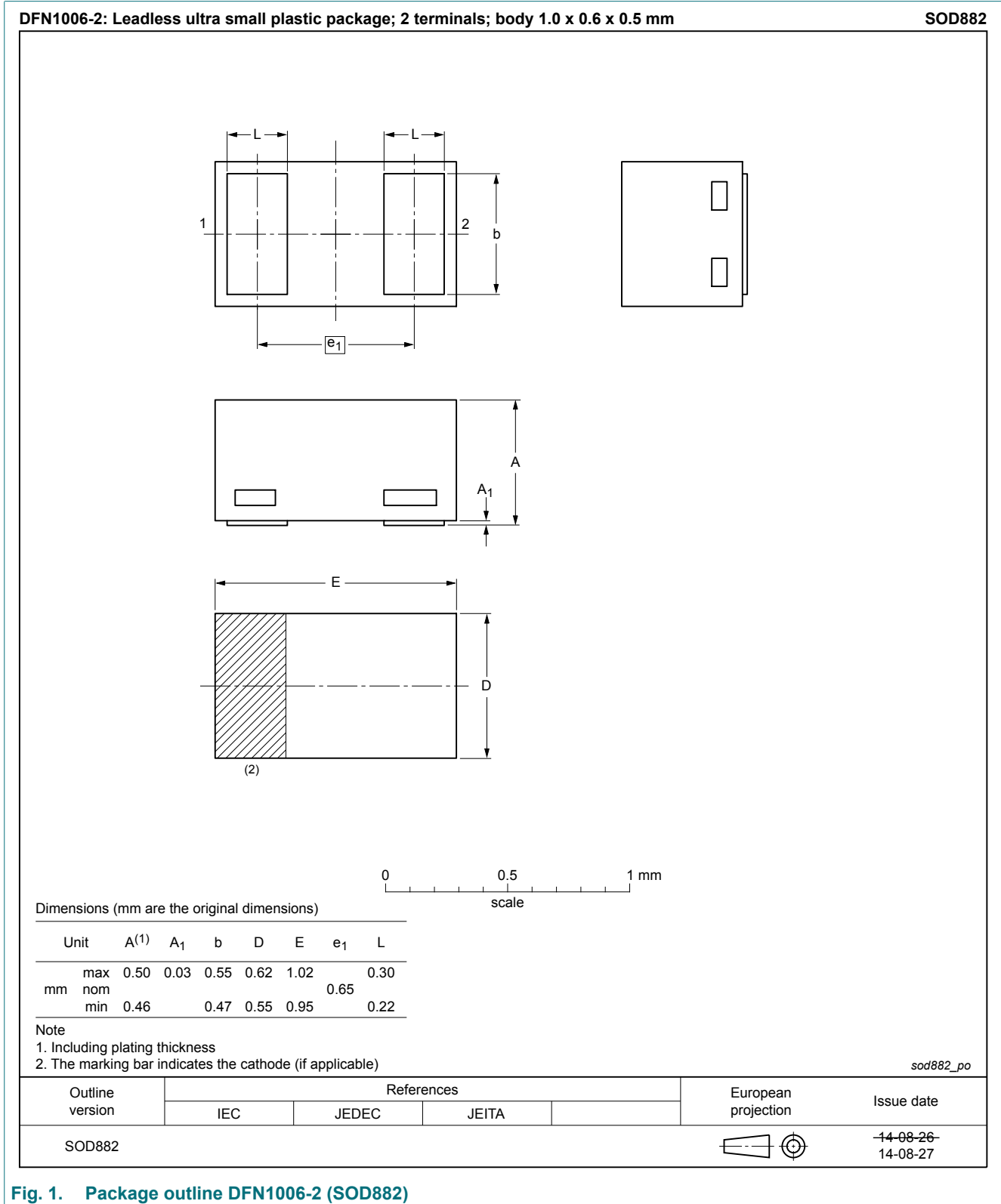


Fig. 1. Package outline DFN1006-2 (SOD882)

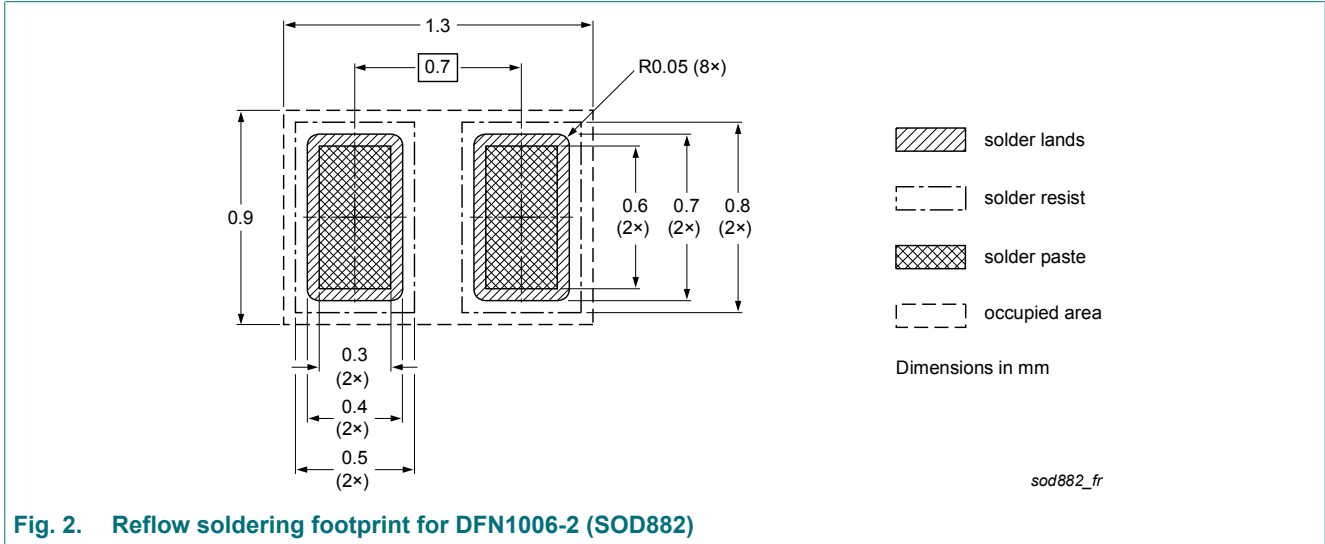


Fig. 2. Reflow soldering footprint for DFN1006-2 (SOD882)
