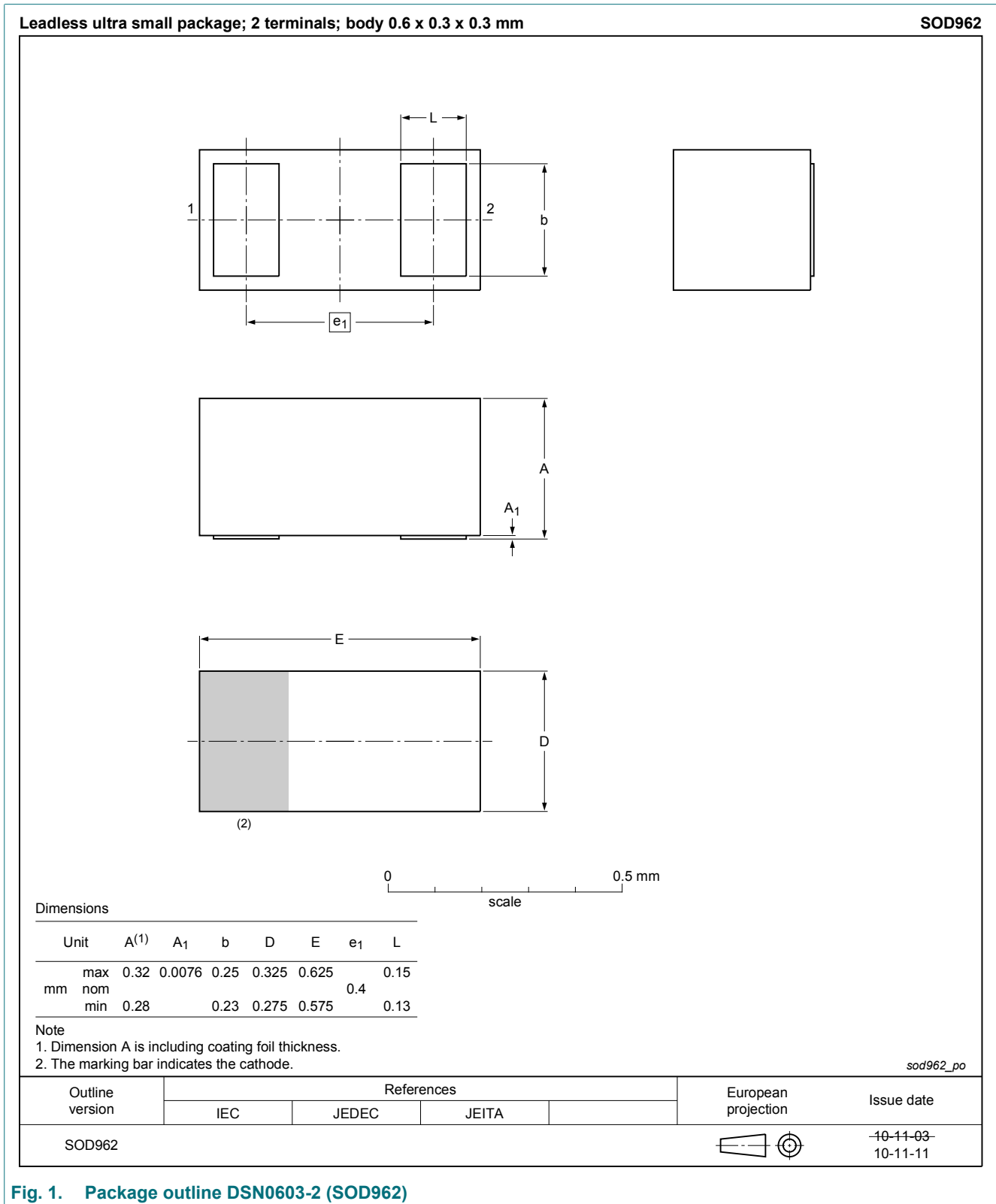


Fig. 1. Package outline DSN0603-2 (SOD962)

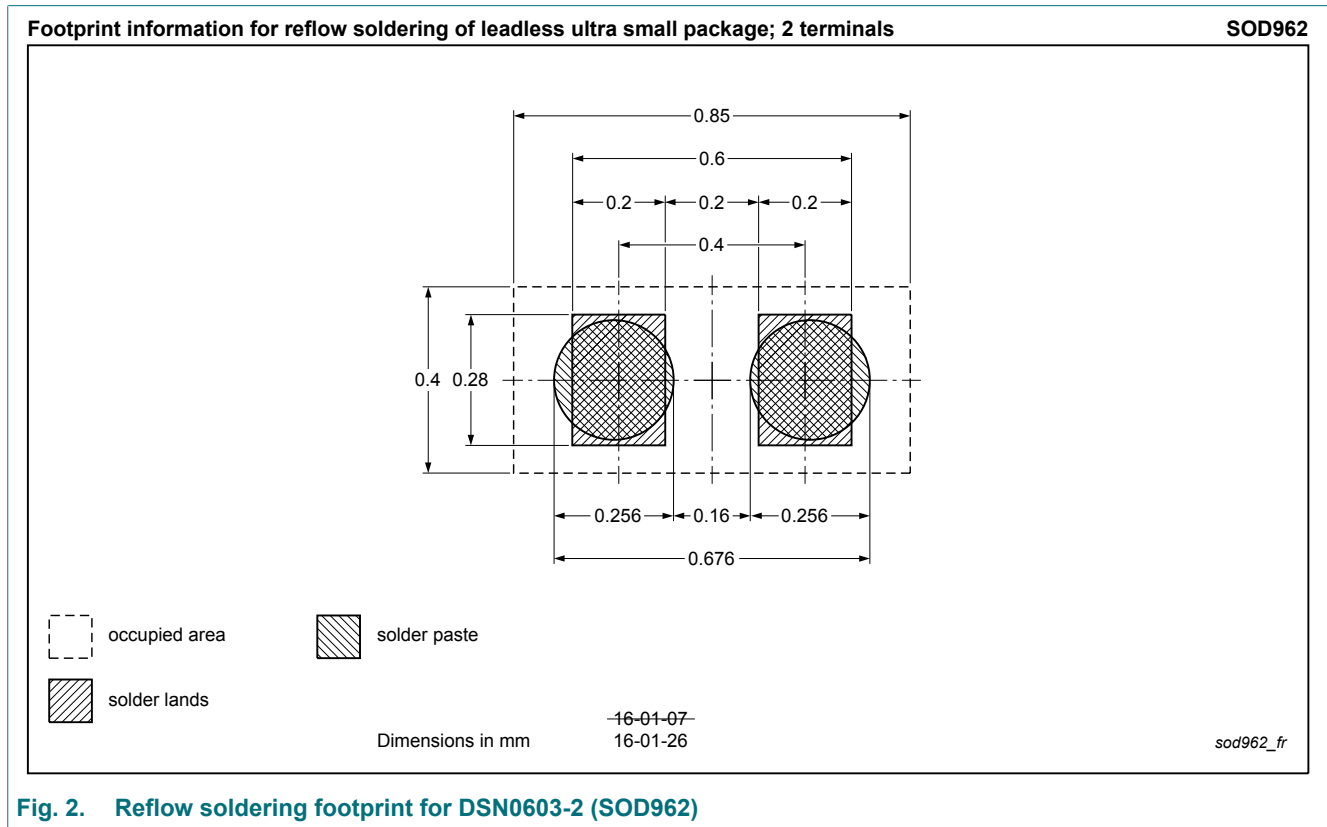


Fig. 2. Reflow soldering footprint for DSN0603-2 (SOD962)
