




Figure 1 : Reverse Current vs. Junction Temperature




Figure 2: Forward Current vs. Forward Voltage





Figure 3: Differential Forward Resistance vs. Forward Current

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

TEMIC can certify that our semiconductors are not manufactured with and do not contain ozone depleting substances.
