




Figure 1 : Epoxy glass hard tissue, board thickness 1.5 mm, $$R_{thJA}\!\leq\!70~\text{K/W}$}$




Figure 3 : Average Forward Current vs. Ambient Temperature




Figure 2 : Thermal Resistance vs. Lead Length




Figure 4 : Average Forward Current vs. Ambient Temperature

Figure 5 : Junction Temperature vs. Reverse/Repetitive Peak Reverse Voltage




Figure 7 : Forward Current vs. Forward Voltage




Figure 6 : Reverse Current vs. Junction Temperature





Figure 8 : Diode Capacitance vs. Reverse Voltage
