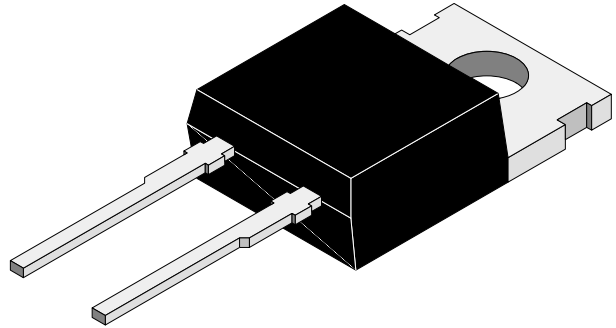

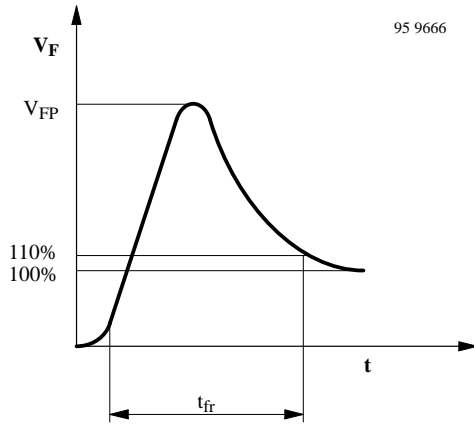


Figure 1 : Turn on transient peak voltage

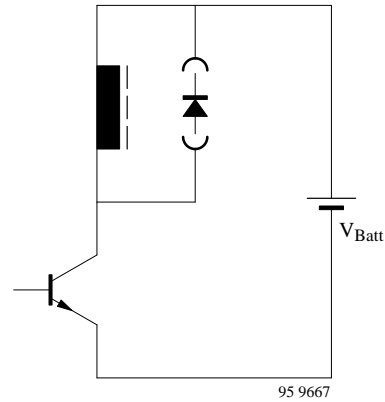


Figure 2 : Test circuit

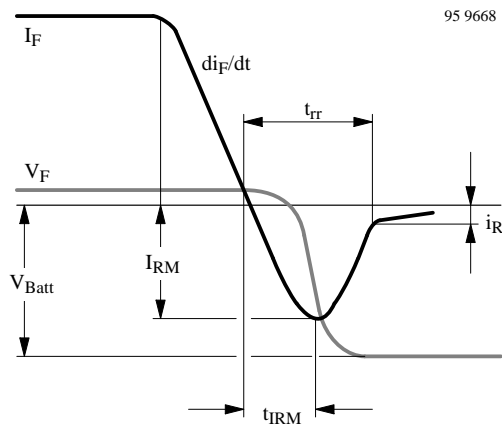


Figure 3 : Turn off switching characteristic

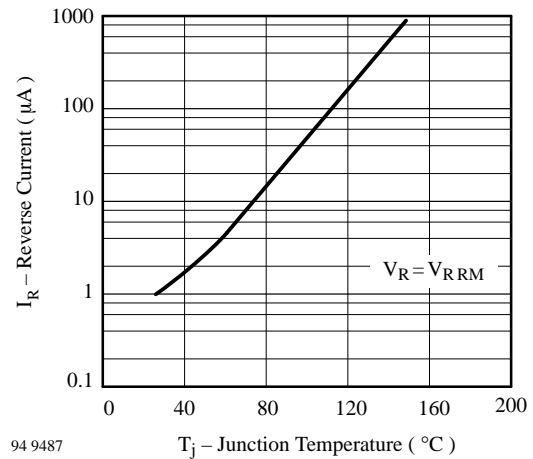


Figure 4 : Reverse Current vs. Junction Temperature

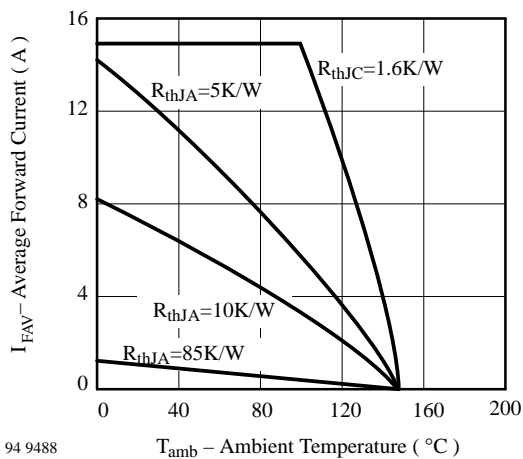


Figure 5 : Average Forward Current vs. Ambient Temperature

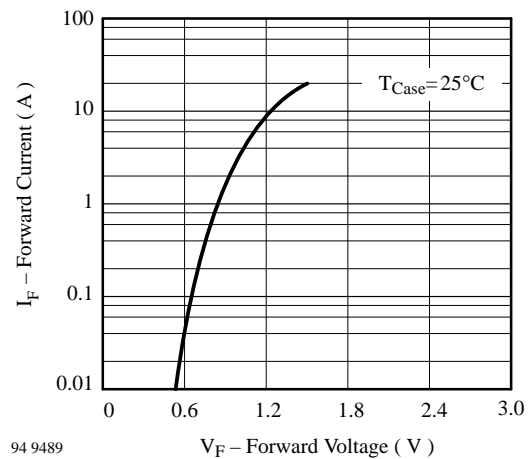
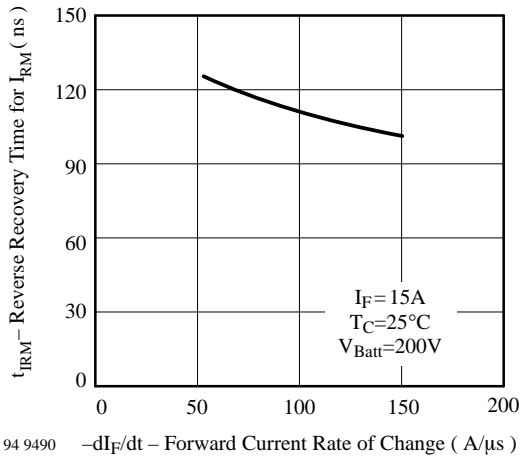
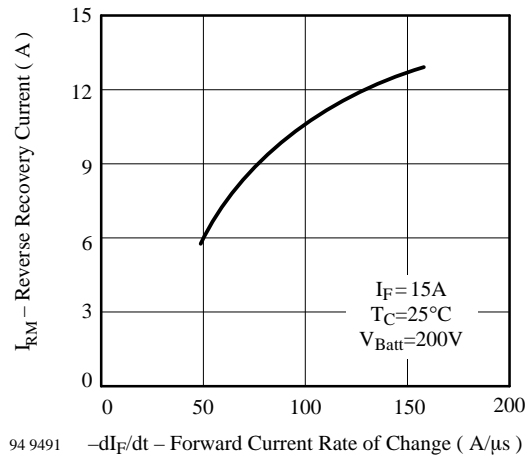


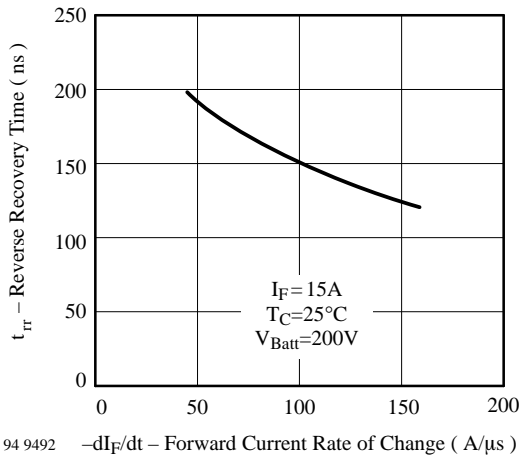
Figure 6 : Forward Current vs. Forward Voltage



**Figure 7 : Reverse Recovery Time for IRM vs. Forward Current Rate of Change**

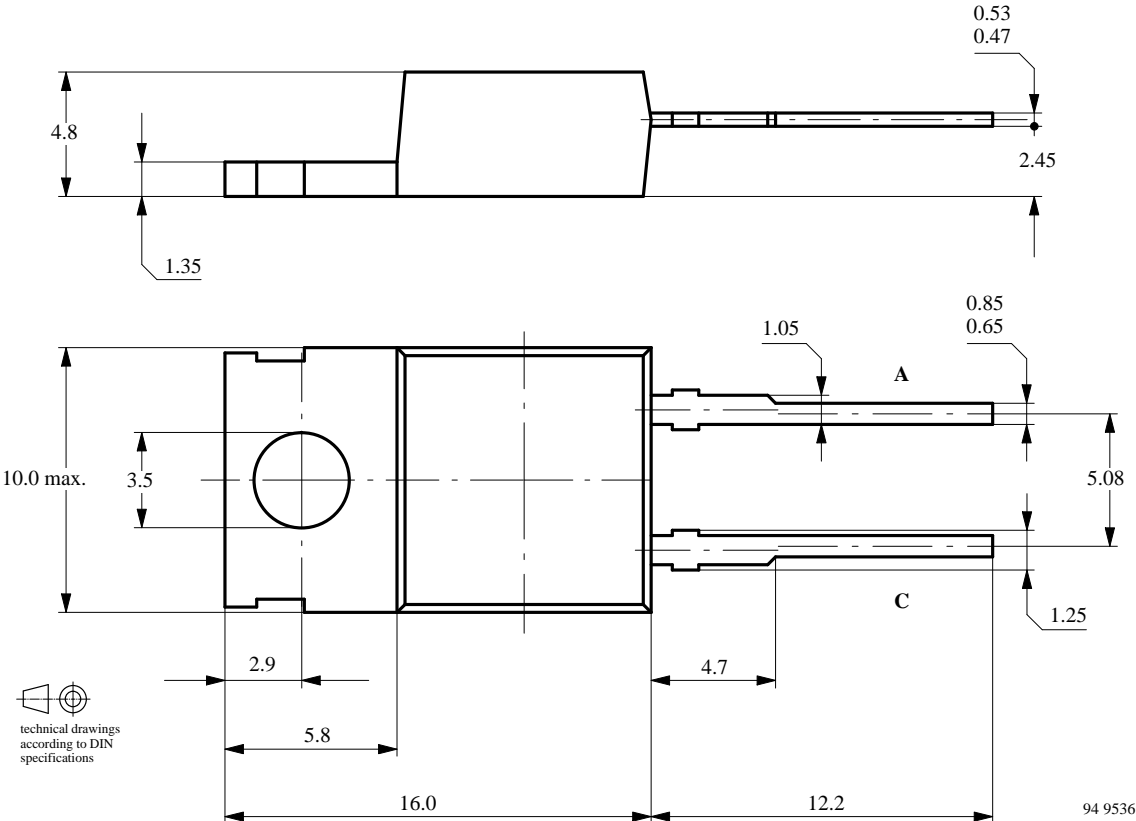


**Figure 8 : Reverse Recovery Current vs. Forward Current Rate of Change**
