
Transmissive Optical Sensor with Phototransistor Output

Description

This device has a compact construction where the emitting light sources and the detectors are located face to face on the same optical axis. The operating wavelength is 950 nm. The detector consists of phototransistor.

- Position sensor for shaft encoder
- Detection of opaque material like paper, IBM cards, magnetic tapes tc.
- Limit switch for mechanical motions in VCR
- Read/write head position in Data storage equipment



Ozone Depleting Substances Policy Statement

- 1. Meet all present and future national and international statutory requirements.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

TEMIC can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
