



Residual Carrier Power--Pc







Operation frequency: 14.5MHz Peak Envelope Power-- P_{pk}





Residual Carrier Power--Pc





- (3) On any frequency removed from the assigned frequency by more than 250 percent of the authorized bandwidth: At least 43 + 10 log P dB.


Operation Frequency--- 29.9MHz





Conducted Spurious emissions Operation frequency-2MHz







Conducted emission_14.5MHz








Radiated Emissions Setup:




