"If your product should require fatory service please call Cobra first before sending your unit in. This will ensure the fastest turn-around time on your repair

You may be asked to send your unit to the Cobra factory. It will be necessary to furnish the following in order to have the product serviced and returned.

- 1. For Warranty Repair include some form of proof-of-purchase, such as a mechanical reproduction or carbon or a sales receipt. If you send the original receipt it cannot be returned.
- 2. Send the entire product.

- 3. Enclose a description of what is happening with the unit. Include a typed or clearly print name and address of where the unit is to be returned.
- 4. Pack unit securely to prevent damage in transit. If possible, use the original packing material.
- 5. Ship prepaid and insured by way of a traceable carrier such as United Parcel Service (UPS) or First Class Mail: to avoid loss in transit to: Cobra Factory Service, Cobra Electronics Corporation, 6500 W. Cortland St., Chicago, IL 60707.
- 6. If the unit is in warranty, upon receipt of your unit it will either be repaired or exchanged depending on the model. Please allow approximately 3 to 4 weeks before contacting us for status. If the unit is out of warranty a letter will automatically be sent informing you of the repair charge or replacement charge. If you have any questions, please call 1.773.889.3087 for assistance

## The CB Story

The Citizens Band lies between the shortwave broadcast and 10-meter Amateur radio bands and was established by law in 1949. The Class D twoway communications service was opened in 1959.

#### FCC Regulations

FCC regulations permit only "transmissions" (one party to another) rather than "broadcasts" (to a wide audience). Advertising is not allowed on CB Channels because it is considered "broadcasting."

#### FCC Warnings

Replacement or substitution of transistors, regular diodes or other parts of a unique nature, with parts other than those recommended by Cobra, may cause a violation of the technical regulations of Part 95 of the FCC Rules, or violation of Type Acceptance requirements of Part 2 of the Rules.

Citizens Band (CB) Radio operators are not required to obtain an FCC license to operate their CB equipment or provide station identification.

Nevertheless, an operator of a CB radio station is still required to comply with the communications act and with the rules of CB Radio Operation.

Due to the characteristics of CB transmissions, it is neccesary to use an external car roof antenna (item #ATW 400) and a BNC adapter (item #CA 43) to receive optimal performance while in your vehicle. See Accessories section on page 19.

#### Power Saver-HI/LOW


#### Note

Battery life is increased up to 50% while in Battery Save LOW Mode. This reduces power output to 1 watt.



The HH 34 can be connected to your cigarette lighter with the provided car cord. This power connection does NOT charge the batteries.

#### Power Saver-HI/LOW

Reduces the power to 1 watt. This does not decrease the unit's ability to receive but does reduce the transmitting range.


You must pay any initial shipping charges required to ship the product for warranty service, but the return charges will be at Cobra's expense, if the product is repaired or replaced under warranty.
