New DAAs must be registered after July 1

As many of you already know, all new DAAs must be registered to be directly connected to the phone network after July 1, 1979.

Western Electric does not plan to register their DAAs, and will cease manufacture of them prior to July 1st. Consequently, these DAAs will not be available from the Bell System after July 1, 1979.

The registration program permits DAAs actually connected to the phone network prior to July 1st to remain connected and to be moved and reconnected. These grandfathered DAAs will continue to be offered by the Bell System, but only on an equipment available basis.

After July 1st, customers must provide an FCC registered DAA for interconnect of Datapoint communications facilities and the phone network. Generally, registered DAAs can be obtained from the vendors supplying the modems (Bell is an exception to this).

If your customer can't find registered DAAs through a vendor, the Datapoint Telecommunications Department in San Antonio may be contacted for assistance. ■


