This document describes the installation procedure for Keysight M8085A MIPI C-PHY CTS Plug-in.

1.1 Introduction

The MIPI C-PHY CTS Plugin user interface allows the user to set the DUT and test configuration.

1.2 Prerequisites

The following are the pre-requisites for installing MIPI C-PHY CTS plug-in:

- The MIPI C-PHY CTS plug-in has to be installed separately along with the M8070A system software. Please make sure that the system should already have M8070A software (version 2.5.2.4 or above) install on it.
- MIPI C-PHY CTS installer which is either available on CD or can be downloaded from Keysight webpage: www.keysight.com
- MIPI C-PHY CTS plug-in license: ("M8085A-CTA | M8085A-CNA | M8085A-CDA")



1.3 License Requirements

The MIPI C-PHY CTS plug-in is a licensed feature. To enable it, the M8085A-CTA | M8085A-CNA | M8085A-CDA licenses are required.

1.4 Installation Steps

Follow the given steps to install MIPI C-PHY CTS plug-in on your system.

 Double-click the executable. This executable file will be available either on CD or Web.




Figure 1: C-PHY Setup Wizard

The following window will appear as shown in Figure 1.

2. Click on the **Next** button to continue to the next step. The license agreement of the C-PHY setup appears as shown in Figure 2.




Figure 3: C-PHY Setup Choose Components Window

 Read all the terms and conditions of the license agreement carefully and select "I accept the terms of the License Agreement" option. Then, click on Next to continue. After pressing the Next button, the following window appears as shown in Figure 3.




Figure 4: C-PHY Setup Choose Install Location Window

4. Click on the **Next** button to continue to the next step. The following window will appear as shown in Figure 4.

- 5. Click the **Browse...** button to select the destination folder where the software shall be installed.




Figure 5: C-PHY Setup Installation Status Window

- 6. Next, click the **Install** button to install the software. The following window will appear as shown in Figure 5.




Figure 6: N5990A Installation Final Window

7. Once the installation is completed, click the **Next** button to continue. The following window will appear as shown in Figure 6.

8. Click on the **Finish** button to complete the MIPI C-PHY CTS plug-in installation.

1.5 How to Access the MIPI C-PHY Plug-in Through M8070A System Software

Follow the steps to access an installed plug-in through M8070A system software:

- 1. Launch M8070A system software user interface.
- 2. In the M8070A user interface, go to **Menu Bar** and then click **Application menu**. It will list all installed plug-ins.
- 3. Select the MIPI C-PHY CTS plug-in.




Figure 7: C-PHY Plug-in User Interface

- 4. The MIPI C-PHY CTS plug-in user interface will appear as shown in Figure 7.
