Description of the Upgrade

Frequency offset mode allows the PNA source and receiver to be tuned to different frequencies. This is convenient, if not necessary, for testing frequency conversion devices, such as mixers and converters, where the input and output frequencies are different.

The PNA source, at one frequency, can be used as the input to the DUT, and the PNA receiver can be tuned to the output signal of the DUT at a different frequency.

This upgrade adds Option 080 which adds the frequency offset mode capability to your PNA.

Installation Procedure for the Upgrade

Installation Requirements

- The network analyzer must be in proper working condition prior to installing this option. Any necessary repairs must be made before proceeding with this installation.
- This installation does not require removal of the analyzer's protective outer covers.
- The analyzer must be powered up and operating to perform this installation. The Network Analyzer program must be running.
- This installation requires that a keyboard and a mouse be connected to the network analyzer.

Verify the Serial and Option Numbers

Refer to the License Key Certificate obtained:

- Verify that the analyzer's model and serial numbers match those on the certificate.
- Verify that the option number on the certificate matches the option number described in this installation note.

If the model number, serial number, or option number do not match the expected results, you will not be able to install the option. If this is the case, contact Agilent for assistance. Refer to "Getting Assistance from Agilent" on page 3.

Enable Option 080

- 1. On the analyzer's System menu, point to Service, and then click Option Enable.
- 2. In the Select Desired Option list, click 080 Frequency Offset.
- 3. Using the keyboard, enter the keyword in the box provided. The keyword is printed on the License Key Certificate. Enter this keyword *exactly* as it is printed on the certificate.
- 4. Click Enable.
- 5. Click Yes in answer to the displayed question in the Restart Analyzer? box.
- 6. When the installation is complete, click **Exit**.

Verify that Option 080 Is Enabled

Once the analyzer has restarted and the Network Analyzer program is again running:

- 1. On the analyzer's Help menu, click About Network Analyzer.
- 2. Verify that "080" is listed after "Options:" in the display. Click **OK**.
