

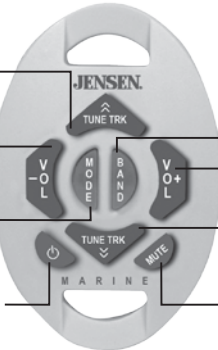
QUICK REFERENCE:

TUNE/TRACK: Press UP to tune to next channel or track.

VOLUME: Press DOWN (-) to DECREASE volume.

MODE: With each press of the button the radio will change through the available playback modes.

ON/OFF: Press to turn radio ON/OFF.



BAND: Press to select BAND and/or preset group channel memory locations.

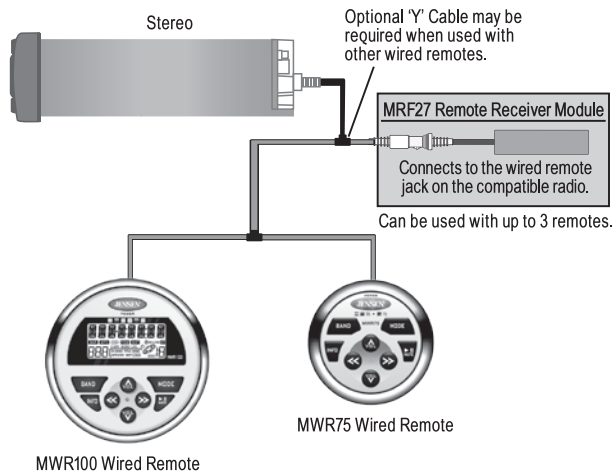
VOLUME: Press UP (+) to INCREASE volume.

TUNE/TRACK: Press DOWN to tune to next channel or track.

MUTE: Press to MUTE audio.

NOTE: It is normal operation to have some delay between remote button press and radio response.
