



- If the battery pack will not be used for a long period of time (a month or more), charge or discharge (use) the battery pack until the remaining battery level becomes 30% to 40% and store it in a cool, dry place.
- This computer prevents overcharging of the battery by recharging only when the remaining power is less than approx. 95% of capacity.
- The battery pack is not charged when the computer is first purchased. Be sure to charge it before using it for the first time. When the AC adaptor is connected to the computer, charging begins automatically.
- Should the battery leak and the fluid get into your eyes, do not rub your eyes. Immediately flush your eyes with clear water and see a doctor for medical treatment as soon as possible.

#### NOTE


- The battery pack may become warm during recharging or normal use. This is completely normal.
- Recharging will not commence if internal temperature of the battery pack is outside of the allowable tempera-

ture range (0 °C to 50 °C {32°F to 122°F}) ( $\Rightarrow \bigoplus$  *Reference Manual* "Battery Power"). Once the allowable range requirement is satisfied, charging begins automatically. Note that the recharging time varies based on the usage conditions. (Recharging takes longer than usual when the temperature is 10 °C {50°F} or below.)

- If the temperature is low, the operating time is shortened. Only use the computer within the allowable temperature range.
- This computer has a high temperature mode function that prevents the degradation of the battery in high temperature environments. (→ ♀ Particle Reference Manual "Battery Power") A level corresponding to a 100% charge for high temperature mode is approximately equivalent to an 80% charge level for normal temperature mode.
- The battery pack is a consumable item. If the amount of time the computer can be run by using a particular battery pack becomes dramatically shorter and repeated recharging does not restore its performance, the battery pack should be replaced with a new one.
- When transporting a spare battery inside a package, briefcase, etc., it is recommended that it be placed in a plastic bag so that its contacts are protected.
- Always power off the computer when it is not in use. Leaving the computer on when the AC adaptor is not connected will exhaust the remaining battery capacity.

## CAUTION

- Do not disconnect the AC adaptor and do not switch the wireless switch to on until the first-time operation procedure is completed.
- When using the computer for the first time, do not connect any peripheral device except the battery pack and AC adaptor.
- Handling the AC adaptor
  - Do not twist or pull the AC power cord forcefully. Doing so may damage the connections.
  - Use only the specified AC adaptor with your computer. Using an AC adaptor other than the one supplied might damage the battery and/or the computer.
  - When the DC plug is not connected to the computer, disconnect the AC cord from your AC wall outlet.
  - · Problems such as sudden voltage drops may arise during periods of thunder and lightning. Since this could adversely affect your computer, an uninterruptible power source (UPS) is highly recommended unless running from the battery pack alone.



## 3 Turn on the computer.

- ① Pull the carrying handle forward.
- ② Lift up the latch (A) and lift open the display.
- ③ Press and hold the power button () for approximately one second until the power indicator ⊕ lights.

## CAUTION

- Do not press the power button repeatedly.
- The computer will forcibly be turned off if you press and hold the power button for four seconds or longer.
- Once you turn off the computer, wait for ten seconds or more before you turn on the computer again.
  - Do not perform the following operation until the hard disk drive indicator let turns off.

# **Operation Environment**

- Place the computer on a flat stable surface. Do not place the computer upright or turn it over. If the computer is
  exposed to an extremely strong impact, it may become inoperable.
- Temperature: Operation: 5 °C to 35 °C {41 °F to 95 °F}

Storage: -20°C to 60 °C {- 4 °F to 140 °F} Humidity: Operation: 30% to 80% RH (No condensation)

Storage: 30% to 90% RH (No condensation)

Even within the above temperature/humidity ranges, using for a long time in an extreme environment will result in the product deterioration and will shorten the product life.

- Do not place the computer in the following areas, otherwise the computer may be damaged.
- Near electronic equipment. Image distortion or noise may occur.
- In extremely high or low temperature.
- As the computer can become hot during operation, keep it away from items that are sensitive to heat.

# **Handling Cautions**

This computer is designed to minimize shock to parts such as the LCD and the hard disk drive and equipped with a dripproof keyboard, but no warranty is provided against any trouble caused by shock. Be extremely careful when handling the computer.

When carrying the computer:

- Turn off the computer.
- Remove all external devices, cables, cards and other protruding things.
- Remove a disc in the CD/DVD drive.
- Do not drop or hit the computer against solid objects.
- Do not leave the display open.
- Do not grip the display part.
- Do not put anything (e.g., a piece of paper) between the display and keyboard.
- When you board an airplane, take the computer with you and never put it in your checked luggage. When using the computer on airplane, follow the airline's instructions.
- When carrying a spare battery, put it in a plastic bag to protect its terminals.
- The touch pad is designed to be used with a finger tip. Do not place any object on its surface and do not press down strongly with sharp-pointed or hard objects that may leave marks (e.g., nails, pencils and ball point pens).
- Avoid any harmful substances such as oil from getting into the touch pad. The cursor may not work correctly. <Only for model with touchscreen>
- Use only the included stylus to touch the touchscreen. Do not place any object on its surface and do not press down strongly with sharp-pointed or hard objects that may leave marks (e.g., nails, pencils and ball point pens).
- Do not use the stylus when dust or dirt (e.g., oil) is on the screen. Otherwise foreign particles on the screen/stylus can scratch the screen surface or obstruct the stylus operation.
- Use the stylus only for touching the screen. Using it for any other purpose may damage the stylus and result in scratches on the screen.

# When using peripheral devices

Follow these instructions and the Reference Manual to avoid any damage to the devices. Carefully read the instruction manuals of the peripheral devices.

- Use the peripheral devices conforming to the computer's specifications.

# Maintenance

## To clean the LCD panel

Use the soft cloth included with the computer. (For further information, refer to "Suggestions About Cleaning the LCD Surface" that comes with the soft cloth.)

### To clean areas other than the LCD panel

Wipe with a soft dry cloth such as gauze. When using detergent, dip a soft cloth in water-diluted detergent and wring it thoroughly.

#### CAUTION

- Do not use benzene, thinner, or rubbing alcohol since it may adversely affect the surface causing discoloration, etc.
   Do not use commercially-available household cleaners and cosmetics, as they may contain components harmful to the surface.
- Do not apply water or detergent directly to the computer, since liquid may enter inside of the computer and cause malfunction or damage.

# Hard Disk Backup Function

The hard disk backup function creates a backup area (storage area) on the hard disk. This area is to back up (store) the hard disk data or to restore the backup data to their original locations.

Using this function, you can protect your data when it is lost or corrupted by operational errors or other factors. You do not need other media or peripheral devices to back up or restore hard disk data on this computer.

At purchase, the hard disk backup function is disabled. If you create a backup area, the hard disk backup function will be enabled and you can back up your data.

The hard disk backup function cannot back up or restore data correctly if a hard disk problem occurs during data backup or restoring. If an error occurs due to an unexpected malfunction, incorrect operation, or other reason while data is being restored, the hard disk data (data before restoration) may be lost.

Matsushita Electric Industrial Co., Ltd. will bear no responsibility for any damages suffered by the user (including loss of data) as a result of the use of this function.

### CAUTION

- To disable the backup function after it is enabled, you have to perform the reinstallation procedure (→ page 20).
- A backup area cannot be created if the hard disk is already divided into several partitions. Return the computer to one partition, and create the backup area.
- If the partition configuration is changed after the backup area is created (creating partitions, changing size, etc.), the backup function will be disabled. You need to return the computer to the original condition and create the backup area again.
- Do not use the NTFS file system compression function. It may result in insufficient capacity of the backup area.
- The hard disk backup function does not accommodate dynamic disks. Do not convert the hard disk to a dynamic disk.

# NOTE

- The backup area requires at least half of the entire hard disk capacity. If the capacity is not sufficient, the backup area will not be created.
- When the backup area is created, the usable hard disk capacity will be less than half of the original capacity.
- The backup area cannot be accessed from Windows. The backup data cannot be copied to CD-R or other removable disk media.
- When the hard disk backup function is executed, data in the backup area will be overwritten and the data previously stored will be lost.

# **Creating the Backup Area**

## Preparation

- Prepare the following items:
  - The Product Recovery DVD-ROM (included)
  - Panasonic CD/DVD drive (included)
- Remove all peripherals (except for the CD/DVD drive).
- Connect the AC adaptor and do not remove it until hard disk backup is complete.
- Turn off the computer and insert the CD/DVD drive into the multimedia pocket
   (→ ♀ Reference Manual "Multimedia Pocket").
- 2 Turn on the computer, and press **F2** several times while [Panasonic] boot screen is displayed.

The Setup Utility starts up.

• If the password is requested, enter the Supervisor Password.

- 3 Select the [Boot] menu and select [IDE MP], and then press **F6** until [IDE MP] moves up to the top of the boot priority order.
- 4 Select the [Security] menu and set [CD/DVD Operation] to [Enable].
- 5 Set the Product Recovery DVD-ROM into the CD/DVD drive.

# 6 Press **F10**.

At the confirmation message, select [Yes] and press **Enter**. The computer restarts.

• If [Enter Password] is displayed during the following procedures, input the Supervisor Password or the User Password.

# 7 Press **3** to execute [3. [Backup]].

At the confirmation message, press  $\overline{\mathbf{Y}}$ .

## CAUTION

When you divide the hard disk into partitions: Do not execute [1. [Recovery]] to divide the hard disk into partitions. The hard disk backup function cannot be enabled after the hard disk has been partitioned. Use step 8 to divide the hard disk.

## 8 Select the setting.

- To create a backup area and enable the backup function without dividing the hard disk Select [1].
- To create a backup area and divide hard disk into two partitions, for OS and data Select [2]. Enter the size of operating system partition and press **Enter**.
  - To cancel: press <u>0</u>.

(The size of data partition will be determined by subtracting the operating system partition size from the maximum size.)

9 At the confirmation message, press  $\overline{\mathbf{Y}}$ .

The backup area is then created.

- 10 When the message [You must reboot in order to enable the Backup function.] appears, remove the Product Recovery DVD-ROM, and press any key to restart the computer. The computer restarts, then the backup process will begin.
- 11 When the message [[Backup] is complete] appears, press **Ctrl** + **Alt** + **Del** to restart the computer.
  - Do not press **Ctrl** + **Alt** + **Del** before the message is displayed.
  - After logging on to Windows, a message will appear indicating that a new device has been installed and that the computer must be restarted to enable the settings.

## 12 Select [Yes] to restart the computer.

- NOTE
- The [Boot] menu in the Setup Utility is now set to start up from the CD/DVD drive. Change it if necessary.
- To perform the backup/restore function next time; "Creating/Restoring the Backup Data" (→ below).
- The backup area cannot be accessed from windows.

# **Creating/Restoring the Backup Data**

## CAUTION

- Before executing the backup function, execute a disk error check.
- Do not interrupt the backup or restore functions. Do not turn off the power and do not press **Ctrl** + **Alt** + **Del**, otherwise Windows cannot start up, or the data may be lost and the backup and restore functions may not be completed.

# 1 Turn on the computer, and press **F2** several times while [Panasonic] boot screen is displayed.

The Setup Utility starts up.

- If the password is requested, enter the Supervisor Password or the User Password.
- 2 Select the [Exit] menu and select [Hard Disk Backup / Restore], and then press **Enter**. At the confirmation message, select [Yes] and press **Enter**.

# 3 Select the setting.

- To back up hard disk contents to the backup area
- 1 Press 1 to execute [1. [Backup]].
  - If the hard disk is divided into two partitions, select the backup method at the next screen.
- (2) At the confirmation message, press  $\overline{\mathbf{Y}}$ .
  - The backup process starts.
- To restore backed up contents to the hard disk
- 1 Press 2 to execute [2. [Restore]].
  - When data is backed up in two partitions, select the restore method at the next screen.
- ② At the confirmation message, press  $\overline{\mathbf{Y}}$ .
- The restore process starts.

NOTE

The required time to complete the backup or restore process depends on the data volume.

- When the message [[Backup] is complete] or [[Restore] is complete] is displayed, press
   Ctrl + Alt + Del to restart the computer.
  - If the backup or restore process was interrupted before completion, execute the process again.
  - After logging on to Windows, a message will appear indicating that a new device has been installed and that the computer must be restarted to enable the settings. Select [Yes] to restart the computer.

### CAUTION

- When the hard disk backup function has been enabled, you cannot erase the backup data even when you erase all data from user accessible area by using a commercial data erasing utility or similar software. To erase all data on the hard disk including backed up data, use the hard disk data erase utility included in this computer (→ page 19). Erase the data using the hard disk data erase utility before disposing of or transferring ownership of this computer.
- During backup, the message [#1805 cannot write image file] may appear, and the backup function may be interrupted. In this case, execute the backup function again. If the backup function is completed normally, the hard disk has no problem.

## To disable the hard disk backup function

Perform the reinstallation procedure.

## CAUTION

- All data in the backup area and hard disk will be erased.
  - ① Perform steps 1-9 for "Reinstalling Software" (→ page 20).
  - ② Select [1] or [2] to execute the reinstallation at the screen for executing the reinstallation.
    - [1]: The hard disk backup function is disabled.
    - [2]: The hard disk backup function is disabled. However the hard disk backup function cannot be reenabled because the hard disk has been divided into partitions.
    - [3]: The hard disk backup function is not disabled.

# Hard Disk Data Erase Utility

When disposing the computer or transferring the ownership, erase all hard disk data in order to avoid data leakage. Even if you erase the data or initialize the hard disk using normal Windows commands, the data can be read with some special software. Use the hard disk data erase utility to erase the data completely.

Note that transferring of the ownership without uninstalling the commercial software will be a violation of the software's license agreement.

The hard disk data erase utility erases the data using overwriting method. If a malfunction or other operational error occurs during the erasing process, the data may not be completely erased. Also there may be special devices to read the erased data. To erase highly confidential data, ask a specialized company. Matsushita Electric Industrial Co., Ltd. will bear no responsibility for losses or damages suffered as a result of the use of this utility.

## CAUTION

The backup area and the backup data will be erased.

#### NOTE

• Even if hard disk data erase is performed, the number of times of DVD's region code setting will not be reset.

## Preparation

- Remove all peripherals (except for the CD/DVD drive).

At the confirmation message, select [Yes] and press **Enter**. The computer restarts.

• When the hard disk backup function has been enabled, the confirmation message appears to inform that the backup function will be disabled, and the backup area and data will be erased. Press **Y** to proceed.

# 7 Press $\overline{2}$ to execute [2. [Erase HDD]].

- To cancel this operation, press **0**.
