Troubleshooting guide

No play.

- •The disc isn't correctly set.
- The disc is scratched or dirty. (Tracks skipped.)
- There is moisture on the lens. Wait for about an hour and then try again.
- •The lens is dirty: clean it with a blower (recommended product: SZZP1038C).If the lens gets marked with fingerprints, gently wipe them off with a cotton swab.

No sound or there is a lot of noise.

- . Ensure the plugs are inserted firmly.
- Wipe the plugs clean with a clean cloth.
- The elapsed playing time disappears and sound is interrupted if bumps continue repeatedly.
- · Separate this unit from mobile telephones

Play doesn't resume from the track where play stopped at.

Play doesn't start

from the first track.

- This doesn't work if you open the lid while the unit is in stop mode.
- This doesn't work during random play
- It may not work correctly under some conditions.
- Play resumes from the track where you last stopped play or power was cut off (play may start from a different track if you change discs after power is cut off). Use skip to return to the first track.

This unit can play CD-DA format audio CD-R and CD-RW that have been finalized* upon completion of recording. It may not be able to play some CD-R or CD-RW due to the condition of the recording.

**Finalizing is a process that enables CD-R/CD-RW players to play audio CD-R and CD-RW.

Resume function

The player stores the track where you stopped play or power was cut off. Opening the lid when the unit is in stop mode cancels the function.

Auto power off function

If the unit is left in stop mode for approximately 10 minutes, the unit powers itself off automatically.







This indicator appears when the unit is on.




■Before playing starts the battery indication may flash although the batteries are not drained. This is normal.

Press again to restart play.

Search



■You can search only within the current track during program, one-track repeat, or random play modes (page 4).

Stop



■Press again to turn the unit off.

Skip



■Press [| wice to skip to the beginning of the previous track during play.

Other Play Methods





Anti-Skip System

This system reduces the skipping caused by vibration to a minimum. You can change the anti-skip memory time to improve sound quality. Each time you press and hold [MODE]

Caution

■Batteries
