Troubleshooting guide

No play.	The HOLD function is on. Release HOLD (⇔page 3). The disc isn't correctly set. The disc is scratched or dirty. (Tracks skipped.) There is moisture on the lens. Wait for about an hour and then try again. The lens is dirty: clean it with a blower (recommended product: SZZP1038C).If the lens gets marked with fingerprints, gently wipe them off with a cotton swab.	
No sound or there is a lot of noise.	 Ensure the plugs are inserted firmly. Wipe the plugs clean with a clean cloth. The elapsed playing time disappears and sound is interrupted if bumps continue repeatedly. Separate this unit from mobile telephones.

HOLD

This function causes the unit to ignore accidental button presses Set to HOLD so the unit doesn't power on accidentally or play is interrupted.

Note on CD-R and CD-RW

This unit can play CD-DA format audio CD-R and CD-RW that have been finalized* upon completion of recording. It may not be able to play some CD-R or CD-RW due to the condition of the recording.
*Finalizing is a process that enables CD-R/CD-RW players to play audio CD-R and CD-RW.

Resume function

The player stores the track where you stopped play. Opening the lid when the unit is in stop mode cancels the function.

Auto off function

If the unit is left in stop mode for approximately 10 minutes, the unit turns itself off automatically.

Changing the sound quality

Each time you press [EQ]



•The effect may differ between different kinds of music.

Caution

■Listening
