Condition

Vehicles sold to Canadian customers were shipped with manufacturing certification labels that contained a National Emissions Mark (NEM) that did not have an approval number.

Correction

Perform a visual check of the label for the approval number and replace the label if necessary.

Procedure

1. Open the driver's side door to access the manufacturing certification label on the door jamb (Figure 1).



2. Inspect the label for the approval number next to the EC symbol (Figure 2). If the label has the approval number, no additional work needs to be done. Discontinue this procedure.



- If the label does not have the approval number, gently peel it off of the door jamb, starting from one corner, and discard.
- 4. Remove any remaining adhesive or label shreds from the area with an alcohol wipe and allow to completely dry.
- 5. Retrieve the updated label for the specific VIN. All labels have been shipped to the home Service Centers for the vehicles. Confirm the VIN on the new label matches the dashboard VIN plate before installing it.
- 6. Place the updated label onto the same location on the door jamb.
- 7. Use touch up paint to cover any nicks or scratches created during removal of the old label.

Affected VIN(s)

Affected Canadian Model S vehicles built between approximately November 1, 2012 and September 27, 2013, and June 16, 2014-September 16, 2014.
