1st generation charge ports do not have a motorized charge port door. 1.5 generation charge ports have a motorized charge port door. 1st generation charge port doors are only compatible with 1st generation charge ports. 1.5 generation charge port doors are only compatible with 1.5 generation charge ports.

# **Out of Warranty Job Lines**

For vehicles out of warranty, if the 1st generation charge port door needs replacement, the customer has the option of replacing or retrofitting the charge port door. If the 1st generation charge port needs replacement, retrofit a 1.5 generation charge port. Use the next section of job lines if the customer requests a retrofit.

NOTE: 1st generation charge port doors are only compatible with 1st generation charge ports. 1.5 generation charge port doors are only compatible with 1.5 generation charge ports.

**WARNING:** Only technicians who have been trained in High Voltage Awareness are permitted to perform this procedure. Proper personal protective equipment (PPE) and insulating HV gloves with a minimum rating of class 0 (1000V) must be worn any time a high voltage cable is handled. Refer to TN-15-92-003, "High Voltage Awareness Care Points" for additional safety information.

# **Retrofit Charge Port and Charge Port Door**

- Remove the 1<sup>st</sup> generation charge port door (refer to Service Manual procedure 44014202).
- Remove the 1<sup>st</sup> generation charge port (refer to Service Manual procedure 44012202).
- 3. Check the <u>electrical diagram</u> for the vehicle (Cabin Fusebox in location F44):
  - If there is a 5A fuse, install a 10A fuse, and then continue to the next step.
  - If there is a 10A fuse, continue to the next step.

NOTE: A 10A fuse is already in use for vehicles built after May 28, 2015.

Install the 1.5 generation charge port (refer to Service Manual procedure 44012502).

5. Install Noise, Vibration, and Harshness (NVH) foam on the connector that attaches the charge port to the charge port door (Figure 1).

6. Install felt tape on the old connector and wire that previously attached to the tail light.

**NOTE:** The 1.5 generation charge port has its own charging status indication LEDs. The old connector and wire to the tail light has to be isolated to prevent future NVH concerns.

- 7. Install a 1.5 generation charge port door (refer to Service Manual procedure 44014102).
- 8. Perform the Toolbox routines listed below:
  - Vehicle Firmware Update
  - Charge Port Door Sensor Calibration Service
- 9. Perform a functional check of the 1.5 generation charge port.
