THE following errors were made by the AIAA Editorial Department staff in the published paper:

Page 299:

On the line preceding Eq. (1), the expression ($g_n = 0$) should read ($\dot{g}_n = 0$).

Page 301:

The equation preceding Eq. (6) should read

$$\dot{\mathbf{g}}_1 = \omega \times \mathbf{g}_1 = (\omega_1 \mathbf{g}_1 + \omega_2 \mathbf{g}_2 + \omega_3 \mathbf{g}_3) \times \mathbf{g}_1 = \omega_3 \mathbf{g}_2 - \omega_2 \mathbf{g}_3$$

The second line in the second column should end with κ^3 , not κ .

The line below Eq. (8) should read "here $\tau \triangleq \mathbf{y}''' \cdot \mathbf{y}' \times \mathbf{y}'' / \kappa^2$ is the torsion of the curve..."

Equation (10) should be

$$\omega_p^j = \begin{cases} (\tau + \nu) \mathbf{y}' + \mathbf{y}' \times \mathbf{y}'' & \text{for } j \in P(k) \\ 0, & \text{otherwise} \end{cases} \quad (10)$$

Page 302:

The line below Eq. (16) should read "Note that e is also a small quantity; and $u'_1 = (\mathbf{u}')_1 \neq (u_1)'$."

The first line of the equation immediately below Eq. (18) should be

$$\mathbf{u}(s, \zeta, t) = \sum \psi_n \eta_n + (\mathbf{u}'_2 \mathbf{g}_3 - \mathbf{u}'_3 \mathbf{g}_2) \times (\zeta_2 \mathbf{g}_2 + \zeta_3 \mathbf{g}_3)$$

where the second \mathbf{u} in the parenthetical expression is *not* boldface.

Page 303:

The first equation on the page should read

$$\tilde{\mathbf{g}}_i = \mathbf{g}_i + \gamma \times \mathbf{g}_i, \quad i = 1, 2, 3$$

where the i in the final \mathbf{g}_i is a subscript.

Equation (27) should be corrected as

$$\{\tilde{\mathbf{g}}\} = [\mathbf{B}] \{\dot{\mathbf{g}}\} + [\dot{\mathbf{B}}] \{\mathbf{g}\} \quad (27)$$

The "where" expression above Eqs. (28) should read "where $\psi'_{ni} = \mathbf{g}_i \cdot \psi'_n$." The fourth line of text below that should be changed to "($\tan \alpha / R$) $\dot{s} = (\tan \alpha / R) \dot{s} = \nu \dot{s}$ to $\dot{\omega}_1$, we finally obtain the ..."

Equation (29) should be written as

$$\begin{aligned} \omega_p^j &= \begin{cases} (\tau + \nu + \kappa u'_3 + \theta') \tilde{\mathbf{g}}_1 + (\kappa \theta - u'_3) \tilde{\mathbf{g}}_2 \\ + [\kappa(1 - u'_1) + u'_2] \tilde{\mathbf{g}}_3, & \text{for } j \in P(k) \\ 0, & \text{otherwise} \end{cases} \\ V_{p'}^{hj} &= \begin{cases} (\mathbf{y}' + \mathbf{u}') + \omega_p^j \times \mathbf{X}^{kj}, & \text{for } j \in P(k) \\ 0, & \text{otherwise} \end{cases} \\ V_{p'}^{hj} &= 0 \end{aligned} \quad (29)$$

Page 304:

There are four obvious misprints in Eqs. (34) and (35), as follows: two redundant equal signs should be omitted from the last of Eqs. (34) and the first of Eqs. (35); in the second of Eqs. (35), the superscript of V should be hj ; the last line of Eqs. (35) should read " $= 0$, otherwise."

In the second line from the bottom of the page, the correct expression is $\zeta = \zeta_2 \mathbf{g}_2 + \zeta_3 \mathbf{g}_3$ (boldface \mathbf{g}_2).

Page 305:

The equation below Eq. (37) should read as follows:

$$\begin{aligned} \dot{H}^{hk} &= \mathbf{I}^{hk} \cdot \dot{\omega} + \omega \times \mathbf{I}^{hk} \cdot \omega + m_k \sum_{n=1}^{NM} \{ h_n \ddot{\eta}_n \\ &+ [(\mathbf{M}_n^T + \mathbf{M}_n) \cdot \dot{\omega}] \eta_n + 2 \mathbf{M}_n \cdot \omega \dot{\eta}_n \\ &+ \omega [\mathbf{M}_n^T + \mathbf{M}_n] \cdot \omega \eta_n \} \\ &+ \int [\mathbf{u} \times \ddot{\mathbf{u}} + \mathbf{u} \times (\dot{\omega} \times \mathbf{u}) + 2 \mathbf{u} \times (\omega \times \dot{\mathbf{u}}) \\ &+ \mathbf{u} \times (\omega \times (\omega \times \mathbf{u}))] dm \end{aligned}$$

In the second column, the second line below the second equation should read "of the cross section. Because ρ , κ , ψ_n , \mathbf{g}_i and Θ_n are all known..."

Page 306:

The last line of Eq. (42) should be changed to

$$+ \frac{1}{2} (\zeta \Sigma \Theta'_i \eta_i)^2 / (1 - \kappa \zeta \cos \beta) \} \zeta d\beta d\zeta ds \quad (42)$$
