## Ti insertion in the $M \mathrm{e}_{5}$ ( $\mathrm{M}=\mathrm{Zr}, \mathrm{Hf}$ ) structure type: $\mathbf{H f}_{0.78} \mathrm{Ti}_{0.22} \mathbf{T e}_{5}$

The group 5 mixed-metal telluride, $\mathrm{Hf}_{0.78} \mathrm{Ti}_{0.22} \mathrm{Te}_{5}$ (hafnium titanium pentatelluride), is isostructural with the binary phases $\mathrm{HfTe}_{5}$ and $\mathrm{ZrTe}_{5}$ and forms a layered structure extending parallel to (010). The layers are made up from chains of bicapped metal-centered trigonal prisms and zigzag Te chains. The metal site (site symmetry $m 2 m$ ) is occupied by statistically disordered Hf [78.1 (5)\%] and Ti [21.9 (5)\%]. In addition to the regular $\mathrm{Te}-\mathrm{Te}$ pair [2.7448 (13) $\AA$ ] forming the short base of the equilateral triangle of the trigonal prism, an intermediate $\mathrm{Te} \cdots \mathrm{Te}$ separation $[2.9129(9) \AA$ ] is also found. The classical charge balance of the compound can be described as $\left[M^{4+}\right]\left[\mathrm{Te}^{2-}\right]\left[\mathrm{Te}_{2}{ }^{2-}\right]\left[\mathrm{Te}_{2}{ }^{0}\right](M=\mathrm{Hf}, \mathrm{Ti})$. The individual metal content can vary in different crystals, apparently forming a random substitutional solid solution $\left(\mathrm{Hf}_{1-x} \mathrm{Ti}_{x}\right) \mathrm{Te}_{5}$, with $0.15 \leq x \leq 0.22$.

## Comment

The existence of the binary pentatellurides, $M \mathrm{Te}_{5}(M=\mathrm{Zr}, \mathrm{Hf})$ was established in 1971 by Brattås \& Kjekshus. These compounds have been the most chalcogen-rich stoichiometric transition metal binary chalcogenides since then. These phases are important not only because of their unusually high chalcogen contents but because of the anomalies in their transport properties (DiSalvo et al., 1981). The Ti analogue of this phase is desired to study the relationship between structure and properties. However, efforts to find $\mathrm{TiTe}_{5}$ have not been successful despite numerous attempts (Furuseth et al., 1973). Indeed, no Ti analogue of the $M T e_{8}$ polyhedra found in $M \mathrm{Te}_{5}$ (Furuseth et al., 1975) has been observed up to now. During attempts to synthesize new metal tellurides, we found the new Ti-containing mixed-metallic phase $\mathrm{Hf}_{0.78} \mathrm{Ti}_{0.22} \mathrm{Te}_{5}$.

The title compound is isostructural with $\mathrm{HfTe}_{5}$ and $\mathrm{ZrTe}_{5}$. Detailed descriptions of this structural type have been reported previously (Furuseth et al., 1973). A view of the structure down the $a$ axis is given in Fig. 1, which shows the layered nature parallel to (010). The structure is composed of chains made up from bicapped trigonal prismatic $M \mathrm{Te}_{8}$ units. The metal $(M)$ site occupied by statistically disordered $\operatorname{Hf}(78.1(5) \%)$ and $\mathrm{Ti}(21.9(5) \%)$ is surrounded by eight Te atoms. Three crystallographically independent Te sites are found in the title compound. Both Te 1 (site symmetry m 2 m ) and Te 2 (site symmetry $m .$. ) are at the corners of a triangular prism and they are bridging the $M$ atoms to form a chain. Two Te 3 (site symmetry $m .$. ) atoms outside the rectangular faces of the prism are connected to the neighboring Te 3 to form the infinite zigzag Te chain. Finally, the $M \mathrm{Te}_{5}$ layer is formed by the alternate linking of these chains (Fig. 2).
The structure shows a wide range of $\mathrm{Te} \cdots \mathrm{Te}$ interactions. In the prism, the $\mathrm{Te} 2 — \mathrm{Te} 2$ pair (2.7448 (13) $\AA$ ) forming the short base of the equilateral triangle exhibits a regular $\mathrm{Te}-\mathrm{Te}$ bond, $\mathrm{Te}_{2}{ }^{2-}$ (e.g. discussed by Pell \& Ibers, 1996). In addition, an intermediate $\mathrm{Te} 3 \cdots \mathrm{Te} 3$ separation (2.9129 (9) $\AA$ ) is indicative of a weak single bond (Mar \& Ibers, 1993) but we assign an oxidation state of 0 for $\mathrm{Te} 3\left({ }^{1}{ }_{\infty}\left[\mathrm{Te}^{0}\right]\right)$. The classical charge balance of the compound can be described as $\left[M^{4+}\right]\left[\mathrm{Te}^{2-}\right]\left[\mathrm{Te}_{2}{ }^{2-}\right]\left[\mathrm{Te}_{2}{ }^{0}\right](M=\mathrm{Hf}, \mathrm{Ti})$.
Structury analysis of three different crystals from the same reaction tube showed that the metal content can vary, apparently forming a random substitutional solid solution $\left(\mathrm{Hf}_{1-x} \mathrm{Ti}_{x}\right) \mathrm{Te}_{5}, 0.15 \leq x \leq 0.22$.

## Experimental

The title compound, $\mathrm{Hf}_{0.78} \mathrm{Ti}_{0.22} \mathrm{Te}_{5}$, was prepared by the reaction of the elements with the use of the reactive halide-flux technique. Hf powder (CERAC 99.8\%), Ti powder (CERAC 99.5\%), and Te powder (CERAC 99.95\%) were mixed in a fused silica tube in a molar ratio of $\mathrm{Hf}: \mathrm{Ti}: \mathrm{Te}=1: 1: 10$ and then CsCl (CERAC 99.9\%) was added in a weight ratio of $\operatorname{HfTiTe}_{10}: \mathrm{CsCl}=1: 2$. The tube was evacuated to 0.133 Pa , sealed and heated gradually $(50 \mathrm{~K} / \mathrm{h})$ to 650 K , where it was kept for 72 h . The tube was then cooled to room temperature at the rate of $3 \mathrm{~K} / \mathrm{h}$. The excess halide was removed with distilled water and dark block-shaped crystals were obtained. The crystals are stable in air and water. A qualitative X-ray fluorescence analysis of the crystals indicated the presence of $\mathrm{Hf}, \mathrm{Ti}$, and Te . A quantitative XRF analysis indicated that
the Hf: Ti ratio is 80: 20. The composition of the compound was determined by single-crystal X-ray diffraction.

## Refinement

The statistically disordered nature of the $M$ site in the title compound was checked by refining the anisotropic displacement parameters (ADPs). When the model was refined assuming $\mathrm{HfTe}_{5}$ or $\mathrm{TiTe}_{5}$, the displacement parameters of the metal site were very large and small, respectively. In both cases the reliability indices were rather high ( $\mathrm{wR} 2>0.127$ ). In the refined mixed-metal model, the ADPs of the metal atoms are comparable with those of the other atoms and the residuals were reduced significantly $(\mathrm{wR} 2=0.068)$. The remaining highest and lowest electron densities are found 0.81 and $0.77 \AA$ from atom Te 1 .

## Special details

Geometry. All s.u.'s (except the s.u. in the dihedral angle between two l.s. planes) are estimated using the full covariance matrix. The cell s.u.'s are taken into account individually in the estimation of s.u.'s in distances, angles and torsion angles; correlations between s.u.'s in cell parameters are only used when they are defined by crystal symmetry. An approximate (isotropic) treatment of cell s.u.'s is used for estimating s.u.'s involving l.s. planes.
Refinement. Refinement of $F^{2}$ against ALL reflections. The weighted $R$-factor $w R$ and goodness of fit $S$ are based on $F^{2}$, conventional $R$-factors $R$ are based on $F$, with $F$ set to zero for negative $F^{2}$. The threshold expression of $F^{2}>2 \sigma\left(F^{2}\right)$ is used only for calculating $R$-factors (gt) etc. and is not relevant to the choice of reflections for refinement. $R$-factors based on $F^{2}$ are statistically about twice as large as those based on $F$, and $R$ - factors based on ALL data will be even larger.
