## A pilot phase I trial of continuous hyperthermic peritoneal perfusion with high-dose carboplatin as primary treatment of patients with small-volume residual ovarian cancer

The above article contained several errors that were not corrected in proof:

1. p 106, column 2, lines 7–8 – The comma between “1200 mg/m<sup>2</sup>” and “correlated” should be deleted.
2. p 107, column 1, second line from the bottom – “...intraperitoneal (CBDCA)” should read “...intraperitoneal **CBDCA**...” (i.e. CBDCA should not be in parenthesis).
3. p 108, column 1, line 5 – “A perfusate volume (4–5)...” should read “A perfusate volume (4–5 liters)...”
4. p 108, column 1, 2nd line under Dosage – “...that may renal drug clearance...” should read “...that may **alter** renal drug clearance...”
5. p 108, column 2, Pharmacokinetic studies line 9 – “...storage at 70 °C...” should read “...storage at –70 °C...”
6. p 109, column 1, Pharmacokinetic studies, second paragraph, line 17 – “... CL<sub>TB</sub>, is composed or renal...” should read “CL<sub>TB</sub> is composed **of** renal...”
7. p 109, column 1, Pharmacokinetic studies second paragraph, line 25 – “...the equation  $R_d = 1 + CL_{TB}/PA...$ ” should read “...the equation  $R_d = 1 + CL_{TB}/PA...$ ”
8. p 109, Table 1 – The BSA of patient 1 should read **2.1** m<sup>2</sup> and not 21 m<sup>2</sup>.
9. p 109, column 2, line 15 – “epithelia” should be “**epithelial**”.
10. p 111, column 2, last paragraph – “First, the fraction of the drug absorbed widely...” should read “First, the fraction of the drug absorbed **varied** widely...”
11. p 112, column 1, second paragraph, line 21 – “...the increase in PA of about 4 orders of magnitude...” should read “...the increase in PA of about **four-fold**...”
12. p 112, line 3 – There should be a closing parenthesis after “182 ml/min”.
