#### **UCSD Chair for Harold Simon**

Harold J. Simon, a founding member of the University of California, San Diego School of Medicine faculty has recently been honoured with an endowed chair in his name. Simon is recognized as a leader in the field of international health and health policy and this chair is in recognition of his contributions through his roles in the design of healthcare systems serving developing countries and his leadership in initiating cultural awareness training for medical students. The Harold Simon Chair in International Health and Cross-cultural Medicine has been established by an anonymous donor.

Simon is currently Professor of Family and Preventive Medicine and Chief of the Division of International Health and Crosscultural Medicine. During his career to date, he has authored eight books and more than 130 articles in refereed journals on a variety of topics including infection and infectious diseases, host-parasite interactions, antimicrobial therapy, medical education, health policy and cross-cultural issues. He is also a fellow of several international societies including the Royal Society of Medicine, the American Association for the Advancement of Science and the American College of Clinical Pharmacology and Therapeutics and founding Fellow of the Infectious Diseases Society of America.

#### Steinman joins Neurocrine Board of Directors

He is also board certified with the American Board of Psychiatry and Neurology and holds seven different patents in the US, Europe and Australia.

## Research pioneer in infectious diseases dies

Nelles Silverthorne, credited with developing the first whooping cough vaccine in the 1930s has recently died at the age of 99. Silverthorne, known as 'Silver' to his colleagues, was renowned for his significant contributions in the field of infectious diseases. He also developed a number of treatments for meningitis, tetanus and diphtheria and was the first Canadian physician to administer penicillin.

During his career, he held several key posts such as Honorary Consultant Physician at the Hospital for Sick Children (Toronto, Canada) and Associate Professor of Paediatrics at the University of Toronto (Ontario, Canada). His career started after graduating in Medicine from the University of Toronto in 1926, after which he became an intern and later a full member of staff at the Hospital for Sick Children. During his time as a practising physician, Silverthorne treated three generations of some families. His achievements led him to receive the Order of Ontario in 1994.
