

It is with great regret that we inform readers and prospective authors of the wish of Professor H. Marsh to retire from his position as an Editor-in-Chief, a wish brought about by his assuming further responsibilities in the University of Durham. Professor Marsh has been Editor-in-Chief since *The International Journal of Heat and Fluid Flow* was established in March 1979 under the auspices of the Institution of Mechanical Engineers. Following the Institution's decision to discontinue publication of the journal in December 1980, Harry Marsh played a major part in securing a speedy resumption of publication by Butterworth Scientific Ltd. in March 1982. It is difficult to exaggerate his contributions to the progress of the journal, particularly in the advances it has reported in the fluid mechanics of turbomachinery and the international reputation it has gained over its eight years of publication.

We are sure readers will want to join us in expressing our appreciation and thanks to Professor Marsh, and we are happy to be able to announce that he has agreed to maintain his association with the journal as an Advisory Editor.

The journal is fortunate in that Professor B. E. Launder of the University of Manchester Institute of Science and Technology has accepted our invitation to take the place of Harry Marsh as an Editor-in-Chief. Readers may have noted Brian Launder's inclusion as such in the June 1987 issue of the journal. He is well known for his research and publications in turbulence modelling, turbulent shear flows and experimental and computational fluid dynamics and convective heat transfer and hardly needs an introduction. He has served as a member of our Editorial Advisory Board since the journal's inauguration. He also brings to his new role the experience of acting as Associate Editor for the *ASME Journal of Fluid Engineering* from 1979 to 1983. We offer Professor Launder a warm welcome and look forward to working with him to ensure the further development of the journal.
