If accepted, the manuscript shall not be published elsewhere in the same form, in either the same or another language, without the consent of the Editors and Publisher.

INSTRUCTIONS TO AUTHORS

Submission of a paper to the International Journal of Pharmaceutics implies: (1) that it is not being submitted for publication elsewhere; (2) the transfer of the Copyright from the Author to the Publisher. Manuscripts submitted under multiple authorship are reviewed on the assumption that all listed authors concur with the submission and that a copy of the final manuscript has been approved by all authors and tacitly or explicitly by the responsible authorities in the laboratories where the work was carried out. If accepted, the manuscript shall not be published elsewhere in the same form, in either the same or another language, without the consent of the Editors and Publisher.

Papers and original figures should be submitted plus **three coples** and accompanied by a letter of transmittal to one of the Editors in Chief. When the paper is to be published as a Rapid Communication. this should be clearly indicated to the Editor in Chief.

TYPES OF PAPERS

- (1) Full length papers
- (2) Rapid communications not exceeding 1500 words or equivalent space
- (3) Descriptions / reviews of computer programs useful to pharmaceutical scientists.
 (4) Suggestions for Review Articles will be considered by the Editors-in-Chief.
