

Food Additives. Entitled "How to Proceed Under the Food Additives Amendment," 12-page booklet is first published section of a seven-part manual on food additives. It offers manufacturers a guide to legal and technical considerations presented by the Food Additives Amendment of 1958. In question-and-answer format, the booklet explains how to determine whether a substance should be classified as a food additive. Other sections describe procedures for filing petitions for approval, for filing objections to regulations, and for filing petitions for the U. S. Circuit Court of Appeals. 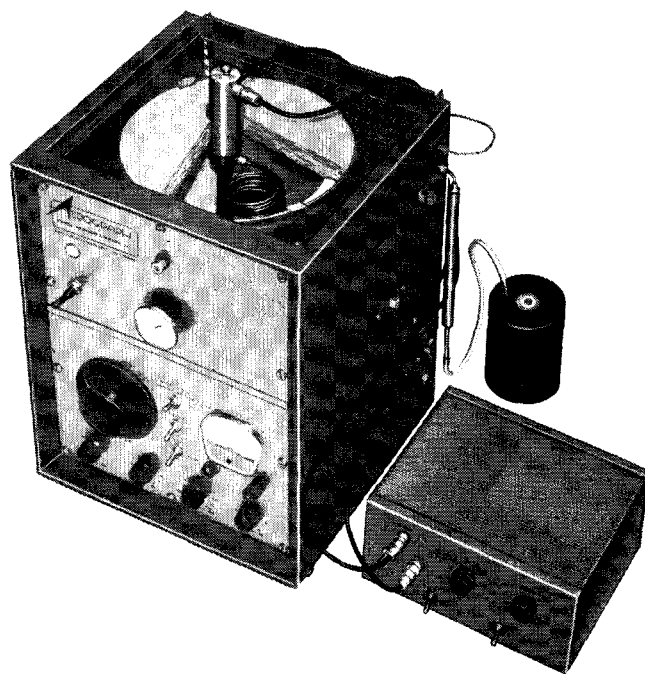
