FOOD CHEM.* **15**, 582 (1967)], the following corrections should be made: Page 588, line 29 from below should read *N*-methylidithiocarbamate instead of *N*-dimethyl. . . .; page 588, line 22 from below should read methylisothiocyanate rather than methylisocyanate; page 589, line 21 from below, delete SMDC, replace with Na-dimethyldithiocarbamate; page 589, line 12 from below, delete SMDC, replace with dimethyldithiocarbamate; and page 590, Figure 8, the letters SMDC in the figure and caption should be replaced with Na-dimethyldithiocarbamate.
