RCRA Regulations Course, May 9-10, and CERCLA/Superfund Course : Legal and Management Strategies, May 11-12, 1989, Washington, DC

The complex RCRA Regulations encompass hundreds of pages and impact literally hundreds of thousands of businesses. Government Institutes' nationally acclaimed RCRA Regulations Course will be held on May 9-10, 1989, at the Stouffer Concourse Hotel near Washington's National Airport, to help those involved with hazardous wastes be sure they are in compliance with all of these regulations.

The course will examine What Wastes are Hazardous; Generator and Transporter Requirements; the Requirements and Specific Facility Standards of Treatment, Storage, and Disposal of Hazardous Wastes; and New Land Ban Disposal Restrictions. Registrants also will get a comprehensive overview of RCRA Permits: Used Oil Regulations; the Underground Storage Tank Regulatory Program; and Federal and State Inspections, Liability and Enforcement-including civil and criminal penalties.

The intensive, two-day course is sponsored by Government Institutes, Inc., and features a team of noted RCRA experts — including Ridgway M. Hall, Jr., Robert C. Davis, Jr., and Nancy S. Bryson of the D.C. law firm of Crowell & Moring — who have been rated as “excellent and knowledgeable speakers” by previous attendees. Also bringing his practical expertise to the program will be David Case, General Counsel for the Hazardous Waste Treatment Council. Joyce Rizzo, Vice President of Hart Environmental Management Corporation, will discuss how to deal with underground storage tank regulations from an engineer's perspective. In addition, senior officials from U.S. EPA Headquarters will describe the complex Section 3001 regulations for the identification and listing of hazardous waste as well as the latest developments in solid waste management under RCRA's Subtitle D.

Immediately following the RCRA Course, Government Institutes will sponsor an expanded two-day course on the Superfund Law and Regulations, including the sweeping Superfund Amendments of 1986.

The new Superfund Amendments and how they will affect environmental manager's compliance strategies will be discussed at the Stouffer Concourse Hotel May 11-12, 1989. The CERCLA/Superfund Course: Legal and Management Strategies is held for two full days to review all the amendments and their impact on the regulated community.

Tougher cleanup standards, new action-forcing schedules for site clean-ups,

new liabilities and indemnity provisions for response-action contractors, new settlement procedures and guidelines, increased fines and penalties for spill or release reporting violations, and the important Community Right-to-Know and emergency planning provisions are just a few of the topics that will be discussed at the expanded Superfund course.

The Superfund Course will be taught by a team of expert Superfund professionals, including Ridgway M. Hall, Jr., Richard Schwartz, Nancy S. Bryson, Robert C. Davis, Jr. and R. Timothy McCrum from the Washington, D.C. law firm of Crowell & Moring. Joining them will be David Case, General Counsel of the Hazardous Waste Treatment Council. Together, this team of instructors has been described by previous registrants as "the most knowledgeable speakers today on hazardous waste". Thomas Vetrano, Senior Project Engineer of Hart Environmental Management Corporation, will discuss the "Role of the Technical Consultant in Superfund Committees." Several top Superfund officials from EPA also will participate.
