# 6<sup>th</sup> International Symposium on Loss Prevention and Safety Promotion in the Process Industry, Oslo, Norway, June 19–22, 1989

The 6<sup>th</sup> international symposium on Loss Prevention and Safety Promotion in the Process Industry, which is the 390 event of the European Federation of Chemical Engineering, will be organised by the Norwegian Society of Chartered Engineers in collaboration with the U.S. Center for Chemical Process Safety at the Oslo Concert Hall, Munkedamsveien 14 in Oslo.

The process industry is working hard to make the plants safe. Large and small accidents, however, are still hurting people and environment, in spite of excellent results which have been made in this field through the years. Various industries have common problems, such as the chemical industry, metallurgical, nuclear, pharmaceutical, oil refining, petrochemical, pulping etc. Their tasks in safety cannot be solved just by themselves. Research, standardisation and regulations are also helpful tools.

During a conference in 1971 in Newcastle the foundation of a series of symposia was made: Delft (1974), Heidelberg (1977), Basel (1980), Harrogate (1983), Cannes (1986) and now in Oslo (1989). These events are organized under the auspices of the European Federation of Chemical Engineers.

About 250 papers have been submitted to the Scientific Committee of the Symposium this year, 70 of which have been accepted for an oral presentation and about 40 as posters. We think that the quality and diversity of the papers is a guarantee for a useful symposium.

Preprints of papers will be sent prior to the Symposium to all delegates whose registration forms/payment have been received.
