Volume **148**, Number 2 (2001), in the article “NMR Phase Noise in Bitter Magnets,” by E. E. Sigmund, E. S. Calder, G. W. Thomas, V. F. Mitrović, H. N. Bachman, W. P. Halperin, P. L. Kuhns, and A. P. Reyes, pages 309–313 (doi:10.1006/jmre.2000.2246): On page 312, the right-hand side of Eq. [11] should read

$$\exp\left(-\frac{1}{64}(\gamma h\omega)^2(2\tau)^4\right)$$

instead of

$$\exp\left(-\frac{1}{4}(\gamma h\omega)^2(2\tau)^4\right).$$

Correspondingly, on page 313, the right-hand side of Eq. [13] should read

$$\left(\frac{64 \ln\left(\frac{1}{0.99}\right)}{(\gamma h\omega)^2}\right)^{1/4}$$

instead of

$$\left(\frac{4 \ln\left(\frac{1}{0.99}\right)}{(\gamma h\omega)^2}\right)^{1/4}.$$

The estimates in the following paragraph using Eq. [13] do not include this error. The corrections do not change the conclusions of the paper.

S. Spencer, Kenneth W. Fishbein, and Craig J. Galban, pages 251–257 (doi:10.1006/jmre.2000.2251): After the author had checked the proofs, an error at the compositor caused a misprint in Eq. [1] on page 251. Equation [1] should read

$$\text{SF}(T_1; \theta, \text{TR}) = \frac{(1 - e^{-\text{TR}/T_1}) \sin \theta}{(1 - e^{-\text{TR}/T_1} \cos \theta)}$$

instead of

$$\text{SF}(T_1; \theta, \text{TR}) = \frac{(1 - e^{-\text{TR}/T_1}) \sin \theta}{(1 - e^{-\text{TR}/T_1}) \cos \theta}.$$
