On page 3262, right hand column, an error was made, the manuscript should read:

(a) a hollow furnace electrode (Lindberg Furnace Co., Watertown, WI); (b) a greyish SiC tube with a clay binder fused in with SiC (Bolt Technical Ceramics, Conroe, Texas);

On page 3266, the caption for figure 6 should read:

Resistivity-temperature plots for melt-processed $\text{YBa}_2\text{Cu}_3\text{O}_{7-x}$ material from (a) the top quarter; (b) the second quarter; (c) the third quarter; (d) the bottom quarter of the SiC tube with the clay binder. Dashed curve represents data taken above and below 77 K several months later on the same sample. Because of the melt zone moved from top to bottom, the sample at the bottom end should contain a larger concentration of impurity phases.
