




Figure 1. ORTEP (ellipsoids at 50% probability) view of the X-ray structure of 7.

This structural re-elucidation compels some corrections in the main text of the article, specified as follows:

Page 514, title, lines 2 and 3. "1,3-Oxathiolan-, 1,3-Oxaselenolan-, and 1,3-Oxazolidin-2-imine" should be changed to "1,3-Oxazolidine-2-thione and 2-Selone".

Page 514, Abstract, lines 1 and 2. "1,3-oxathiolan, 1,3-oxaselenolan-, and 1,3-oxazolidin-2-imine" should be corrected as follows: "1,3-oxazolidine-2-thione and 1,3-oxazolidine-2-selone".

Page 514, Abstract, line 5. Remove "..and sodium cyanamide".

Page 515, column 1, paragraph 4, line 1. "1,3-oxathiolan-2imine" should be changed to "1,3-oxazolidine-2-thione".

Page 515, column 1, paragraph 4, lines 4 and 7. "imidoyl" should be changed to "thionocarbamate".

Page 515, column 1, paragraph 4, line 5. "C=NH" should be changed to "C=S".

Page 515, column 1, paragraph 4, line 9. "imine" should be changed to "amino".

Page 515, column 1, paragraph 4, line 14. "sulfur" should be changed to "nitrogen".

Page 515, column 2, paragraph 1, line 1. "oxathiolane" should be changed to oxazolidine".

Page 516, column 1, paragraph 1, line 3. "1,3-oxathiolan-2imine" should be changed to "1,3-oxazolidine-2-thione".

Page 516, column 1, paragraph 3, line 3. "selenocarboimidate" should be changed to "oxazolidin-2-selone".

Page 516. Synthesis of compound 15 could not be reproduced, so Scheme 3b and related text must be removed.

Page 516. Column 2, paragraph 1, line 1. "1,3-oxathiolan-2imine" should be changed to "1,3-oxazolidine-2-thione".

Page 516. Column 2, paragraph 3, lines 1 and 2. "1,3-Oxathiolan, 1,3-Oxaselenolan-, and 1,3-Oxazolidin-2-imine" should be corrected as follows: "1,3-Oxazolidine-2-thione and 1,3-Oxazolidine-2-selone".
