# Synthesis of arene ruthenium triazolato complexes by cycloaddition of the corresponding arene ruthenium azido complexes with activated alkynes or with fumaronitrile

#### Abstract

The neutral arene ruthenium azido complexes $\left[\left(\eta^{6}-p\right.\right.$-cymene $\left.) \mathrm{Ru}(\mathrm{LL})\left(\mathrm{N}_{3}\right)\right]$, $[\mathrm{LL}=$ acetylacetonato (acac) (4), benzoylacetonato (bzac) (5) diphenylbenzoyl methane $(d b z m)(6)]$ undergo $[3+2]$ cycloaddition reaction with a series of activated alkynes and fumaronitrile to produce the arene ruthenium triazolato complexes: $\left[\left(\eta^{6}-p\right.\right.$-cymene $\left.) \mathrm{Ru}(\mathrm{LL})\left\{\mathrm{N}_{3} \mathrm{C}_{2}\left(\mathrm{CO}_{2} \mathrm{R}\right)_{2}\right\}\right][\mathrm{LL}=(a c a c), \mathrm{R}=\mathrm{Me}$ (7); $\mathrm{LL}=(b z a c)$, $\mathrm{R}=\mathrm{Me}(\mathbf{8}) ; \mathrm{LL}=(d b z m), \mathrm{R}=\mathrm{Me}(\mathbf{9}) ; \mathrm{LL}=(a c a c), \mathrm{R}=\mathrm{Et}(\mathbf{1 0}) ; \mathrm{LL}=(b z a c), \mathrm{R}=\mathrm{Et}(\mathbf{1 1}) ; \mathrm{LL}=(d b z m), \mathrm{R}=\mathrm{Et}(\mathbf{1 2})$ and $\left[\left(\eta^{6}-p-c y m-\right.\right.$ ene) $\left.\mathrm{Ru}(\mathrm{LL})\left(\mathrm{N}_{3} \mathrm{C}_{2} \mathrm{HCN}\right)\right] ; \mathrm{LL}=\operatorname{acac}(13)$, bzac (14); dbzm (15). However, cationic azido complexes, $\left[\left(\eta^{6}-p-c y m e n e\right) \mathrm{Ru}(d p p e)\left(\mathrm{N}_{3}\right)\right]^{+}$and $\left[\left(\eta^{6} \text {-p-cymene }\right) \mathrm{Ru}(d p p m)\left(\mathrm{N}_{3}\right)\right]^{+}$do not undergo such cycloaddition reactions. The complexes were characterized on the basis of microanalyses, FT-IR and NMR spectroscopic data. Crystal structures of representative complexes were determined by single crystal X-ray diffraction.

## 1. Introduction

In organic chemistry 1,3-dipolar cycloaddition reactions are common processes. The process involves the reaction between 1,3-dipoles or a propargynellyl type with dipolarophiles. One of the most useful synthetic applications of azides is the preparation of 1,2,3-triazoles via 1,3-dipolar cycloaddition reactions of azides with substituted acetylene compounds [1-4]. The dipolar cycloaddition reactions between acetylenes and azides are very important and the most efficient route to synthesize 1,2,3-triazoles [4,5]. In analogy, a coordinated azide group in metal complexes can also undergo such cycloaddition reactions [6]. Azido

[^0]complexes undergo [ $3+2$ ] cycloaddition reactions with nitriles [7-19] and isonitriles [7,8,20-23] to produce tetrazolato complexes. Similar reactions with alkynes produce triazolates complexes [12,24-26]; alkenes, however, react very slowly and mostly afforded mixture of products [8,12].

Although such reactions are studied extensively in synthetic organic chemistry, dipolar cycloaddition reactions of azide coordinated metal complexes are relatively unexplored. A few reports appeared on cycloaddition of alkynes to ruthenium azido complexes in recent years [27-29]. However, to the best of our knowledge cycloaddition reaction of arene ruthenium azido complexes have not been studied. Our study reveals that such cycloaddition reactions are favorable in neutral complexes, but do not occur in cationic arene ruthenium azido complexes. Bennett et al. [30] reported the synthesis of $\left[\left(\eta^{6}\right.\right.$-arene $) \mathrm{Ru}($ acac $\left.) \mathrm{Cl}\right]$ by the reaction of a arene ruthenium dimer with acac in presence
of base and its reactions with various ligands. Here, we report the preparation of $p$-cymene ruthenium $\beta$-diketonato azido complexes $\left[\left(\eta^{6}\right.\right.$-arene $\left.) \mathrm{Ru}(\mathrm{LL})\left(\mathrm{N}_{3}\right)\right]$. These azido complexes undergo $[3+2]$ cycloaddition reactions with a series of activated alkynes and fumaronitrile to produce $p$-cymene ruthenium triazolato complexes. The spectral and structural characterizations of these complexes are presented.

## 2. Experimental

Caution: All the azide reactions should perform with extreme care.

### 2.1. Physical methods and materials

All solvents were dried in appropriate drying agents and distilled prior to use [31]. $\mathrm{RuCl}_{3} \cdot 3 \mathrm{H}_{2} \mathrm{O}$ (Arora Matthey Limited) and dimethylacetylenedicarboxylate (Aldrich) and diethylacetylenedicarboxylate (Acros) were purchased and used as received. NMR spectra were recorded on a Bruker AMX-400 MHz spectrometer at $400.13\left({ }^{1} \mathrm{H}\right)$, 100.61 MHz ( ${ }^{13} \mathrm{C}$ ) with $\mathrm{SiMe}_{4}$ as internal reference and coupling constants are given in hertz. Infrared spectra were recorded as a KBr pellets on a Perkin-Elmer model 983 spectrometer. Elemental analyses were carried out at the SAIF, NEHU, Shillong, using a Perkin-Elmer 2400 CHN/S analyzer. The precursor complexes [ $\left\{\left(\eta^{6}-p \text {-cymene }\right) \mathrm{RuCl}_{2}\right\}_{2}$ ] [32], [\{( $\eta^{6}-p$-cymene $\left.\left.) \mathrm{Ru}\left(\mu-N_{3}\right) \mathrm{Cl}\right\}_{2}\right]$ [33,34], [( $\eta^{6}-p$-cymene) $\mathrm{Ru}(b z a c) \mathrm{Cl}]$ (2) and $\left[\left(\eta^{6}-p\right.\right.$-cymene $\left.) \mathrm{Ru}(d b z m) \mathrm{Cl}\right]$ (3) were prepared by following a literature method [34]. While the complex $\left[\left(\eta^{6}-p\right.\right.$-cymene $\left.) \mathrm{Ru}(a c a c) \mathrm{Cl}\right]$ (1) was prepared by minor modification of reported method [35]. The following nomenclature was used in the text.

### 2.2. Synthesis of complexes

### 2.2.1. Preparation of $\left[\left(\eta^{6}-p\right.\right.$-cymene $\left.) R u(a c a c) C l\right]$ (1)

The complex [\{( $\eta^{6}-p$-cymene $\left.) \mathrm{RuCl}_{2}\right\}_{2}$ ] $(100 \mathrm{mg}, 0.163$ mmol) and $\mathrm{Na}($ acac $)(57 \mathrm{mg}, 0.40 \mathrm{mmol})$ were stirred in dry methanol 20 ml for 3 h . The solution turned into bright yellow, the solvent was removed by rotaryevaporator and the residue was dissolved in dichloromethane and filtered to remove sodium chloride. The solution was concentrated to ca. 5 ml and excess of hexane was
added and kept at room temperature. A yellow crystalline solid was precipitated out. The precipitate was collected and dried. The spectroscopic data are consisted with the reported values.

### 2.2.2. Preparation of $\left[\left(\eta^{6}\right.\right.$-p-cymene) $\left.R u(a c a c)\left(N_{3}\right)\right]$ (4)

Two routes were used to prepare this complex:
Route (a): The complex [( $\eta^{6}$-p-cymene) Ru(acac)Cl] $(100 \mathrm{mg}, 0.270 \mathrm{mmol})$ and $\mathrm{NaN}_{3}(35 \mathrm{mg}, 0.54 \mathrm{mmol})$ were stirred in 30 ml of ethanol for 6 h . The solvent was removed on rotary-evaporator and the residue was dissolved in diethyl ether then filtered. The filtrate on evaporating at room temperature affords a bright red crystalline solid of the complex. Yield: $83 \mathrm{mg}, 82 \%$.

Route (b): The complex $\left[\left\{\left(\eta^{6}-p \text {-cymene }\right) \mathrm{Ru}\left(\mu-\mathrm{N}_{3}\right) \mathrm{Cl}\right\}_{2}\right]$ $(100 \mathrm{mg}, \quad 0.160 \mathrm{mmol})$ and $\left[\mathrm{Na}(a c a c) \cdot \mathrm{H}_{2} \mathrm{O}\right] \quad(56 \mathrm{mg}$, 0.40 mmol ) were stirred in 30 ml of ethanol for 5 h , and then solvent was removed. The residue was dissolved in dichloromethane and then filtered. The filtrate on concentration and addition of excess hexane afford red crystalline solid of the complex.

### 2.2.3. Preparation of $\left[\left(\eta^{6}-p\right.\right.$-cymene $\left.) R u(b z a c) N_{3}\right]$ (5)

This complex was prepared by following a similar method as described in the preparation of complex 4 (route b) using $\left[\mathrm{Na}(b z a c) \cdot \mathrm{H}_{2} \mathrm{O}\right]$ instead of $\left[\mathrm{Na}(a c a c) \cdot \mathrm{H}_{2} \mathrm{O}\right]$. Yield: $82 \mathrm{mg}, 81 \%$.

### 2.2.4. Preparation of $\left[\left(\eta^{6}-p\right.\right.$-cymene $\left.) R u(d b z m) N_{3}\right]$ (6)

This complex was prepared by following a similar method as described in the preparation of complex 4 (route b) using $\left[\mathrm{Na}(\mathrm{dbzm}) \cdot \mathrm{H}_{2} \mathrm{O}\right]$ instead of $\left[\mathrm{Na}(a c a c) \cdot \mathrm{H}_{2} \mathrm{O}\right]$. Yield: 86 mg ( $84 \%$ ).

2.2.5. Preparation of triazolato complexes $\left[\left(\eta^{6}-p-\right.\right.$ cymene) $\left.R u(L L)\left\{N_{3} C_{2}\left(\mathrm{CO}_{2} R\right)_{2}\right\}\right](L L=a c a c, R=M e$ (7), $L L=$ bzac, $R=\operatorname{Me}(8) ; L L=(d b z m), R=\operatorname{Me}(9)$, $L L=a c a c, R=E t(10) ; L L=(b z a c), R=E t(11)$, $L L=d b z m, R=E t(12))$

General procedure: A round bottom flask charged with corresponding azido complex (4) ( $100 \mathrm{mg}, 0.26 \mathrm{mmol}$ ) or (5) $(100 \mathrm{mg}, 0.22 \mathrm{mmol})$ or (6) $(100 \mathrm{mg}, 0.20 \mathrm{mmol})$ was added fivefold excess of dimethylacetylenedicarboxylate/ diethylacetylenedicarboxylate and $\mathrm{CH}_{2} \mathrm{Cl}_{2}(20 \mathrm{ml})$. The mixture was stirred at room temperature and then the solution was reduced to ca. 3 ml on rotary evaporator. To this solution was added 30 ml of hexane, whereby the compound precipitated out as a yellow solid. The solid was collected by centrifuged and washed with $2 \times 20 \mathrm{ml}$ of hexane and dried under vacuum to gave the triazolato complexes $\left[\left(\eta^{6}\right.\right.$ - $p$-cymene $\left.) \mathrm{Ru}(\mathrm{LL})\left\{\mathrm{N}_{3} \mathrm{C}_{2}\left(\mathrm{CO}_{2} \mathrm{R}\right)_{2}\right\}\right]$ (7-12).

Reaction time, yield, analytical and spectroscopic data are as follows:

## 3. Structural analysis and refinement

X-ray quality crystals of complex 4 were grown by slow evaporation of diethyl ether solution of complex 4 at room temperature while the crystals of $\mathbf{7 , 1 1}, \mathbf{1 2}$ and $\mathbf{1 3}$ were obtained by diffusion of hexane into acetone solution of the complexes. X-ray diffraction data were measured at 120(2) K on a Bruker AXS Apex CCD area detector employing graphite monochromated Mo $\mathrm{K} \alpha$ radiation ( $\lambda=0.71073 \AA$ ). Absorption correction were made by modeling a transmission surface by spherical harmonics employing equivalent reflections with $I>2 \sigma(I)$ (sadbas) [36]. The structures were solved by direct methods and refined by full matrix least squares base on $F^{2}[37,38]$. Non-hydrogen atoms were refined anisotropically and hydrogen atoms were refined using a "riding" model. The selected bond lengths and angles are tabulated in Tables 1,2 and summary of collection parameters and refinement data is presented in Table 3 respectively.

## 4. Result and discussions

### 4.1. Synthesis of arene ruthenium azido complexes

Treatment of the complexes [ $\left(\eta^{6}-p\right.$-cymene $\left.) \mathrm{Ru}(\mathrm{LL}) \mathrm{Cl}\right]$ with $\mathrm{NaN}_{3}$ in ethanol afforded the azido complexes $\left[\left(\eta^{6}\right.\right.$ -$p$-cymene $\left.) \mathrm{Ru}(\mathrm{LL})\left(\mathrm{N}_{3}\right)\right]$ in fairly good yield (Scheme 1). The formation of the azido complexes can be readily confirmed by the appearance of a strong characteristic band of the terminal azide stretching frequency at around $2015-2036 \mathrm{~cm}^{-1}$. Alternatively, the azido complexes can also be prepared by the reaction of azide dimer $\left[\left\{\left(\eta^{6}-p\right.\right.\right.$ cymene) $\left.\left.\mathrm{Ru}\left(\mu-\mathrm{N}_{3}\right) \mathrm{Cl}\right\}_{2}\right]$ with sodium salts of $\beta$-diketonate. The absence of the bridging azido band at $2057 \mathrm{~cm}^{-1}$ of the starting complex and appearance of a new band in

the region 2015-2030 $\mathrm{cm}^{-1}$ confirmed the formation of the azido complexes $\left[\left(\eta^{6}-p\right.\right.$-cymene $\left.) \mathrm{Ru}(\mathrm{LL})\left(\mathrm{N}_{3}\right)\right]$.

### 4.2. Reaction of ruthenium azido complexes with DMD or DED

The reaction of azido complexes 4-6 with a fivefold excess of the substituted acetylenes dimethylacetylene-

dicarboxylate $\left(\mathrm{MeO}_{2} \mathrm{CC}_{2} \mathrm{CO}_{2} \mathrm{Me}\right)$ (DMD) or diethylacetylenedicarboxylate $\left(\mathrm{EtO}_{2} \mathrm{CC}_{2} \mathrm{CO}_{2} \mathrm{Et}\right)$ (DED) in dichloromethane at room temperature afforded the yellow ruthenium triazolato complexes in good yield (Scheme 2). The formation of the triazolato complexes can be readily confirmed by observing the disappearance of azide band and the appearance of new bands due to $\mathrm{C}=\mathrm{O}$ stretching frequencies at $1726 \mathrm{~cm}^{-1}$. In addition to the $\mathrm{C}=\mathrm{O}$ stretching frequencies, the IR spectra of these complexes showed a pair of strong bands at around $1517-1578 \mathrm{~cm}^{-1}$ which are assignable to coupled $(\mathrm{C}=\mathrm{O})+(\mathrm{C}=\mathrm{C})$ modes of the $\beta$-diketonate $[39,40]$. Surprisingly, the triazolato complexes formed from the two acetylenes differ in their mode of bonding. The dimethylacetylenedicarboxylate exclusively produced $\mathrm{N}(2)$ bonded triazolato complexes while diethylacetylenedicarboxylate produced exclusively $\mathrm{N}(1)$ bonded triazolato complexes. This has been confirmed by the X-ray analysis of the complexes 7, $\mathbf{1 1}$ and $\mathbf{1 2}$.

It should be noted that the triazole anion could be coordinated by a metal through either its $\mathrm{N}(1)$ or $\mathrm{N}(2)$ nitrogen atoms $[7,26]$ which are essentially isoenergetic as indicated by molecular orbital calculations [26,27]. Evidence obtained to date indicates that either of the two isomers $\mathrm{N}(1)$ and $\mathrm{N}(2)$-bonded are formed simultaneously [ $7,12,16,26,27]$ or only the $\mathrm{N}(2)$ bound isomer is produced exclusively [7,12,16,17]. In our cases both the $N(1)$ and $\mathrm{N}(2)$ bonded isomers are formed depending on the substituents of the triazolato ring. Thus, methoxy-substituted acetylene produced exclusively $\mathrm{N}(2)$ bonded isomer while ethoxy-substituted acetylene exclusively produced $\mathrm{N}(1)$ isomer. Ellis et al. have reported the initial formation of $\mathrm{N}(1)$ bonded complex via azide attack on the coordinated nitrile carbon of pentamethylamine cobalt complexes which slowly isomerized to the $\mathrm{N}(2)$ bonded complex [41]. It is
believed that the triazolato complexes initially form the $\mathrm{N}(1)$ bonded complexes which then isomerize to the $\mathrm{N}(2)$ bonded complexes. Isomerization from $\mathrm{N}(1)$ to $\mathrm{N}(2)$ is favored as far as steric factors are concerned while electronic factors favor no isomerization.

It has been reported that the $\mathrm{N}(1)$ nitrogens of the triazolato anions are more nucleophilic than the $\mathrm{N}(2)$ nitrogens [27]. The $\mathrm{N}(1)$ to $\mathrm{N}(2)$ linkage isomerization reaction appears to be driven by the steric congestion between the triazole ring substituents. An inspection of molecular models of the linkage isomers indicates that this congestion would be totally relieved in the $N(2)$ bonding isomer. Thus, formation of exclusively $\mathrm{N}(1)$ bonded triazolato complexes $\mathbf{1 0}-\mathbf{1 2}$ could not be due to steric factors but it is believed that it is due to electronic factors. As mentioned previously, a consideration of ring nitrogen nucleophilicity favors $\mathrm{N}(1)$ coordination for substituted triazolato complexes [27]. Thus, in the case of the ethoxy substituted triazolato complexes ( $\mathbf{1 0}-\mathbf{1 2}$ ) no isomerization takes place from the $\mathrm{N}(1)$ to $\mathrm{N}(2)$ bonded complexes due to the high inductive effect of the ethoxy group which favors the $\mathrm{N}(1)$ bonded triazolato complexes. But the methoxy substituted triazolato complexes isomerize from the $\mathrm{N}(1)$ to $\mathrm{N}(2)$ bonded isomers and produce exclusively the $\mathrm{N}(2)$ bonded triazolato complexes (7-9). In order to confirm the mode of bonding, the crystal structures of the representative complexes have been determined. On the basis of spectroscopic data and X-ray analysis, the methoxy-substituted triazolato complex has been proposed $\mathrm{N}(2)$ bonded while ethoxy-substituted triazolato complexes are proposed to be $\mathrm{N}(1)$ bonded triazolato complexes.

The ${ }^{1} \mathrm{H}$ NMR spectrum of complex 7 is shown in Fig. 1. The ${ }^{1} \mathrm{H}$ NMR spectra of the complexes $7-9$ exhibit, in addition to the $p$-cymene resonances, singlet resonances

corresponding to the $\beta$-diketonate ligand in the region $\delta$ 4.9-6.2 for $\gamma$-proton and a singlet at ca. $\delta 3.8$ assignable to the methoxy carbonyl group protons of the triazolato group.

The ${ }^{1} \mathrm{H}$ NMR spectra of complexes $\mathbf{1 0}-\mathbf{1 2}$ exhibited a quartet at ca. $\delta 4.29$ and a triplet ca. $\delta 1.28$ due to the methylene and methyl protons of the ethoxy carbonyl group. The ${ }^{13} \mathrm{C}\left\{{ }^{1} \mathrm{H}\right\}$ NMR of these complexes exhibited a single resonance at $\delta 162$ due to carbon of $\mathrm{CO}_{2}$ group
while the carbons of the $\beta$-diketonate group appear at $\delta$ 183-189.

### 4.3. Reaction of ruthenium azido complexes with fumaronitrile

The reaction of the azido complexes 4-6 with excess fumaronitrile at room temperature for $10-15 \mathrm{~h}$ affords the $\mathrm{N}(2)$ bound 4-cyano-1,2,3-triazolato complexes (13-15) in good yield. The formation of the triazolato complexes is readily confirmed by the absence of the starting azide stretching frequency and the appearance of a strong band at around $2220 \mathrm{~cm}^{-1}$ corresponding to the stretching frequency of the $\mathrm{C} \equiv \mathrm{N}$ group of the coordinated triazolato group. The ${ }^{1} \mathrm{H}$ NMR spectra of these complexes showed characteristic singlet resonances at $\delta 6.9$ assigned to the CH group of the triazolato ring proton and a singlet in the region $\delta 5.19-6.16$ attributed to $\gamma$-proton of the $\beta$ diketonato group. In addition, the ${ }^{1} \mathrm{H}$ NMR spectra contains doublet resonances corresponding to the $p$-cymene group in the region $\delta 5.3$ arising from the protons of the arene ring, a multiplet at ca. $\delta 2.87$ due to $\mathrm{CHMe}_{2}$, a singlet at $\delta 2$ for methyl group and a doublet at $\delta 1.2$ for the methyl protons of isopropyl group. In principle, the cycloaddition of fumaronitrile to the coordinated azide can take place via $\mathrm{C}=\mathrm{C}$ or $\mathrm{C} \equiv \mathrm{N}$. The reaction of coordinated azide in $\mathrm{Ni}(\mathrm{II})$ with $\mathrm{CH}_{2}=\mathrm{CHCN}$ gave a triazolinato complex [7]. A pathway via direct cyclization of $\mathrm{HC} \equiv \mathrm{CCN}$ with azide resulting in the formation of triazolato has also occurred [27,42]. Complexes $\mathbf{1 3 - 1 5}$ are clearly formed by $[3+2]$ cyclization between the azido ligand and the $\mathrm{C}=\mathrm{C}$ double bond following removal of a HCN molecule. The proposed structures of the complexes are confirmed by a determination of molecular structure of representative complex 13 by single crystal X-ray diffraction.

## 5. Crystal structures

### 5.1. Crystal structure of $\left[\left(\eta^{6}-p\right.\right.$-cymene) $\left.R u(a c a c) N_{3}\right]$ (4)

The ORTEP drawing of complex $\mathbf{4}$ with the atom labeling scheme is shown in Fig. 2. The selected bond lengths and angles are listed in Table 1.

The complex crystallizes in the $P 2(1) / c$ space group. The ruthenium atom is coordinated by a $p$-cymene ligand in $\eta^{6}$ fashion occupying three facile coordination sites. The remaining coordination sites are occupied by the O -atoms of the acetylacetonate ligand and azide group. The unit cell consists of two molecules. The two molecules differ only in the orientation of the azide groups. In one molecule

the $-\mathrm{N}=\mathrm{N}=\mathrm{N}$ group is directed horizontally while in the other it directed vertically. The distance between the ruthenium and the centroid of the $p$-cymene ligand in both molecules is comparable, the values being $1.652(4) \AA(\mathrm{Ru} 1-$ Cent) and $1.657(5) \AA$, (Ru2-Cent). The Ru1-O(1) $[2.077(3) \AA]$ and $\mathrm{Ru} 1-\mathrm{O}(2)[2.057(3) \AA]$, in one of the molecules is comparable to that of the other and the values are in the range of reported $\mathrm{Ru}-\mathrm{O}$ bond lengths of other ruthenium $\beta$-diketnoate systems [43].

The $\mathrm{N}-\mathrm{N}$ bond lengths in the molecules are in the range of 1.134 (6)-1.162 (5) $\AA$, which are comparable to other reported $\mathrm{N}-\mathrm{N}$ bond lengths. However, the ruthenium and nitrogen of the azide bond distance, 2.102(4) $\AA$, is slightly longer than that of other reported complexes such as rhodium [44] and copper [6b] complexes.

The structure of the compounds 7, 11, $\mathbf{1 2}$ and $\mathbf{1 3}$ consists of a neutral arene ring bonded to the ruthenium, along with anionic $\beta$-diketonato and triazolato ligands. The molecular structures of complexes 7, 11, $\mathbf{1 2}$ and $\mathbf{1 3}$ with atom labeling scheme are shown in Figs. 3-6. Selected bond lengths and angles are presented in Table 2. The complexes 7, 11 and 13 crystallized in the $P 2(1) / c$ space group while complex 12 crystallized in the $P 2(1) 2(1) 2(1)$ space group. The $p$ -

cymene ligand is bonded to the ruthenium atom in $\eta^{6}$-fashion with ruthenium to centroid of the ring being 1.660 (3), 1.667 (4), 1.670 (2) and 1.656 (5) A, for complex 7, 11, 12 and 13, respectively. The complexes adopt a typical threelegged piano stool conformation with the N and the two O -atoms as the legs. The $\mathrm{Ru}-\mathrm{O}(1)$ and $\mathrm{Ru}-\mathrm{O}(2)$ bond distances of the triazolato complexes $\mathbf{7 , 1 3}$ are comparable to the starting azido complex 4 . The remarkable difference in the structure between the methoxy substituted complex 7 and that of ethoxy substituted complexes $\mathbf{1 1}$ and $\mathbf{1 2}$ is the mode of coordination of the triazolato unit to the ruthenium atom. In complex 7, the triazolato group is bonded to the metal through $\mathrm{N}(2)$ - while in complexes 11 and $\mathbf{1 2}$, it is bonded through $\mathrm{N}(1)$ - atom of the triazolato group. It is notable that most cycloaddition reactions of coordinated azide with acetylenes to produce triazoles exclusively form the $\mathrm{N}(2)$-isomer. To the best of our knowledge, complexes $\mathbf{1 1}$ and $\mathbf{1 2}$ represent first structurally characterized $\mathrm{N}(1)$-bound isomer obtained from such cycloaddition reaction. There is no significant difference in the bond distances of the heterocyclic ring indicating delocalization of electrons in the ring. The $\mathrm{Ru}-\mathrm{O}(1)$ and $\mathrm{Ru}-\mathrm{O}(2)$ bond distances in the complexes range from 2.0581 to $2.079 \AA$ which is comparable to those of the reported $\mathrm{Ru}-\mathrm{O}$ bond lengths [43]. The $\mathrm{O}(1)-\mathrm{Ru}-\mathrm{O}(2)$ bond angles of the complex 7 (88.81(8) A) are comparable to that of complexes $\mathbf{1 1}$ (88.32(11) A) and $\mathbf{1 2 ( 8 8 . 8 9 ( 6 ) ~ \AA ) . ~}$

## 6. Conclusions

Previously, we reported the syntheses of indenyl ruthenium triazolato complexes. In these complexes the
triazolato ligand binds to the metal through the $\mathrm{N}(2)$ atom irrespective of acetylenes are used. Where as in the present study the bonding depend on the acetylene. In the case of dimethylacetylenedicarboxylate the bonding is through $\mathrm{N}(2)$ whereas in the case of diethylacetylenedicarboxylate the bonding is through $\mathrm{N}(1)$. Even though we expected the chemistry to be similar to indenyl ruthenium systems, we observed the formation of new bonding modes in the arene ruthenium system. Complexes $\mathbf{1 1}$ and $\mathbf{1 2}$ are the first examples of structurally characterized $\mathrm{N}(1)$-bound isomers obtained from such cycloaddition reactions.
